

BERJIS DESAI ANNOUNCES HIS 575 DAY PLAN FOR THE BPP

The induction of two new trustees will enthuse the new Board to achieve the following within the next 575 day period.

The idea is to minimise politics and increase focus on BPP economics and finances. A crisis is the right moment to eliminate ego and the past grievances. Dynamics of the new Board will be more harmonious and gentle. As a result, interaction between the trustees will become speedier and more productive. This is not wishful thinking but eminently achievable.

In the next 575 day period, the two new trustees will be catalyst for the following 12 point program.

 Review every tenant/licensee litigation in which BPP is involved, whether as plaintiff or defendant. Objective is to continue with only such litigation where it involves a question of policy or principle. I believe we can end 70% of unproductive litigation. Stress and harassment to BPP tenants and licensees will end. Savings in BPP legal costs as well as to our beneficiaries. Special bonus for members of BPP staff suggesting solutions to end such litigation.

- Review salary and other conditions of service of all categories of BPP staff. To improve efficiency and effectiveness, higher cost on this account is fully justified, despite strained cash flow. Priority of housing allotment to BPP staff who have completed 12 years of service or any other special circumstance which necessitates immediate out of turn allotment.
- 3. Review housing applications from all practising Mobeds; out of turn priority for alloting homes for practising full time Mobed; also for practising part time mobeds over 10 years. Mediclaim cover for these mobeds and immediate dependant family members; premium to be paid by other Parsi charities until BPP finances improve.
- 4. Review housing applications from all young married or to be married couples and give housing Incentives to bear not less than two children,
- 5. Expert White paper on Reversal of population decline including incentives aside from second and third child subsidy.
- 6. Formulation of long term policies relating to tenancies/ leave and license; to

- eliminate subjectivity in, and improve speed of, decision making and ensuring maximum transparency and fairness in matters relating to transfer and transmission (upon death of tenant) including reviewing the present system of auctions of high value flats.
- 7. To achieve financial closure of at least two stalled projects by eliminating the roadblocks through persuasion, and if necessary, Out of the box legal solutions. Critical for stabilising BPP finances.
- 8. To review and improve the efficacy of accounting practices and policies of the BPP; also unresolved income tax and property tax issues
- To increase the amount of financial assistance to students and economically weaker beneficiaries. Again by coordinated effort with other fund rich Parsi charities
- 10.End the acrimonious bitter atmosphere in Federation meetings. Make the Federation an instrument of unity.
- 11. Change term of trustees from 7 to 5 years. Maximum 3 terms; restricting period to 15 years instead of the present 21. Certain changes in the Election Scheme having regard to the experience of its working from 2008 to 2021.
- 12.To make Doongerwadi more secure and efficient and user friendly.

COVID- 19 IMMUNIZATION

Trustees decided at their last Board Meeting that BPP being the Apex body should take the lead and finance for atleast first five thousand covid vaccines to be given FREE to the Senior Citizens of the Community. Only Five thousand vaccines are required at present since there is an age restriction for priority of vaccine jabs though later on the same can be provided for the full Community.

Trustee Mr. Viraf Mehta informed that he has discussed this issue only yesterday with Mr. Parvez Irani of the Irani Anjuman in this matter and suggested that BPP and the

Irani Anjuman should jointly sponsor the immunization of the full Parsi Community in Mumbai.

In the above matter the Trustees called up Mr. Parvez Irani and discussed the issue. It was agreed that BPP and Irani Anjuman jointly will sponsor the immunization Project free of cost for the whole Parsi Community of Mumbai. It was also decided to announce the same publicly through various sources by this week end. Hence given below is the JOINT public notice issued by BPP and Iranian Zoroastrian Anjuman.

The Bombay Parsi Punchayet and the Iranian Zoroastrian Anjuman are working on a proposal to make available free vaccines for our community members.


This proposal is subject to availability of the vaccines and acceptance of the proposal by the authorities / vaccination centres / hospitals.

Dear Sirs,

Politics makes strange bedfellows goes the saying. In West Bengal elections the party in power at the national level is using every possible means to win over MPs and MLAs of the AITC (TMC) to win the state.

For power at 209, D.N.Road, the almost drowning defacto and reformist 'Chairman' is not leaving any stone unturned to get back his majority on the BPP board by displaying support to the certain winner, the lady candidate Anahita Desai. Anahita wants to provide housing to deserving newly married couples; Randeria wants intermarried friends to benefit by allowing them multiple homes!

Anahita wishes to care for senior citizens with medical and financial help; Randeria deprives a single meal to such seniors only to spite those who expose his misdeeds!

Anahita wishes to communicate with the community as she believes "Misinformation and outright falsehoods are often spread by vested interests"; Randeria, in the guise of "The Truth. Delivered Weekly" has blocked completely all communication by total control of the weekly Parsi media. Facts and events NOT palatable to him and which expose his malafide acts are never allowed to be printed. Readers are fed stories with a view to only promote themselves, at times at the cost of his colleagues on the board.

Anahita wants to revamp employment; Randeria wants to employ and house only his preferred lot, at times even foreigners, as to him good and efficient professionals are not available locally!

POLICE WANT TO RETURN THE CASH RS.20 LAKHS FOUND IN LATE CEO'S CABIN BUT KHOJESTE MISTRY AND KERSI RANDERIA WON'T TAKE IT BACK

On 27th January 2021, MRA Marg police had informed Khojeste Mistry, who claims to be a HOLY MAN by calling himself A Parsi Preacher, to come to the Police Station to complete formalities and collect the cash Rs. 20 lakhs found in late CEO's CABIN lying with the MRA Marg police but deposited in his FIR filed by him.

Khojeste Mistry passed on this message to BPP CEO who in turn sent mail to all BPP Trustees on Wednesday 27th January 2021.

Under normal circumstances one would have expected the Trustees to be proactive on a urgent conference call to depute some senior staff the same day to go to MRA Marg police station to collect the badly needed cash Rs. 20 lakhs belonging to BPP just rotting away in the police safe without any return.

But once again the criminal mind of Kersi Randeria went into overdrive and he realized that his accusation that this Rs. 20 lakhs found in the CEO's cupboard was the same misappropriated transfer fees would no longer hold good and hence Kersi Randeria advised his colleagues as well as Khojeste Mistry that since matter was subjudice to take no urgent steps to collect the Rs. 20 lakhs cash but to await further discussion at next **Board meeting to be held on Tuesday** 2nd February 2021 and decide further course of action..

THUS IN SPITE OF CASH CRUNCH **FACED BY BPP, CASH RS. 20 LAKHS BELONGING TO THE TRUST AND THE COMMUNITY WHICH WAS LYING** SEALED IN THE BPP CUPBOARD SINCE AUGUST 2014 IS NOW LYING **SEALED TILL PRESENT DATE IN MRA** MARG POLICE LOCKER. IN THE FIR FILED BY KHOJESTE MISTRY.

WHY IS KERSI RANDERIA NOT **ALLOWING KHOJESTE MISTRY TO** APPROACH MRA MARG POLICE STATION TO INQUIRE INTO THE POLICE REQUIREMENTS BEFORE THEY CAN RELEASE THE RS. 20 LAKHS TO THE BPP.

In the Parsi Junction issue of 7th February 2021, we had reported that according to police the Rs. 20 lakhs Cash deposited in the Magistrate's Court been deposited in MRA Marg Police Station Locker in Khojeste Mistry's Complaint No. MECR 02/2014 u/s 406, 420 and 34 IPC as seized property amounting to Rs. 20,01,000/=. Hence the amount can only be returned to Khojeste Mistry and no one else though the money does not belong to Khojeste Mistry but to BPP Trust.

We further reported that only Khojeste Mistry has to file an Application in the 38th Magistrate Court at Ballad Pier for Return of Seized Property his pending Complaint No. SW/3800027/2014 (MERC Complaint No. 02/2014) and the money will be returned to Khojeste Mistry who will then have to forward the Cash of Rs. 20,01,000/ back to the BPP Trust.

HOWEVER ALTHOUGH ALMOST TWO MONTHS HAVE PASSED SINCE THE POLICE INFORMED KHOJESTE MISTRY TO COME TO MRA MARG POLICE STATION TO COMPLETE FORMALITIES TO COLLECT THE CASH RS 20 LAKHS NOT ONE STEP HAS BEEN TAKEN EITHER BY KHOJESTE MISTRY OR BY KERSI RANDERIA TO RECOVER THE CASH **RS. 20 LAKHS FROM THE POLICE IN** SPITE OF THEIR REQUEST.

BOTH OF THEM REALIZE THAT IF THEY COLLECT THE CASH OF RS 20 LAKHS THEN THE CHARGES OF MISAPPROPRIATION LEVELLED BY THEM AGAINST DINSHAW MEHTA WOULD NO LONGER SURVIVE.

The witch hunt of Yazdi Desai. (due to loss of his wife to Dinshaw Mehta supported Muncherji Cama), Khojeste Mistry (Wapiz Trustee), Kersi Randeria and Arzan Ghadially to somehow discredit Dinshaw Mehta in the eyes of the community so that the community stops electing candidates put up/supported by Dinshaw Mehta was so strong that they were willing to sacrifice Rs. 20 lakhs of community

charity funds to get their revenge on **Dinshaw Mehta.**

Thus if it is accepted as all the Trustees have done that transfer fees of Musharraf Kader was Rs. 45 lakhs which has been received in full by BPP in November 2013 itself than this cash Rs. 20 lakhs found in CEO's cupboard and now to be collected from the police has no connection with the pending complaint even if it is sub-judice.

It is time that the Trustees see the writing on the wall and dismiss any perverted reasoning of Kersi Randeria or Khojeste Mistry not to collect the cash if the police are willing to hand it over and hopefully the cash Rs. 20 lakhs will come back to the coffers of BPP and the community for charity use.

However it is open to doubt whether both Khojeste Mistry and Kersi Randeria will allow this Rs. 20 lakhs to be returned to BPP as both of them had made false and fabricated accusations that this is the Rs. 20 lakhs cash found in the late CEO's cupboard that Dinshaw Mehta had misappropriated out of Rs. 65 lakhs transfer fees for the Dadi House Tenancy and only Rs. 45 lakhs had been received by BPP in November 2013.

IF THIS TOO IS RETURNED THEN ALONG WITH THE ADMISSION AND ACCEPTANCE BY KERSI RANDERIA, KHOJESTE MISTRY, YAZDI DESAI AND NOSHIR DADRAWALA THAT TRANSFER FEES WERE RS. 45 LAKHS AND NEVER RS. 65 LAKHS AS FALSELY ACCUSED BY THEM TO FABRICATE A FALSE FIR AGAINST DINSHAW MEHTA NO LONGER SURVIVES AND ALL OF THEM WOULD HAVE TO APOLOGISE TO **DINSHAW MEHTA AND HIS FAMILY** FOR THE FALSE ACCUSATION.

WILL THEY BE MAN ENOUGH TO ACKNOWLEDGE THEIR **GUILT** FOR FALSE CHARGE AGAINST **DINSHAW MEHTA AND APOLOGIZE UNEQUIVOCALLY TO HIS FAMILY.**

ZULEIKA HOMAVAZIR FILES APPEAL IN HIGH COURT AGAINST HER DISQUALIFICATION

As the community is aware, the Trustees of BPP even after giving Zuleika Homavazir several opportunities to get an Affidavit from her Proposer, Rustom Jeejeebhoy, that he had not converted to Christianity but continued to profess the Zoroastrian religion, finally had no option but to disqualify her on ground that her Notice of Candidature is invalid as her Proposer is not a Parsi Zoroastrian within the meaning of the Election Scheme formulated by the High Court as far back as 1910 with modifications and amendments from time to time since then.

Thus by Public Notice published in Jame-Jamshed and Parsi Junction of Sunday 21st Feb 2021, the Trustees announced the names of seven valid candidates along with the names of their Proposers and Seconders.

Being aggrieved by her disqualification, Zuleika Homavazir filed an Originating Summons in the High Court being OS No. of 2021 in Suit no. (L) 5425 of 2021 and on Friday 26th Feb served it to the Trustees with Notice that the above matter is likely to be placed on the Board of His Lordship Mr. Justice A. K. Menon in Court Room No. 21 on Monday 1st March 2021 seeking urgent ad interim/interim reliefs as set out in the Originating Summons and Plaint in the matter.

Unfortunately on Monday 1st March, BPP Senior Counsel could not attend in time as he was on his legs in another Court and the matter was adjourned to Wednesday 3rd March for hearing when the matter was argued for well over an hour.

The argument of Zuleika Homavazir that the name of Rustom Jeejeebhoy is still on the Voters list was very convincingly countered by BPP's Senior Counsel Som Somashekharan that if a name is on the voters list for Municipal or Assembly elections can a person who takes on citizenship of another country vote?

Both parties claim that they came to know that Jeejeebhoy is an apostate only now. Court Also asked if a second nomination instead of a co-proposer was filed and in which case the BPP would have had to accept the second nomination as per the Election Scheme.

The Hon'ble Court has given Zuleika Homavazir one more chance to obtain Affidavit from Rustom Jeejeebhoy until Monday 8th Feb that he has not converted and continues to profess the Zoroastrian religion in which case she will be allowed to contest the elections failing which the disqualification imposed by the Trustees will prevail.

Somashekharan argued the matter brilliantly and tenaciously on behalf of the BPP and the matter is kept for ORDERS on Monday 8th Feb when the fate of Zuleika Homavazir will be declared by the High Court.

Even otherwise it is open to doubt whether in these increasing covid times, whether the Trustees will take the risk of holding the elections on 14-3-21 or whether the BMC or State Govt will bring in new sanctions to contain the pandemic. It would be ideal if the elections were postponed for three months by which time most Parsi Seniors will hopefully have received their vaccine jabs.

Whilst on Zuleika Homavazir, it is interesting to reproduce her threats given to Dinshaw Mehta and Parsi Junction for exposing her dishonesty in claiming a Rustom Baug flat allotted to her on Leave License basis with Refundable Deposit as being given to her on Ownership basis for which she filed five cases against BPP Trustees in general and Dinshaw Mehta in particular out of which three cases have been disposed off but two still remain to be argued on merits.

We give below her threats and warnings to this paper as under:

Zuleika election threat

My Dear Community Members,

Whatever the outcome of my Originating Summons, I thank all of you, my dear Community members for your support and good wishes.

My main contention apart from a win in this Election with your blessings & votes, is to EXPOSE The Bitter Truth of the Trustees. Whether it be their crude mismanagement of the Trust administration wherein accounts/ taxes are manipulated or be their worthless illegal attitude.

The impression given to the Community that all's well is an understatement.

The Government agencies, some day will catch up & take the BPP to task for which the

Trustees will face the music and the eventual brunt will fall upon the Community.

Mr. Mehta is bound to escape such a storm leaving the Community to fend for itself.

Mr. Mehta, I am indeed surprised that you along with Mr.Sethna whose illegal private publication that you use to your advantage has not stooped to the level of publishing grudges in my Personal Life.

Beware Mr. Mehta, if you do, I shall leave no stone unturned to sue you and the publication on grounds of Defamation and outraging the modesty of a woman.

More compromises remain to be exposed which are more severe.

Leave & Licence holders in the five RN & NN Wadia Baugs, please refer to your monthly compensation receipts - bears the signature of none other than Mr. K. UDWADIA as Secretary who expired 5 years ago. What were the trustees including the Chairman doing all these five years in office and above all what has our "so called" Chartered Accountant trustee done?

A Criminal Breach of Trust by the Trustees.

You, my dear Community members, be the best judge and vote accordingly. Please don't get carried away by the endorsements, advertisements in weekly publications and meetings that have transpired in Baugs. Certain candidates have already defaulted in their Code of Conduct which still remains Voluntary due to reasons best known to the Trustees.

Trustee Kersi Randeria in breach of the specific Trust Deed of Bharucha Baug has been insistent to erect an Ownership Bldg at Bharucha Baug in spite of well knowing that the Multi Storey Bldg therein when tried to be converted as Ownership Bldg., in 1993 was objected by Fali Poncha, Dinshaw Mehta and others and ultimately the proposal was given up at that time and flats thereof were allotted free to deserving applicants through munificent Donations from well wishers.

When the Ownership proposal was again mooted in 2016 by Kersi Randeria, Parvez Driver and Dinshaw Mehta objected to it. Even a lawyers Notice from Advocate Rumi Mirza to Kersi Randeria about Ownership bldg. being in breach of the Bharucha Baug



Trust Deed evoked no response from him except defiance to still do so.

Thanks to Kersi Randeria, BPP has already paid the Architect almost Rs. 1 Crore so far to get the BMC approvals without any progress and yet Kersi Randeria is hell bent on stubbornly going ahead with the project. But now with BMC asking for a portion of land of Bharucha Baug the other Trustees have at last told Kersi Randeria Enough. And the project has been shelved. But how long that time will show.

But coming back to the repairs of the internal roads of Bharucha Baug, Feroze Karkaria approached the Corporator/MLA of Andheri (W) for help to repair the internal roads and luckily he has received a positive response from local MLA Ameet Satam who is ready to repair the internal roads from his MLA Funds.

There was a coconut breaking ceremony conducted yesterday at the Club premises for the repair/ resurfacing of the Bharucha Baug roads . This was attended by MLA Shree Ameet Satam and Councillor, Smt Sunita Mehtaji. Also present were two BPP Trustees, Mr. Viraf Mehta and Mr Kersi Randeria. Mr Satam informed the gathering that the road work would start soon and be completed in two phases. Phase 1, road repairs and Phase 2 enhancing the wall of D block next to where the water tankers stand after road work repairs.

CORRECTIONS TO PROFESSION OF CANDIDATES PUBLISHED IN PARSI JUNCTION OF 21-2-2021

Against the name of Kaikhushroo Irani, Parsi Junction had shown his profession as 'Court Clerk'.

On WhatsApp and mail of Jamshed Salamat Irani, Kaikhushroo Irani has complained that he is 'Senior Advocate, High Court' and that Parsi Junction has demeaned him by calling him a 'Court Clerk'.

When we were informed of his complaint, we approached the High Court Bar Council to ascertain the correct fact. On inquiry we were informed that there is no 'Kaikhushroo Irani' registered as Senior Advocate on their Roster. Parsi Junction was further unofficially informed by one of the staff that one 'Kaikhushru Tavakulli' is enrolled as a Senior Advocate but there is no Kaikhushroo Irani enrolled as a Senior Advocate.

Under the circumstances we cannot and do not accept Kaikhushroo Irani as a Senior Advocate of the High Court and hence we cannot rectify the original profession disclosed in Parsi Junction of 21-2-2021 like we did in the similar case of Farahnaz Irani.

In fact we recollect seeing him regularly in the Small Causes Court carrying the brief and papers of his Senior Advocate of the moment with whom he was attending in Small Causes Court.

In fact it needs to be pointed out that this is the same Kaikhushroo Irani who lied to the Board of Trustees in collusion with Trustee Kersi Randeria that the Petits had filed Eviction Application before the Competent Authority for his removal and that Petits had won the application and he with his family would be homeless.

Actually he had won before the Competent Authority and had been given Leave to Defend which meant he was safe in his flat for the next 10 years at least. Not only that but the Petit Trust filed an Appeal with the Konkan Commissioner where also he won against

In spite of this since he was an employee of Kersi Randeria, the latter lied to the Board and got him allotted a 2RK flat of 600 sq.ft. in Palmlands, Contractor Baug on promise that he would reimburse the BPP Rs. 40 lakhs which they had paid the outgoing tenant to take possession of the flat.

Even though he is married to a Christian wife yet his Godfather Kersi Randeria who was the defacto Chairman at that time ensured that this BPP flat was allotted to Kaikhushroo Irani even with a non-Parsi wife and that too without any payment leave aside Rs. 40 lakhs.

Thus at present Irani is in possession and enjoyment of two Charity flats without paying a dime out of the agreed Rs. 40 lakhs. If you have a Godfather like Kersi Randeria on the Board you can get away even with Murder.

The issue is closed with no further correspondence needed on the same.



Well no, it's not harmful simply because it's water based sunscreen designed for kids and the UV rays from the sun are way more harmful for your kids' skin.

Your skin is actually the largest organ of your body. It is fragile and an essential organ. Application of your skin care products is equally important. If you don't apply the products in the correct order you will not see the best results from the regime.

A step by step guide on how to layer your skin care products.

Thumb rule is to apply the product with the thinnest consistency to the thickest. You also want to use the products with ingredients that are most important to penetrate and follow it with products that need to sit on top of the skin.

Daytime Regime:

Cleanser: The cleanser gives the skin a cleaner, fresher feeling and appearance. It prepares the skin.

Toner: Most people tend to skip this step, partly because there is an assumption that most toners are harsh and irritate the skin. Fortunately, the new breed of toners are



great and you can pick one as per your skin type. They act like a delivery system for antioxidants, vitamin B derivatives and even toning acids.

Face Serum: There are various face serums available now, depending on your requirement, as they address specific concerns. So it's better to keep them as close to the skin as possible. Some have retinol, hyaluronic acid, Vitamin C etc. But make sure you consult a dermatologist to get the right suggestion.

Eye Cream: The under eye and eye skin is extremely thin and needs most care. We have to prevent it from losing its laxity in the long run. Regular use of eye cream over time will keep the eyelid skin elastic and can improve or prevent against some fine lines or collagen loss. Remember: Nothing is magic. Results don't occur overnight.

Moisturizer: Yes, everyone needs a moisturizer even if you have oily skin. Most of us do need extra hydration after the havoc that sun, weather and harsh chemicals wreak on our skin. Best time to apply is when the skin is still damp. You'll be able to lock in the hydration sooner.

So even if you're indoors, if you're close to a window you still run the risk of exposure to UVA rays and possible skin damage. Therefore, do not skip sunscreen. Select your spf as per the extent of sun exposure.

Night time regime:

Make-up remover and cleanser: Remove your makeup first with a dedicated makeup remover before washing your face with a gentle cleanser.

Toners, Boosters and Essence: At night, some people after toning like to layer their skin with some hydrating boosters or essence to nourish the skin.

Eye Cream: Aside from addressing crow's feet and dark circles, eye creams can also serve to protect your delicate eye area from your other skin care products.

Skincare treatments and Serum: Night is the best time to treat your skin because the skin does most of its repairing, restoring and regenerating as we sleep. Your anti-ageing or de-tanning treatments can be performed now.

Moisturizer/Night Cream: A lot of people tend to use the same moisturizer in the day and night but it's better to use a night cream or a thicker moisturizer in the night so that it is absorbed over the course of hours. It also helps to avoid water evaporation while you sleep.
