
You are requested to kindly provide full cooperation to the above two representatives officially appointed by the Trustees,

Thanking you, A. F. SARKARI Acting C. E. O., B. P. P." However the Managing Committee for obvious reasons was not willing to have the elections conducted under BPP supervision and wanted to have their own **Election Commission and hence replied** as under:

Also, the Managing Committee of CCWA conveyed its urgent meeting on the 4th August 2020 to discuss this email received and would like to share with you all the gist of our discussion.

The elections of the Managing Committee of CCWA are governed by the Bye



Laws of the Association. The Managing Committee has taken all efforts to abide by them and ensure they are followed in spirit and not just in letter.

- As per Clause 12 of the Bye Laws of CCWA, the Managing Committee is assigned the responsibility to form an Election Committee.
- The Election committee has been formed with due consideration and deliberation of the members of the managing committee and considering they are highly ethical, responsible and respected personalities of the colony.
- The 2 members suggested in your email, Mr Sarkari and Mr Patel are too individuals of high character and ethics. The Managing Committee of CCWA unanimously vouches for their character.
- CCWA feels the BPP should have taken the CCWA committee into confidence at first, upon receipt of such a letter and

hear the facts from our side too. We always appreciate your practice of having this protocol followed by our Hon Trustees, before coming to any domestic decisions pertaining to our Colony. The current committee of CCWA has always maintained transparency with the BPP and its Board and we humbly reciprocate the same in return.

- CCWA Committee is shocked to see this letter written by our residents (23 in nos) as it indirectly throws the existing Election Committee Members under bad light, as if they are not trustworthy and maligns the reputation of our Election Committee (residents).
- CCWA also would like to put on record that this survey / campaign was done in secrecy by few individuals literally behind our backs.
- Current membership stands at 173 members of which 23 have sent you a dissent note. What would be reply to most of the remaining members in this case as the survey only represents a fraction of the current members.
- CCWA is also surprised by the speed of action in which BPP have acted to get this point tabled and resolved in your Board Meetings. We have had other numerous colony matters with BPP office bearers which have still not been addressed at all or have significant follow ups to be done and times to address.
- The Managing Committee also would like a copy of the letter which has been addressed to the BPP and would like to know the individual/s who have handed over the letter to the BPP. The current Managing Committee of CCWA has capable resources of addressing such dissent fairly and as per the rules mentioned in the Bye Laws.

The Managing Committee would like the BPP to review their decision based on the facts which have been now provided and sincerely leave the proceedings of the elections of Captain Colony to the appointed Election Committee of Captain Colony only, as per our Bye Laws.

The Managing Committee defiantly continued with its Election Commission and started the election process of calling for prospective candidates and on receipt of Jimmy Gadiwalla's nomination form informed Jimmy Gadiwalla, the very Founder of the Captain Colony Welfare Association as well as its Bye-laws and its Registration with Charity Commissioner, that he was guilty of a technical breach that 'he has to be a member of the Association at least six months prior to date of elections' which he was not.

The Managing Committee as a show of a magnanimous gesture by their letter dated 14th August 2020 informed Jimmy Gadiwalla that they would overlook the breach and have decided to allow Jimmy Gadiwalla, and Rayoomand Hira to contest the elections only if they could get a Consent Letter from all the other 11 contesting candidates to give their NOC to allow both of them to stand for elections in spite of not meeting the criteria as per clause 7(e) of the Bye laws and further their Consent letter was to be obtained from all the 11 candidates and to be submitted to the Managing Committee by end of day of the 14th August itself.

Asking a potentially disqualified candidate to obtain NOC of the other contesting candidates is itself malafide and against all norms of natural justice as no candidate would normally allow such a candidate to contest as his chances of being elected would automatically reduce and hence such a condition was unfair and unjust and was just a theatrical tactic to show how fair they are, well knowing that all 11 candidates would never give their NOC. It was a well orchestrated and preplanned gambit by the MC as both of them managed to get the sign of 10 out of 11 candidates giving their NOC to allow them to contest. Only candidate Vahista S. Ankleseria refused to sign the

Consent letter and based on that one refusal, the MC disqualified both of them.

THE GAMES PARSIS PLAY TO GET ELECTED EVEN ON THE MANAGING COMMITTEE OF Α COLONY ASSOCIATION!! DISGRACEFUL!!

Not just that but when Jimmy Gadiwalla pointed out that candidate Firoze Davar though suffering from the same technical breach was accepted by the MC as a candidate, they immediately wrote a nasty letter to Firoze Davar for trying to help the two disqualified candidates and on the same ground now disqualified Firoze Davar too.

Expecting no Justice from the motivated and self preservation seeking Managing Committee, Jimmy Gadiwalla again sought justice from the Trustees and forwarded to them the 1) letters of the MC dated 14th August to Jimmy Gadiwalla and 2) Rayoomand Daver disqualifying them for not having obtained Consent letters from all 11 candidates, 3) letter dated 18th August from MC to Firoze Daver disqualifying him, 4) letter dated 17th August from MC to Jimmy Gadiwalla denying the motivated disqualification of their candidature and advising them that 'TIMES ARE CHANGING AND SO SHOULD YOU', 5) letter dated 20th August 2020 from Pervez Tavadia giving the final list of candidates standing for elections.

But in response the Trustees immediately understood the injustice being done in not having a fair and transparent elections and informed the MC to postpone the elections till a fair solution to the controversy was worked out by them in consultation with all disputing parties. For lack of space we are not publishing all these letters.

But the MC was on a high horse and decided not to obey their request and sent the below mail regretting postponing the elections and unable to heed to the Trustees request:

We acknowledge receipt of your email dated 19th August 2020. We have had a discussion amongst our Managing Committee of CCWA today, 20 Aug 2020 to discuss this email received and would like to share with you all the gist of our discussion.

- We would like to draw reference to our email reply sent to your good offices on 4th August wherein we had stated in detail all our facts. This note was also acknowledged by Mrs Tirandaz -Chairperson on the same date and you are also marked in all these communications. Please recollect our email dated 23 July 2020 wherein we had mentioned our plans for Elections and enclosed the full circular with all details. In spite of the above, we are shocked to receive an email from you stating that you have not been kept informed about the election process.
- As per our email dated 4th August, we have not received the letters which have been submitted by our residents to your good offices. If you had sent them to us, we would have already clarified their dissent or doubts by now.
- As regards the point of 'serious irregularities' we would like to say that BPP has been unfortunately misled and as we mentioned in our note on 4th August, all the facts are not clear to you or being deliberately misinterpreted and brought to your attention.
- The following candidates have been disqualified after giving due consideration: o Jamshed Gaadiwalla
 - o Rayoomand Hira
 - o Firoze Davar

For Mr Jamshed Gadiwalla and Rayoomand Hira, on the 13th August we called for an urgent meeting of the Managing Committee which he agreed and attended to all the plan of actions. All documents have been enclosed for your perusal.

- As regards Mr Firoze Davar, there was an error of omission as regards his membership of last year and this man deliberately concealed all the facts out of malafide intent. Communication enclosed for your perusal.
- Please find below the list of Final Candidates which we have received from the Election Commission of CCWA. (file enclosed) The Elections will be held as per schedule dated 23 Aug 2020.
- If for any unforeseen reasons, the date of elections is postponed the list of candidates will stand to remain the same. This is as per our Bye Laws.

We don't see any valid reasons or justifications to postpone the elections, As you can see in our responses is clear and transparent. We respect your view but regret unable to heed to your request.

Nevertheless, we would request you to come over to Captain Colony tomorrow (Friday 21 August) so that we can discuss in person your views.

As requested by you, I'm sending the copy of the Bye Laws in a separate email on account of the size restrictions.

Those in our community and others too who interact with the BPP are now aware that they need to meet Kersi Randeria for everything; from a pin to an elephant! Ever since the new board took charge in October 2015, KERSI RANDERIA (KR) made it his business to manage the affairs of the BPP as if it was his personal fiefdom.

He decides appointments and dismissals from security guards to CEO's, contractors and architects, allotments of houses, doling out favors to his friends and family and getting vindictive with those who question him. Rather belatedly it has dawned on the community and some of his colleagues on the board that Randeria functions like a dictator and is perceived to be the main reason for the financial crunch faced by the BPP.

His dissent in his own newspapers, printed below every advertisement of the BPP when BPP intends to auction flats is only a facade to cover up a hidden agenda and has nothing to do with protecting Parsi properties from sales.

I have over the years demanded that the BPP disclose the complete details of the allottees of the 150 flats that were allotted from October 2015 to date but there is complete silence. In the words of Trustee Noshir Dadrawala if "the linen is clean than hang it out to dry"! Then what prevents the BPP from being transparent and accountable which was an election promise by almost all candidates? By allotting flats to a few selected needy and deserving, Randeria has tried to cover his tracks. In Mahim alone, I am privy to information to several flats that have been sold and the complete proceeds do not appear to figure in the BPP books. Where those funds have gone only KR will be able to explain.

The following will demonstrate how Randeria functions with impunity:

1. Some of the colleagues of RANDERIA feel that he is good at liaising with government authorities. However, I disagree with this. Sometime in 2017/18 when the Municipal Corporation of Greater Mumbai came out with the scheme of segregating wet and dry waste, and putting up plants for treating wet garbage, RANDERIA, instead of telling the then Municipal Commissioner that we will ensure the segregation of the wet and dry garbage but Solid waste management Is the duty of the Municipality, and we will have no part in that. But no - RANDERIA wishes to

The Trustees regret to inform you that the Managing Committee elections scheduled for Aug. 23, 2020 have been declared by the Managing Committee despite written directions given by the Trust to postpone the

Before the process started the trustees had appointed the Acting CEO Mr. Aspi Sarkari & Sr. Executive Ronny Patel to oversee the election process because of the internal differences between the candidates. Unfortunately, the Managing Committee in complete disregard of the directions of the BPP decided to go ahead and appoint an Election Committee.

It was a cause of concern for the Trustees that this so called Election Committee played no role in the Election process, and the present committee members all of whom are also candidates have controlled the entire process leading to objections and controversies.

The Trust had received complaints from some of the candidates and had therefore asked the committee members to send to the Trustees all the papers, more particularly, the bye laws of the Welfare Association.

We were surprised & pained that despite this request the committee members have till now not sent us the bye laws. Further despite two written requests to defer the elections, the present committee in its wisdom and in gross disregard to the wishes of the Trustees have announced the elections.

Residents are requested NOT to participate in this election as the Trustees have unanimously decided that that they do not recognize this elections, will not recognize any members, if elected through this election and will not have any interaction with any committee members if it so be elected.

Whereas the Trustees have never interfered in any baug / colony level elections, they have been forced to do so in this case due to the surprisingly unexplainable and unacceptable defiant attitude of the committee members.

The Trustees will be sealing the Meher Jinwalla Hall and will not allow these elections to be conducted.

We request the occupants for their cooperation and apologize for this unfortunate inconvenience.

please the authorities for reasons which will soon be in the public domain. He eagerly went ahead to set up a waste management plant on our sacred lands at the Doongerwadi. He was contemplating collecting the garbage from baugs and colonies all over Mumbai and then processing the same at Doongerwadi. I had vehemently opposed this move of his and unfortunately for him and fortunately for the community the orthodox lobby as well as WAPIZ, pressurized him to drop this nonsensical idea.

- 2. Instead of filing a legal suit, as advised by Mulla and Mulla, against the illegal demand in 2016-17 of Property Tax for Land Under Constuction (LUC) for the Godrei Baug Ownership bldg. construction right from 2010 though the construction had stopped for years for lack of sanctioned plans, Randeria convinced his colleagues to appoint a Liason company to reduce the Tax liability by paying them bribes in the guise of consultancy fees of Rs. 40 lakhs for the reduction in demand of LUC Tax. Raises doubt as to what was his cut from the huge fees of Rs. 40 lakhs paid to the company. CASH CRUNCH, Mr. Randeria!!
- 3. Inspite of wasting Rs. 40 lakhs consultancy fees, BPP yet has paid more than Rs. 5 crores as LUC Tax so far on a building languishing for years and will have to continue to pay every year this illegal demand of LUC Tax as demanded instead of going to Court and getting a stay on it. WHAT A WASTE OF RS. 5 CRORES! CASH **CRUNCH, MR. RANDERIA!!**

Is this how one deals with Government officials by appointing consultants?

- In some of the deals negotiated by Randeria, it has now come to light that the parties he had been dealing with are now wanted by law-enforcement agencies in India and abroad. Does this speak well of you Randeria? KR had negotiated with one Shetty of Dubai to hand over Parsi Lying in Hospital but luckily the Dubai police escapades of Shetty came to light before the deal was signed.
- 4. Randeria is not trustee material as he totally lacks humane touch. A person making tall claims in a paper owned by him about a food helpline that HE has started during the pandemic, denies meals to a poor Parsi resident of Khan Estate Mr. Bodhanwalla, only because the case was put up by me, though he was aware that the flat of Bodhanwalla will ultimately revert to the BPP upon his demise. Height of vindictiveness and insensitivity, RANDERIA!!!

5. Whenever his colleague Trustees proposed a reduction in the extra service charges levied from February 2017, as they too felt that it was a very steep burden on our residents, RANDERIA shouted from the rooftop about the cash crunch faced by the BPP.

RANDERIA did you not think of the cash crunch when YOU:

- a. Instigated your then gang of four majority Trustees for denying Armaity Tirandaz and Viraf Mehta access to official files and records which as legally elected Trustees they are entitled to and compelled them to approach the High Court to secure their rights. While they fought the case from their own funds, you spent Rs. 80 lakhs of B.P.P. community charity money in fighting this frivolous litigation. Why did you not fight this case with your own money? CASH CRUNCH?
- b. You favored one Mr. Kaikhushru Irani with a flat in Palmlands, Contractor Baug at Mahim. The incorrect excuse given by you for this largesse was that Mr. Irani has lost a case in court filed by Petit Trust for his eviction and is without a roof over his head, when in fact he had won both before the Competent Authority as well as in appeal before the Additional Commissioner, and also promised to reimburse the BPP Rs. 40/- lakhs spent by BPP to the outgoing Tenant and for which you stood guarantee. By lying and misguiding your colleagues you got the flat allotted to Irani even though he was married to a non-Parsi, superseding more deserving other Parsis. So where are the 40 lakhs since last three years of allotment which you said Mr. Irani will give to the BPP? CASH CRUNCH!!!

- c. A flat in Godrej Baug worth 60 lakhs was given by you to your lady partner's relative for just Rs. 8 lakhs though the relative was willing to give a Deposit of Rs. 30 lakhs-CASH CRUNCH !!!! Right K.R?
- d. You manipulated the appointment of Mrs. Shenaz Khambatta as the Jt. Dy. C.E.O. of B.P.P. on a very high salary when in reality she had approached the BPP only for a house. Despite knowing that she is a Canadian Citizen, you allowed her to seek a house of her choice worth a few crores in Cusrow Baug and without allotting the same as a Service apartment whereby the flat would revert to the BPP if she resigns or retires.

Wow RANDERIA what largesse - CASH **CRUNCH!!!**

- e. RANDERIA what about your Kaka's B.P.P. flat in Contractor Building, Byculla which after the demise of your Kaka, you surreptitiously transferred to your mother's name and also added the name of your nephew who lives in Godriei Baug with his mother. This despite you acquiring a large ownership flat at Dadar. You should have taken your mother to your large ownership flat in Dadar and surrendered the Kaka's flat to B.P.P. so that the same could be allotted to some poor and needy person. RANDERIA aren't you citing this excuse when you dissent to the sale of flats by B.P.P.? DOUBLE STANDARDS -**RANDERIA?- Dissent when other residents** want to encash their tenancy rights which is PERMISSIBLE UNDER THE LAW SINCE 2000, BUT WHEN IT COMES TO YOUR FLAT, SURREPTITIOUSLY TRANSFER IT TO YOUR MOTHER'S NAME AND ADD YOUR **NEPHEW'S NAME TOO WITH FUTURE GAINS IN MIND. RIGHT RANDERIA?**
- f. The 20 lakhs cash belonging to BPP found in the BPP cupboard and lost because of your attempted vindictive manipulation. Cash Crunch?
- g. You appoint most of the Senior as well as junior staff who retire from Godrej so that your control over them continues. Thus on retirement you immediately appointed Mr. Bilal Baig as Senior Engineer at Salary of over Rs. 1 lakh a month superseding late Mr. Rustom Toddywala, senior engineer since April 1997 at a measly Rs. 45,000/-.
- h. You have taken control of appointing contractors for repair jobs with your cut included in the quotation or bribe demanded later from him, as alleged by a contractor in writing to the Trust. My own case of bribe being offered to stop my protest against the illegal levy of extra service charges of Rs. 750/ pm is proof of your modus operandi
- i) Due to inter-se disputes in earlier board and stay order of the Charity Commissioner, the very successful scheme of encashment of Tenancy on 50:50 basis and auction of high value flats which had increased BPP funds from Rs. 16 crores in 1994 to over Rs. 250 crores in 2013, had come to a standstill from November 2013 because of a stay order manipulated by you. After the new board including you, Kersi Randeria, was elected in October 2015 and the Stay Order

of the Charity Commissioner was removed in January 2016, yet you did not allow the reintroduction of the successful Refundable Deposit Scheme for the next three years by which time you gifted away flats each worth crores to your friends and relatives and most needy Parsis willing to pay high deposits for BPP flats had purchased flats outside in private buildings and the market of Parsi buyers had depleted. Ultimately in 2019, when the other Trustees decided to overrule your Objection and resume the RDS, you deliberately and in breach of the **High Court Consent Terms, published your** Dissent Note below the Auction notice in newspapers owned or controlled by you so as to dissuade needy Parsis to bid for the flats. Luckily for you the Chairman who was proposing and in fact even threatened to file Contempt of Court proceedings or even a 41-D application for your removal as a Trustee, has suffered an unfortunate stroke thereby limiting his ability to function to take such action. CASH CRUNCH OF YOUR MAKING, MR. RANDERIA!!

i) Due to your animosity with Yazdi Kasad, the Contractor of Navsari, the Ownership C-bldg which is ready for occupation since years which would fetch around Rs. 15 to 20 crores, is rotting away in Navsari instead of encashing its sale value at the earliest. Did you not think of the Cash Crunch?

I could go on and on but I think the above instances of the loss caused to community funds and assets are enough to prove my charge of causing huge loss to the Apex body the BPP and consequently to the community and why you should not be removed/recalled as a Trustee of our apex Trust?

Now, now RANDERIA, don't tell the community that all the Trustees have consented to all that is mentioned above. By now the community is well aware that you are the DE FACTO chairman and you manipulate your colleagues to toe your line OR ELSE????. RIGHT RANDERIA? Community by now is well aware that YOU RANDERIA with your arm twisting tactics get your MAJORITY colleagues to do your bidding. The exchange of emails between some trustees and you will prove this.

Though it is well-known that all trustees are jointly and severally accountable for acts of commission and omission, may I remind you when in 2008, you and I were joint intervenors before the CC against all the Trustees of the then board in a 41 D application, you without my consent amended our application and dropped charges against all other trustees and decided to proceed only against Mr. Dinshaw Mehta. Likewise, the time has come when you alone should be facing action for your removal as Trustee under Sec.41-D for causing tremendous financial losses and for adhocism, favoritism and nepotism in the administration of the BPP and for bringing the Administration and the institution under a financial crunch.

Recently I had conveyed to all concerned that I will not endorse a copy to Randeria of any of my communications to the BPP as I have stopped recognizing Randeria as a trustee of the BPP. As a voter, since he personally had made tall promises to me and the community, I have a right to do so. If Randeria still does not disclose the complete list of flats allotted along with the terms and conditions of allotment, the names of the allottees and the justification of doing so, he should stop issuing legal notices of eviction on tenants/licensees on grounds of a bonafide requirement by the BPP in pursuit of the aims and objectives of the BPP trust deed ie. "to provide clean, comfortable and inexpensive residences for poor and needy middle-class members of the Parsi community professing the Zoroastrian faith". This is a hoax played on our courts of law and the legal system.

Randeria, your only option now is to reimburse the losses that you have caused to the BPP as amply stated above and resign!

WAIVER OF SERVICE CHARGES

The first Zoom Board Meeting of the BPP Trustees after the lockdown started on 24th March 2020 due to the Corona Virus pandemic was held on 29th July 2020 which unfortunately was attended by only three Trustees-Armaity Tirandaz, Viraf Mehta and Xerxes Dastur-whilst Kersi Randeria boycotted the board meeting due to controversy of Acting Chairman Armaity Tirandaz being elected prior to the proposed meeting as the Chairman has to finalize the Agenda of the meeting by noon of the day of (prior to) the board meeting as per the High Court Consent Terms. Noshir Dadrawalla recused himself from attending to avoid the expected disharmony and unpleasantness at the very first board meeting after four months.

At the said board meeting the Trustees unanimously decided to waive the full extra service charges of Rs. 750/ pm levied from February 2017 with effect from

September 2020. However the circular to all colony residents as well as colony Managers informing of the waiver was kept pending till the 29th July Minutes were approved at the next zoom board meeting scheduled for 7th August 2020. Unfortunately the item was differed at the said board meeting of 7th August which all the five healthy Trustees attended.

Hence item of approving the Minutes of 29-7 and 7-8-2020 meeting was Item 1 on the Agenda finalized by Armaity Tirandaz of the next board meeting held on 11th August 2020. However whilst four Trustees were agreeable to approve the said Minutes without any changes, Kersi Randeria who had even not attended the 29th July meeting insisted that the Acting Chairman had not prepared faithful Minutes of what transpired that day and wanted the draft of the Minutes prepared by the Administration to compare the two Drafts

to prove his point. The Acting Chairman Armaity Tirandaz readily agreed and instructed the staff to send the draft notes of the 29th July meeting prepared by the Administration.

Thus at the next Zoom Board Meeting of 18th August, the Acting Chairman Armaity Tirandaz proposed Item 1 of the Agenda as approval of the three Minutes as finalized by her of the Board Meetings of 29th July, 7th August and 11th August 2020. Much heat but without any light was generated by Kersi Randeria whilst discussing the Minutes in trying to point out discrepancy between the Minutes of the Acting Chairman and the draft notes of the Administration. However all his Objections were over-ruled by the four Trustees who approved the Minutes of 29th July with Kersi Randeria giving his dissent to the approval of the Minutes and sought leave to send his note for the dissent to the Administration which should be taken

as part of the Minutes as also the say of the other Trustees on his dissent note.

Subsequently the Minutes of both 7th August and 11th August were also approved only by the four Trustees with once again Kersi Randeria dissenting to the approval of both the Minutes which were attended by all five Trustees. Due to the overbearing attitude of Kersi Randeria towards the Acting Chairman Armaity Tirandaz at the meeting, one of the Trustees had to reprimand Kersi Randeria for trying to browbeat and harass the Acting Chairman and advised him to be civil and respectful to the lady.

As soon as the Minutes of 29th July were approved at Board meeting of 18th August, the Circular dated 18th August was dispatched to every BPP colony and Colony Manager to stop the recovery of the full extra Rs. 750/ pm from September 2020 in view of the residents suffering loss of jobs, decrease in income and non-payments of salary since the corona virus pandemic started in March 2020.

As expected we received the below mail from Phiroze Amroliwalla claiming to be the main opponent of this illegal levy of Rs. 750/ pm. Whilst we agree that he was one of the main opponent to protest against this levy, one should not forget the role played by the late Parvez Driver who was always in the forefront of the protest as also Armaity Tirandaz, Muncherii Cama and Viraf Mehta who opposed the increase from inception and Noshir Dadrawalla who proposed to reduce it first to R. 400/ pm and later to Rs. 350/pm as also all the Tenants of the various colonies especially of Gamadia colony who fearless of the consequences refused to pay this illegal Rs. 750/pm even though the manager refused to accept rent without the 750/ and giving them threats of eviction cases being filed against them.
