at all times will have to be maintained by their staff to ensure that such information will not be misused to capture/take over their residences.

In the Parsi Junction of 20th Sept 2020 we had called for Applications from such families affected by the Covid Pandemic who have not been paid their full salary or lost their jobs or their Income has been adversely affected. Whilst we have received two such applications, Dinshaw Tamboly has received a deluge of cases and through donations from our Champions of Philanthropy he has been able to help many such families.

Out of the two cases this paper received, one was A PATHETIC CASE from Nirlon BPP Complex who has lost most of his salary due to non-payment from his employers and to whom Dinshaw Tamboly on 22nd Sept sent mail to the Applicant that he would receive Rs. 10,000/ per month for six months from October 2020 to March 2021 from the WZO Trust Fund Covid Account and in addition since their childs school fees were to be paid the WZOTF Covid a/c would also pay their child's 4th 5th and 6th Installment of school fees of Rs. 42,200/ each in October 2020, January 2021 and March 2021 respectively. Thus a total sum of Rs. 1, 86,600/ as financial assistance will be given to this Nirlon family in the next six months.

The second case was of a family residing in Malcolm Baug who have been adopted by this paper and they will receive Rs. 10,000/ pm for the next six months.

This communication has been addressed to all mentioned in the list of recipients, on behalf of a donor, who through our good offices has been making substantial donations to various upcountry Anjumans for various projects.

Our donor has been very disturbed to read the details published in the latest issue of Parsi Junction (September 20, 2020) concerning alienation of community property at Rajkot.

The purpose of this communication is not to go into the merits or otherwise of the details published.

After receiving confirmation from the Rajkot Anjuman that there was no intent to alienate the Agiary Estate, donors, through our good offices

had contributed just under Rs. ten lakhs towards replacing the roof of the Agiary at Rajkot, the work for which was carried out between end January / early March 2020. Our donor has been considering having the Agiary painted for which a substantial outlay will be required.

Before we consider finalizing the painting of the Agiary, we would like to receive unequivocal and absolute confirmation from all concerned - BPP, FPZAI, Rajkot Anjuman - that the estate on which the Agiary is situated is not intended to be sold, disposed off or liquidated.

We look forward to receiving unequivocal and absolute confirmation from all addresses and also an assurance that should any other individuals / institution undertake such a misadventure, all of you - lady & gentlemen - will resist the same with all the resources at your command.

Early confirmation of all concerned will be very much appreciated.

HUMBLE APPEAL TO COWASJI DHUNJISHAW BAUG CHARITY TRUST

C. D. BAUG at S.V. Road, Goregaon (W), Mumbai 400062 was constructed around 2004 comprising of about 24 flats of 2RK each and were given out on Leave and License in December 2004 for three years which were subsequently renewed in 2008, 2013 and 2016 which was to expire in September 2019. Yes, most of the Occupants have prospered since then and they would no longer be deemed to be poor for whom the Baug was built. But in today's times a Parsi earning even Rs. 1 lakh pm would not be able to afford to buy a flat from the open market.

To their shock all the Occupants were refused to renew their expired Leave License Agreement and instead were told to vacate their premises and hand over vacant possession of their premises to the Trustees, all members of the Jeejeebhoy family-late Byram Nanabhov Jeejeebhov. Behram Doctor, Mr. Rustom Nanabhoy Jeejeebhoy, Mr. Jamshed **Byram** Jeejeebhoy, and Mr. Byram Rustom Jeejeebhoy having their office address at 83, Jolly Chambers II, Nariman Point, Mumbai-400051.

As a sop the Trustees offered them a window of two years to vacate during which time they would have to look for and shift to alternate premises after which they would have to hand over vacant possession of their premises back to the Trust.

Most of the Occupants rather than indulge in costly but futile legal exercise agreed to the Trustees proposal and signed Consent Terms in Court agreeing to vacate after two years. But a few of them decided to take their chance through the legal route.

However the Eviction suits filed by the Trustees before the Competent Authority at Bandra in September 2019 was decreed against them by the Competent Authority, (Rent Act) Konkan Division in January 2020 and eviction was ordered against them without any

relief of hearing the matter on merits nor given an opportunity of Leave to Defend. They then went in Revision Appeal in the Court of Additional Commissioner, Konkan Division in January 2020 and though the Revision Application was heard and closed for Orders in March 2020 itself, due to the covid pandemic the actual order was issued only in July 2020.

We appreciate the help rendered by the Trustees of the BPP of legal costs to these Applicants but wonder why they do not treat their own Occupants with the same sympathy and concern shown to Occupants of other Trusts. In fact we are aware that Kersi Randeria and another Trustee went out of their way to support and help the Occupants of Vasai Parsi Punchayet Trust at Valiv when the Trustees refused to make them Trustees of Vasai Parsi Punchayet including filing 41 D Application against them for their removal for which the BPP fully paid their legal costs.

Coming back to the C.D. Baug occupants, they have to now decide whether they wish to move the High Court or sign a two year moratorium allowing them to continue to reside for two years and hope that within that period they are offered alternate premises by some other Trust in possession of vacant flats. Whilst BPP may consider to pay for their legal costs, it will be difficult to give alternate accommodation out of turn with over 500 applicants on their own waiting list.

In view of this uncertainty affecting the health of most of the Occupants with families and small children, we most humbly appeal to the Jeejeebhoy family, whose Philanthropy and largesse has had no rival to date, to consider the cause of these Parsi families and allow them to keep on continuing their Leave License for at least five years so that they can continue to reside in your Baug without any mental strain affecting their and their families physical well being.

HIGH COURT EXTENDS DATE OF **ELECTIONS BY SIX MONTHS**

In the Parsi Junction issue of 30th August 2020, we had informed the community of the Trustees decision to move the High Court to extend date of elections due to the unfortunate demise of Trustee Zarir Bhathena on 24th June 2020. Under normal circumstances elections for his replacement would have to be held by 23rd September 2020.

However due to the pandemic stuation prevailing at present, Trustees decided to postpone the elections by six months upto 23rd March 2021 and through their Advocates Mulla and Mulla moved the High Court for such relief. The Miscellaneous Petition No. (L) 3064 of 2020 was filed on 11th September 2020 and the Charity Commissioner's office was also served on the same day.

The Application came up for hearing at Serial No. 24 on 14th September, 2020 and Serial No. 23 on 16th September, 2020 before His Lordship the Hon'ble Mr. Justice B. P. Colabawalla. However, on both dates the matter did not reach. Thereafter, the matter was listed at Serial No. 9 on 21st September, 2020 before His Lordship the Hon'ble Mr. Justice B. P. Colabawalla when the matter was heard in detail and Order was passed on same day as under:

- 1. This Miscellaneous Application has been filed seeking an extension of time for appointment of a day for the election (and for holding thereof) to fill the vacancy caused by the demise of the trustee Mr. Zarir Manchershaw Bhathena, who expired on 24th June, 2020. The extension sought is for a period of six months from 23rd September, 2020 or such other reasonable period as this Court deems fit.
- 2. Mr. Dandiwala, the learned advocate appearing on behalf of the Petitioners, brought to my attention Clause 16 of the Scheme for the Election of the Trustees of the Funds and Immovable Properties of the Parsi Punchayet of Bombay. Relying upon the aforesaid Clause, he submitted that under normal circumstances when a vacancy occurs, the same has to be filled not less than 28 days and not more than 3 months from the date of such vacancy. This vacancy is to be filled up by a process of election. He further brought to my attention the proviso to Clause 16 which stipulates that if an election is not fixed during three months period, then an extension can be granted by the Court. Thus, in these circumstances, he submitted that the present Petition is filed seeking extension of time for appointment of a day for the election to fill the vacancy caused by the demise of Mr. Zarir Manchershaw Bhathena. He submitted that this has become necessary in view of the COVID-19 Pandemic and it is in these circumstances the aforesaid relief is sought from the Court.
- 3. Ms. Chavan, the learned AGP appearing on behalf of the Charity Commissioner

has fairly stated that as far as the extension is concerned, the Charity Commissioner would submit to the orders of the court.

- 4. On hearing Mr. Dandiwala and Ms. Chavan and on going through the abovementioned Petition, I think it would be in the interest of justice to grant extension as sought.
- 5. Accordingly, the Petition is allowed in terms of the prayer clause 17A, which reads thus :-
 - "17 The Petitioners therefore pray that: A This Hon'ble Court be pleased to grant extension of the time for appointment of a day for the election (and for holding thereof) to fill the vacancy caused by demise of the trustee Mr. Zarir Manchershaw Bhathena and for carrying out other formalities as per the said Scheme, by 6 (six) months from 23rd September, 2020 or such other reasonable period as this Hon'ble Court deems fit."
- 6. Miscellaneous Petition is accordingly disposed of. However, there shall be no order as to costs.
- This order shall be digitally signed by the Private Secretary/Personal Assistant of this Court. All concerned shall act on production by fax or e-mail of a digitally signed copy of this order.

WE HAVE RECEIVED THE BELOW CLARIFICATION FROM THE TRUSTEES OF THE PRAYER HALL TRUST FOR PUBLISHING **IN THE PARSI JUNCTION ISSUE:**

The Prayer Hall Services & Maintenance Trust

September 23, 2020

PUBLIC NOTICE CUM CLARIFICATION

In view of the frequent queries we have been receiving over the last few weeks, the Prayer Hall Services and Maintenance Trust ('PHS&MT' or 'Trust') would like to correct misleading and incorrect information being circulated in the media - particularly digital/social media and also provide certain clarifications, about the type and nature of services provided by PHS&MT, the role and responsibilities of the Coordinator and re-emphasize certain other facts which members of the public may not be fully aware of:

- 1. The ownership of the Prayer Hall vests with the Municipal Corporation of Greater Mumbai (MCGM) and the PHS&MT has no proprietary rights over the Prayer Hall.
- 2. The Prayer Hall is available for use by members of all communities, religions, faiths and not only Zoroastrians. It is therefore incorrect to refer to it as the 'Parsi Prayer Hall'.
- 3. Any Parsi Irani Zoroastrian, wishing to use the Prayer Hall for obsequies, is free to have the ceremonies and prayers performed by a priest of his / her own choice.
- 4. The object for which the PHS&MT has been established is: (quoting from the Trust Deed) "to assist the members of the Parsi / Irani Zoroastrian community in using the Prayer Hall at the Worli Cemetery and its cleanliness and upkeep".
- 5. In order to assist Parsi Irani Zoroastrians who wish to use the Hall, Er. Framroze Mirza has been appointed as Coordinator. He is contactable 24X7 on the following Telephone Numbers (+91) 8691012488; 9821421593. His role as Coordinator is to assist in giving details regarding an ambulance or hearse, preparing the Prayer Hall for each ceremony, providing for items required during ceremonies such as sukhad, flowers, fruits, etc.(at a cost to be decided mutually between the concerned parties) in case the officiating priest is not in a position to do so and providing guidance with regard to documentation prescribed by the authorities. The scope of his work includes overseeing security arrangements, cleaning & upkeep of the Prayer Hall and safe custody of all moveable items kept at the Hall.
- 6. It so happens that Er. Mirza is also a practicing priest and is one of the few priests who perform prayer ceremonies at the Prayer Hall. Families who either do not have a priest or whose priest is not willing to perform obsequies at the Prayer Hall, may if they wish, request Er. Mirza to conduct the prayers and arrange for

other priests required for performing certain ceremonies at the Prayer Hall. It is important however to clarify that there is absolutely no compulsion to enlist his services and members of the community are free to have ceremonies performed at the Prayer Hall through any priest / priests of their choice and are not bound in any way to get any ceremonies performed through Er. Mirza or the priests who work with him.

- 7. The PHS&MT is neither entitled to, nor does it engage priests for prayers to be performed at the Prayer Hall and accordingly cannot charge, or receive, any consideration for obsequies to be performed at the Prayer Hall. All matters pertaining to the payments to be made to the priest/s and the ceremonies to be performed must be directly discussed and agreed between the concerned priest/s and the person availing of the priest's services and the Trust is in no way concerned with the same.
- 8. The PHS&MT had over the past few years since it was set-up, followed a practice of issuing advisories as to the maximum amounts, which any priest who carries out ceremonies at the Prayer Hall, and not just Er. Mirza should charge, in respect of the various prayer ceremonies. The charges were meant to be indicative and issued as a guideline from time to time so that some sort of parity was maintained with the charges for similar ceremonies performed at Doongerwadi or in an Agiary or Atash Behram. The Trustees have decided to stop this practice forthwith, in view of the uncalled-for accusations levelled against the Trust, coupled with the fact that no other institution is doing so. The Trust has accordingly removed the Rate Chart from its website.
- 9. During the Covid 19 pandemic, bodies of persons who were Covid positive are brought to the crematorium, which is located in close proximity to the Prayer Hall. If the deceased person is a Parsi / Irani Zoroastrian whose family wishes to have Geh Sarna ceremony performed, the same has to be done in the parking area outside the Prayer Hall with the body of the deceased kept in the ambulance/hearse till the prayers are complete. This is in accordance with directions issued by the Municipal Corporation of Greater Mumbai. Er. Framroze Mirza has indicated his willingness to carry out the Geh Sarna ceremony as per these directives outside the crematorium in the car parking area. The family of the deceased person is free to engage any priest of their choice for the Geh Sarna and such arrangement has nothing to do with the Prayer Hall Services & Maintenance Trust, because as of now, it is impermissible by regulation to bring the body of the deceased (who was Covid positive) into the Prayer Hall.
- 10. Finally, it is important for those who wish to avail of the services of the Prayer Hall to know that the amounts which the Trust can afford to pay to the cleaners, watchmen & helpers working at the Hall are extremely low. Since the Trust is not charging for any services provided, it relies solely on the interest earned on its corpus and the small donations it receives from grateful users. Accordingly, it was decided some years ago that Er. Mirza would recover an amount of Rs. 6,000/-from users of the Hall for gratuities to be distributed amongst various service providers as necessary,

in order to supplement their meagre earnings and consistently maintain the high level of service and cleanliness that the Trust has always ensured, since its inception. Unfortunately, Er. Mirza has had to face uncalled for criticism and considerable resistance for this payment and has been questioned why this amount is collected in cash and even been asked why he does not give a receipt for the same.

The Trustees have decided that in these circumstances, the earlier arrangement will be discontinued and Er. Mirza will no longer ask for the amount of Rs. 6,000/- from users of the Hall. The Trustees realise that this will further strain the limited resources of the Trust, at a time when interest earnings are depressed, but an attempt will be made to enhance the payments to service providers at the Hall. The Trustees are sure that the goodwill and generosity of users of the Hall will see us through this difficult phase and sincerely hope that the Prayer Hall is maintained at the same level of service and cleanliness as always.

Your old habit of making use of me as a resource and then kicking me in the butt telling me to get lost so that you proceed with your own selfish agenda will never leave your mental software ever.

D. About me unilaterally changing the meeting date, let me clarify further.

In the meeting of 4th September 2020 at Worli naka with Mr. Khanolkar and his team of 8 engineers and just 2 of us you had stated that placing the Parsi Gate opposite the Al Sabah Court was dangerous as the tetrapods are highest there.

Next morning I am really ill, I confirm with Nauzer Bharucha if he was attending and he says no. So I call Vijay and also message Mr. Swamy requesting to change the date as I was ill to Friday so that I can attend too. 


