

# CHILDISH KERSI RANDERIA & NOSHIR DADRAWALA

It seems like just yesterday Kersi Randeria was going about town complaining about Yazdi Desai's Saturday Durbar(as he liked to call it), at the Wapiz office. Now Randeria has managed to rope in Noshir Dadrawala to do the same. His excuse, as pathetic as it is, is that the BPP Board meetings are being held over zoom.

I think Mr. Randeria has forgotten that over the last 9 months the BPP managed to give over 5000 free meals, help the poor and needy with food, clothes and medicines and also help our mobeds in need of help. All this was done through conference calls and online meetings.

Since official Zoom Board meetings begun end of July, the BPP has managed to tackle every hurdle that it has come across. Even the staff agree that the functioning has been seamless.

There has been no issue which has suffered because of this form of meeting. Housing was on hold until last month first because the office of the Registrar was not open and then because of the complications due to the death of Trustee Zarir Bhatena.

All these meetings were being attended over zoom by all the five trustees. With the lockdown being partially lifted, two trustees seem to believe that life is back to normal. Mr. Dadrawala brags about travelling by taxi, eating at restaurants and meeting people all the time while Mr. Randeria, despite a few of his family members having contracted Covid already, brags about how he keeps visiting his functioning factory in Gujarat.

Both of them need a reality check! They need to realise that they are not only putting themselves at risk but their family and friends too. And now they intend to put our community members at risk.

For the last two weeks both of them, like stubborn children, have told their colleague Trustees that if no physical board meetings are held, they will not attend the zoom meeting. Without even discussing this at a Board meeting, they have decided not to attend the BPP Zoom Meetings and instead sit in the BPP office at the exact same time as the zoom meeting. Their excuse is that 'important files' on certain items which are available only at the BPP need to be perused during discussions. Of course they fail to mention that for all these months things ran just fine. Admin was instructed on which files to keep handy during discussions. If ever a file was not available at that time, the item was deferred by a week by which time not only did admin email the entire Board all the relevant information but also keep the files handy.

Please ask yourself a very simple question:

If Mr. Randeria and Mr. Dadrawala are already sitting in the BPP Board room which means they have access to whatever file they need, then why can't they just log in to the Zoom meeting from there and join their colleagues Trustees?

The answer sadly is EGO.

For the last few months, Kersi Randeria has found himself in a minority in the BPP and his frustration is very visible. He has made it his agenda to delay and oppose literally every decision the BPP is trying to implement. He doesn't allow BPP clarifications to be printed in the Parsi Times but instead he and Noshir write week after week trying to justify their vain stand.

In the recent past, Mr. Randeria has blatantly been misusing his own paper and has constantly been taking jibes at his colleague Trustees, not Noshir of course. He lambasts his colleagues for allowing the BEST to run three ten-inch electric cables along the Doongerwadi wall but will not tell the community that he was part of the decision made by the BPP (unanimously) to allow the BMC to run a 4 foot water pipe through the Doongerwadi.

Mr. Randeria keeps trying to twist the simple usage of a drone, over the landslide area, into a religious issue and blames his colleagues for the same. But he will not tell you that Noshir Dadrawala was also part of the decision to allow the drone. He will also not tell you that he was in favour of a cremate ni bungli at the Doongerwadi.

And of course now their pettiness is in front of the entire community. They choose to sit in the BPP Board room meeting six or seven individuals instead of tackling important discussions like the sale of the Navsari ownership building, sale of the Godrej Baug ownership building, potential settlement of 70 crores with HPCL or most important of all, the upcoming elections in March because of the untimely demise of Trustee Zarir Bhatena.

The BPP has been in deep financial trouble ever since the new board took over. Thanks to Mr. Randeria and his majority, all flat auctions were put on hold for the first few years. Without any alternative being given to the BPP, the accounts ran dry. So bad is the situation that the BPP was not able to make October Salary payments on time. They paid the October and November salaries together.

With so many important issues needing urgent attention at the BPP, it makes us wonder whether the real agenda of Mr Randeria is to either stop the functioning of the BPP or bankrupt it. And given the recent disclosure of the dismal state of his personal finances, the latter could just be a possibilty.

Noshir Dadrawala has been telling people that all he is asking for is one physical meeting a month. Yet, despite the rest of the Board agreeing to do so from Jan 2021 and even putting out a public notice, he along with Kersi Randeria gave another front page ad in the Parsi Times yesterday once again stating that they will not attend the zoom meeting and instead will sit in the BPP Board. It is high time he learns to man up to what HE believes and not what he is told to believe by Kersi Randeria.





# WATER SUPPLY ISSUE AT NEW KHAREGHAT COLONY, 'B' BLOCK AND MALBARI BUILDINGS





Since the last few days a new problem has developed at New Khareghat Colony, especially concerning B building and Malbari building therein.

It seems that water is supplied from the Reservoir at Malabar Hill, next to Ambawadi, to New Khareghat Colony through pipelines passing through Spenta building property which still belongs to the Bombay Parsi Punchayet as the Lease Deed of the land and building Spenta is still not Executed nor Registered.

Recently one of the pipe lines supplying water to B building and Malbari building started leaking heavily due to its corrosion, leading to flooding of the basement of Spenta. On a complaint to BMC, stop valves were placed on the pipelines at the entrance of Spenta, resulting in stoppage of water supply to New Khareghat Colony. Since then the residents have had to rely on water tankers for their water supply.

With the Khareghat Colony Residents Association led by Bakhtyar Vajifdar and Malbari building activist Phiroze Amroliwalla taking an active interest in restoration of water supply, plans for repairs have been initiated by installing new pipelines skirting Spenta down to New Khareghat Colony. But the Occupants of B building were saddled with the cost of laying new pipelines.

This is where the co-operation given by the Trustees to BMC to lay the 24 inch pipelines through Doongerwadi came to



their assistance. When Trustee Viraf Mehta approached the Water Dept. at D Ward for help, the Hydraulic Engineer and Asstt. Commissioner of D Ward has promised them full assistance. We are hopeful that shortly water supply will be restored to them. For a better understanding of the gravity of the situation we give below the sequence of events concerning the water problem.

We received a copy of mail sent by Phiroze **Amroliwalla to the Trustees as under:** 

Dear all,

On December 17, 2020, in response to a WhatsApp message, I attended a meeting scheduled for 6.30 pm but preponed to 4.30 pm. This meeting was in connection with the replacement of three water pipes supplying water to 'B' Block and Malbari Building in New Khareghat Colony.

Mr. Hoshedar Divwala spoke on the issue and stated that though only one pipe was leaking at present, as the pipes were old and corroded, he suggested replacing all 3 as a long term solution for the problem. Thereafter I suggested that we should first represent the MCGM and stress the fact that though the pipeline runs through our BPP property, the responsibility lies with the Municipality to replace the leaking/corroded pipes up to the meter which is located adjacent to our Malbari Building. This was before my visit to the point of origin of the pipes on Ridge road outside Spenta Building.

Courtesy of Hoshedar, we both visited the Spenta Building and Hoshedar pointed out the spot where I was informed that at the request of office bearers of Spenta Apartments, the local ward level BMC department has installed three shut-off valves which they (Spenta) shut off when there is leakage in their car parking area. This is the cause of the stoppage of water supply to our buildings. Therefore Spenta wishes that these pipelines be diverted from outside their building which will result in a drop in water pressure as the pipes will run facing uphill and the water pressure will further drop due to raising vertical pipes to cross over the wall and thereafter drop down through hilly terrain towards our buildings. Mr. Hoshedar agreed that this diversion will result in a drop in pressure.

The easy way out is for residents to fully contribute and get the work done at the residents' cost. A word of caution: Not every resident family can spend time and again a few thousand Rupees, and there will be a few who resist on principle saying it is not their responsibility. Both these valid reasons pass an extra burden on to those willing to pay. The BPP, though being the landlord, is NOT responsible for this as the problem is created by the leakage to Spenta and the pipelines are the MCGM's responsibility. However, I must caution here that in-spite of spending from our pockets we face the prospect of lower water pressure for reasons explained above.

In view of the facts stated above, the residents are left with the following options, which to my mind is the proper way to move forward:

A) The leakage is affecting the Spenta Apartments due to old and corroded MCGM pipelines and therefore these two parties have to sort it out between them, NOT by getting shut-off valves fixed outside their building and then misusing them BY SHUTTING OFF WATER SUPPLY TO KHAREGHAT COLONY.

This option will naturally, be time-consuming, therefore, in the meantime, Spenta should be warned to ensure that these valves are not shut off at any time as this affects our water supply and they, in their own interest, should expedite the above action.

B) Senior-level, preferably Trustees of

BPP, should represent to the Municipal Commissioner and bring to his notice that this switching off the water supply by Spenta is unlawful thus affecting water supply to Khareghat and therefore take appropriate action including issuing instructions to replace the leaking/corroded pipes to resolve the matter.

The Trustees may remind the MCGM of their having cooperated only recently by allowing 2 feet diameter water pipelines through Doongerwadi and should prevail upon the Water DEPT of BMC to replace and relocate the new pipeline supplying water to B bldg.

C) Another alternative could be for all stakeholders to approach MLA Mr. Lodha or the local Corporator to fund these repairs from their MLA/Councillor funds.

The above suggestions are made in good faith with a view to helping resolve the issue without burdening the residents every time.

### Phiroze Amroliwalla

In response the Residents Association requested the Trustees to take up the issue of restoration of water supply with D Ward and temporarily worked out a plan of water supply through C building supply lines to the affected buildings. We give below the mail of the Association requesting Trustees help:

Dear Mr. Amroliwalla,

It would have been prudent to address the letter to the Trustees and the Executives of the BPP, with a 'cc' to our association, as they are the governing body of our trust while we are only facilitators on behalf of the colony residents.

That being said, thank you for the detailed summary of our meeting and putting forward your points succinctly.

On behalf of the affected residents, we appeal to the Trustees to please take this forward with the Water Department of BMC.

In the meantime, the residents of 'C' building have graciously allowed the severely affected residents of 'B' Building in the new colony a temporary connection, through the BMC lines connected to 'C' building. This work has already been carried out.

We hope that this will be a temporary arrangement and not a permanent one, as it may lead to a drop in capacity of water flowing into each building, as the timings presently are severely restricted due to ongoing work on Ridge Road.

We are sure that with a little pressure from our Trustees, the Deputy Engineer - Water Works - BMC, will definitely help us in this situation.

On learning of the distress facing some of the residents, Trustee Viraf Mehta visited Spenta basement to assess the leakage and then approached the water dept. officers in D Ward office for necessary action and assistance to solve the water supply problem. The D Ward staff were very co-operative especially in view of the Trustees coming to their assistance by allowing new 2 feet water pipelines being installed through Doongerwadi to supply water to most of D Ward after the landslide in August 2020. However they requested time to get approval from the Hydraulic Engineer for doing the needful. We give below the mail of Viraf Mehta on the water supply issue:

Hi Bakhtyar and Mr. Amroliwala,

I went over to Spenta bldg last week and met with Mr. Rustom Vazifdar to assess the problem

Post that I had a conversation with Water Dept BMC to try and resolve the leakage quickly. Later, a different and more permanent solution of moving the pipes around Spenta was discussed.

I will definitely use our good offices with the BMC and try and get this matter resolved expeditiously.

Considering the help the BPP has provided the BMC in the recent past. I am sure we can try and get this change made with little or no cost to the residents or the Trust.

Shall follow up with them again and keep you posted.

The Board of Trustees have decided to hold physical meetings one or two times a month from January 2021 and rest on virtual medium of zoom.

Whilst Noshir Dadrawala has welcomed this move yet the petty Kersi Randeria insists that he will not attend any Zoom meeting and has the audacity to propose in the Parsi Times that we will hold two meetings every month, once every fortnight, but we will not have any Zoom meetings as they are a waste of time.

The physical meetings were not acceptable to the Board of Trustees as there would be no control on the number of beneficiaries who would physically attend the BPP office.

However once Noshir agreed not to allow any beneficiary to attend the BPP Boardroom without prior appointment, the Board of Trustees have agreed to hold alternate physical and Zoom meetings which has been accepted by Noshir as a good thing. Of course Noshir gets swayed by Kersi Randeria very easily and it is to be seen how he will react to alternate Zoom meeting if Kersi does not attend.

Kersi Randeria has been inflicted with the Covid 19 virus sometime back and hence has a certain immunity to its recurrence and is keen to ensure that other Trustees also get infected and hopefully succumb. Hence his diabolic opposition to the Zoom meeting and insistence on physical meeting.

The Board of trustees have conducted over 20 board meetings on zoom and it would be unfair to term it that it was a waste of time. Many things have been achieved and at right time a marksheet will be prepared to show the cussedness of Kersi Randeria not to attend zoom meetings. In fact much more has been achieved when ever he has absented himself as he loves to hear his own voice and goes on and on on the pettiest issue to ensure that not much is achieved. But since his absence far more work has been done and the Trustees hope that he remains absent for more meetings.
