

## MYSTERY OF THE CASH RS.20 LAKHS FOUND IN LATE CEO'S CABIN STILL CONTINUES

In the Parsi
Junction issue of
31st January 2021,
we had pointed
out that On 27th
January 2021,
MRA Marg police
informed Khojeste
Mistry, who claims

to be a Parsi Preacher and Gods follower, to come to the Police Station to collect the cash Rs. 20 lakhs lying with them in his FIR filed by him.

Khojeste Mistry passed on this message to BPP CEO who in turn sent mail to all BPP Trustees on Wednesday 27th January 2021 as under:

### "Dear All.

We have received a call from Ex-Trustee Mr. Khojeste Mistree informing that he had received a call from Jamadar Gaodeh of MRA Police Station stating that the 20 Lakhs INR should be collected.

This is for your information. Aspi F. Sarkari"

Under normal circumstances one would have expected the Trustees to be proactive on a urgent conference call to depute some senior staff the same day to go to MRA Marg police station

to collect the badly needed cash Rs. 20 lakhs belonging to BPP just rotting away in the police safe without any return.

But once again the criminal mind of Kersi Randeria went into overdrive and realized that his accusation that this Rs. 20 lakhs was the same misappropriated transfer fees would no longer hold good and hence Kersi Randeria advised his colleagues that since matter was subjudice to take no urgent steps to collect the Rs. 20 lakhs cash but to await further discussion at next Board meeting to be held on Tuesday 2nd February 2021 and decide further course of action.

At the physical Board meeting held on Wednesday 3rd February 2021, Kersi Randeria deliberately ensured that this matter did not come up for discussion and the matter got postponed to next board meeting to be held on 9th Feb 2021.

THUS IN SPITE OF CASH CRUNCH FACED BY BPP, CASH RS. 20 LAKHS BELONGING TO THE TRUST AND THE COMMUNITY IS LYING SEALED IN THE BPP CUPBOARD SINCE AUGUST 2014 AND THEREAFTER TILL PRESENT DATE IN MRA MARG POLICE LOCKER.

WHY IS KERSI RANDERIA NOT ALLOWING ADMINISTRATION TO APPROACH MRA MARG POLICE STATION TO INQUIRE INTO THE POLICE REQUIREMENTS BEFORE THEY CAN RELEASE THE RS. 20 LAKHS TO THE BPP.

Knowing the vindictive and vengeful character of Kersi Randeria, this paper in its role of Investigative Journalism sent its staff to MRA Marg Police Station and on inquiry have learnt that Jamadar Gaode had phoned up Khojeste Mistry several times and requested him to come to the Police Station and contact him when he will be able to advice the next procedure to be followed to release the money in his favor.

We were informed by Jamadar Gaode that the Rs. 20 lakhs Cash deposited in the 38th Magistrate's Court has been deposited in MRA Marg Police Station Locker in Khojeste Mistry's Complaint No. MECR 02/2014 u/s406, 420 and 34 IPC as seized property AMOUNTING TO Rs. 20,01,000/=. Hence the amount can only be returned to Khojeste Mistry and no one else though the money does not belong to Khojeste Mistry but to BPP Trust.

Jamadar Gaode further informed us

that only Khojeste Mistry has to file an Application in the 38th Magistrate Court at Ballad Pier for Return of Seized Property in the pending MERC Complaint No. 02/2014 and the money will be returned to Khojeste Mistry who will then have to forward the Cash of Rs. 20,01,000/ back to the BPP Trust.

We recommened to appoint Advocate Akil Seth with Mobile No. 9930010999 who is famous for making Application for Return of Seized property with very reasonable charges. Hence it is advised that Khojeste Mistry should approach this Advocate or any other Advocate of his choice and file an Application for return of seized property before the 38th Magistrate's Court, Ballad Pier.

Regarding the cash Rs. 20 lakhs found in the CEO's cabin in August 2014, The police did a detailed investigation questioning each and every member of the staff from the highest Officer to the lowest clerk and then submitted a detailed Report in May 2015 to the Trustees that the Rs. 20 lakhs Cash lying in the cupboard was BPP's money belonging to the community and gave a finding that it was money belonging to the BPP and advised to use it for community benefit and unsealed the cupboard and the locker in the cupboard.

However before the money could be deposited in the Bank account of BPP, Kersi Randeria and Arzan Ghadially, instead of taking advantage of the police clearance of the cash of Rs. 20 lakhs, approached the Dy. Commissioner that the MRA Police had done a shoddy investigation and to order a re-investigation which was accepted by the Dy. Commissioner and the safe and cupboard was resealed with police ordering not to touch the Cash Rs. 20 lakhs lying in the cupboard.

The witch hunt of Kersi Randeria and Arzan Ghadially to somehow discredit Dinshaw Mehta in the eyes of the community so that the community stops electing candidates put up/supported by Dinshaw Mehta was so strong that they were willing to sacrifice Rs. 20 lakhs of community charity funds to get their revenge on Dinshaw Mehta.

After the new Board was elected in October 2015, all the Trustees including Yazdi Desai, Khojeste Mistry, Kersi Randeria and others agreed that transfer fees was only Rs. 45 lakhs which has been received in full by BPP in November 2013 and on that basis Kersi Randeria got his colleagues to sign a Resolution on those lines that since full transfer fees of Rs. 45 lakhs has been received Musharraf should be recognized as Tenant of first floor premises of Dadi House.

Under threat of closing down his Guest House activity in Dadi House, Kersi Randeria got Musharraf, a co-accused in June/ July 2016 to give at least a limited Affidavit that they gave Rs. 20 lakhs by four donor cheques in early 2013 and Rs. 25 lakhs cash to the wife of late CEO at his residence on 31st March 2013 which was replaced by five donor cheques amounting to Rs. 25 lakhs in November 2013 by Dinshaw Mehta.

This RESOLUTION copy signed by all seven Trustees was handed over by **Kersi Randeria to Musharraf Kader with** one hand and with the other took the Affidavit of Musharraf, a co-accused that cash Rs. 25 lakhs was returned to him in November 2013 by Dinshaw Mehta and not by late CEO, which Khojeste Mistry then submitted to Court for further investigation in 2016 and which ultimately led to the watered down meaningless charge sheet of use of BPP CASH OF Rs. 25 lakhs from March 2013 till November 2013.

Thus if it is accepted as all the Trustees have done that transfer fees was Rs. 45 lakhs which has been received in full by BPP in November 2013 itself than this cash Rs. 20 lakhs found in CEO's cupboard and now to be collected from the police has no connection with the pending complaint even if it is subiudice.

It is time that the Trustees see the writing on the wall and dismiss any perverted reasoning of Kersi Randeria not to collect the cash if the police are willing to hand it over and hopefully the cash Rs. 20 lakhs will come back to the coffers of BPP and the community for charity use.

Howeveritis open to doubt whether both **Khojeste Mistry and Kersi Randeria will** allow this Rs. 20 lakhs to be returned to BPP as both of them had made false and fabricated accusations that this is the Rs. 20 lakhs cash found in the late CEO's cupboard that Dinshaw Mehta had misappropriated out of Rs. 65 lakhs transfer fees for the Dadi House Tenancy and only Rs. 45 lakhs had been received by BPP in November 2013.

In that case the whole allegation of misappropriation fails and both of them would have to apologise not just to Dinshaw Mehta but his whole family as Kersi Randeria is on record telling Viraf Mehta and other Trustees that his father is a crook who usurped Rs. 20 lakhs of Trust Funds. Now since it is admitted by all concerned that transfer fees were only Rs. 45 lakhs and never Rs. 65 lakhs nothing further survives in the complaint of Khojeste Mistry.

Time will show whether Khojeste Mistry is a Man of Honor to own up his mistake and repay the money to BPP and apologise to the Mehta family for the false and baseless accusation of theft of Rs. 20 lakhs out of imaginary transfer fees of Rs. 65 lakhs whilst all knew it was only Rs. 45 lakhs. At the most the charge that can be levied is the use of Musharraf's Rs. 25 lakhs cash given on 31-3-2013 to Mehli Colah's wife for six months which was returned by Dinshaw Mehta according to Musharraf in November 2013 but according to Dinshaw Mehta was returned to Musharraf in April/May 2013 by Mehli Colah as per instructions of Yazdi Desai and Khojeste Mistry and once Musharraf could arrange the white payment of balance Rs. 25 lakhs he did so through five different cheques.

## India's Vaccine Diplomacy and the Parsis

India's vaccine diplomacy drive which has become the toast of the town in many a world capital, has much to thank the Parsis - a tiny community which migrated from ancient Persia to India's western shores some 12 centuries ago.

Billionaire Adar Poonawala and his father Cyrus took the leap of faith in the early days of development of the Oxford University -AstraZeneca vaccine and

agreed to invest in a huge facility in the west Indian city of Pune to make a billion doses of the vaccine for the world market. In times to come that decision by the horse fancier father and son duo will surely be regarded as one of 'daring entrepreneurship.'

"The Pharmacy of the World will deliver to overcome the Covid challenge," tweeted India's Foreign Minister S. Jaishankar as the flights to foreign capitals delivering India's first lot of vaccine gifts took off earlier this month. He might as well have added with help from the Parsis.

When the vaccines from Poonawala's Serum Institute factory started shipping out, they were ferried by refrigerated trucks manufactured by another celebrated Parsi tycoon family - the house of Tatas. The airline which flew out the first lot of vaccines to Bhutan, Maldives and Bangladesh bore the logo of Air India, a state-run carrier launched by a former chairman of the Tata Group, the late JRD Tata.

Among the other airlines which have been pressed into service shipping the vaccines are the Tata-run Vistara Airways and another Pasi family, the Wadias, run GoAir. The Parsis who number fewer than 1 lakh people have a larger than life, imprint on India's social, educational, cultural, military and economic

The man who told Lt. Gen. AAK Niazi in December 1971 that he was "surrounded by land, air and sea" by Indian and Bangladesh forces and demanded that Niazi and his troops surrender or "we wipe you out", was



none other than Gen. (later Field Marshall) 'Sam' Maneckshaw, the brilliant military tactician who was India's Chief of Army Staff during the Liberation War.

He was not the only Parsi who helped the cause of freedom. Long before Manekshaw was born, Indian nationalism and the demand for India's independence was defined in the late 19th century by another towering leader from this community - Dadabhai Naoroji, hailed by many including Mahatma Gandhi as the 'Grand Old Man of India'.

Independent India's drive to build its nuclear capacity, was also led by another brilliant Parsi - nuclear scientist Homi Nusserwanji Sethna - who led the efforts which culminated in India exploding its first nuclear device in the deserts of Rajasthan in 1974, three years after being threatened by the nuclear capable US 7th fleet at the height of the Bangladesh Liberation war.

To come back to our tale of India's vaccine diplomacy, the 'Covidshield' vaccine manufactured at Adar Poonawala's factory have been sent as India's "supplies under grant assistance" to all neighbouring countries including Bangladesh, Nepal, Myanmar, Afghanistan, Sri Lanka, Mauritius and Seychelles. The sole outlier remains Pakistan which has opted for a Chinese vaccine.

While India's vaccine flights were not aimed at displacing rival gifts from China to its neighbours, the fact remains that most nations in South Asia seem to have preferred Oxford-AstraZeneca to China's Sinovac.

The shipments began within 72 hours of India starting its own inoculation drive to cover some 300 million of its most vulnerables - doctors, nurses, policemen, journalists, people over 50 years of age and those with prior diseases- by August this year.

Besides gifts, sales contracted often with help from South Bloc where India's Prime Minister and Minister for External Affairs have their offices, to nations across the globe from Brazil to Morocco to South Africa

and Saudi Arabia, have made Poonawala a worldwide household name.

Brazil which had earlier started out with a Chinese made vaccine changed course and in late January opted for Indian made AstraZeneca vaccines. The South American giant nation's President Jair Bolsonaro is believed to have sought his friend Indian PM Narendra Modi's assistance in getting the coveted drug. Post shipment flights, Bolsonaro tweeted 'Dhanyavad' (thanks) with a picture of legendary monkey warrior Hanuman carrying medicines to Brasilia!

Ambassadors of some 100 countries were flown down to Pune, for an on-site visit in early December, to help those nations make up their minds on placing orders and Poonawala's factory will over the coming months indeed be a pharmacy for the world.

The Oxford-Astra Zeneca vaccine is made from a weakened version of a common cold virus extracted from chimpanzees, modified to look more like coronavirus and is one of two candidate drugs allowed by the Indian drug regulators to be used for emergency vaccinations.

At an average of \$3 a dose, the billion doses to be made by Serum Institute, represents just \$3 billion in revenues, small change for the global medicine industry which has revenues running into hundreds of billions of dollars. However, the diplomatic gains for India from the success of Poonawala's entrepreneurial gamble could perhaps only be described as 'immeasurable'.




