The last Parsiana issue of 21st February 2021 has very telling figures of Parsi Marriages compared to Intermarrieds for the year 2020 just gone by for our city of Mumbai. We reproduce the full article herein below that in 2020 for the first time ever, there were more INTERMARRIED than the count of pure Parsi marriages. This is today's reality and one has to address it at the earliest.

The only way out seems to be to give all kinds of Incentives to Parsi marriages and disincentives to Intermarried Parsis. We are sure that

since Berjis Desai has agreed with us that he will tackle this problem on Priority basis the community has to seriously give him a chance to come up with an out of the Box thinking being a brilliant lawyer that Berjis is. We are quite convinced that given a free hand and full cooperation of his colleague Trustees he will deliver the goods and help our community to survive with our head held high.

We reproduce below the Parsiana article as we are sure that the ultra orthodox, the TZML OR THE PIPZ or whatever they call themselves would shun Parsiana like the plague and we are republishing this article for them to see the writing on the wall. So here goes:

Bombay: The Telling Figures for 2020

More Parsis marry out, than in

In 2020, for the first time ever, the percentage of interfaith marriages in Bombay exceeded the count of Parsi marriages. There were 42 Parsi to Parsi marriages (49%) as versus 43 Parsi to non-Parsi marriages (51%). In 2019 the interfaith marriage percent was 45%. 2020 is an exceptional year due to the pandemic and the restrictions enforced on social gatherings. Plus some Parsis view a leap year as an inauspicious time to get married.

Those marrying non-Parsis probably being of a more unconventional nature may not be so bound by this superstition. But in the preceding leap year, 2016, of the 166 marriages, 103 were Parsi and 63 interfaith.

The interfaith marriage percentages have been steadily increasing since 1987 when Parsiana first started listing marriage data obtained from the Bombay High Court (for Parsi marriages) and the Registrar of Marriages (for interfaith data). The interfaith marriage percentage for 1988, 32 years ago was 14%. On an average the increase works out to 1.59% a year.

Twenty-four males and 19 females opted for non-Parsi spouses in 2020 which means more men (56%) married non-Parsis as compared to females (44%). The number of Parsi marriages in 2020 declined to 42 from 123 in 2019 and interfaith marriages from 99 in 2019 to 43 in 2020.

The average age of brides increased from 32 years in 2019 to 33 in 2020. For grooms, the average age increased from 34 to 36 years. The youngest bride was 23 years, and the eldest, 53. The youngest groom was 26 years and the eldest, 58 years.

January saw the highest number of community marriages, 19, and interfaith marriages, eight, with February showing the next highest count of 14 community and eight interfaith marriages. There was not a

single Parsi or interfaith marriage registered in the months of April, July and August.

The number of deaths increased to 841 in 2020 from 775 in 2019, with 721 (86%) deceased consigned to the dakhmas and 120 (14%) cremated. Covid corpses per se have to be cremated or buried as per law.

The average age at death reduced from 83 in 2019 to 80 in 2020, the youngest to die being a four-year-old girl, and the eldest, two 103-year-old females. The community lost six centenarians and 133 nonagenarians who constituted 17 percent of the deceased in 2020.

For the data on births, Parsiana is primarily dependent on the Breach Candy Hospital and a few families who intimate us along with documentary proof. Parsi birth figures compiled by the Bombay Municipal Corporation are reportedly given to The Chief Registrar of Births and Deaths and the Director General of Health Services,

Maharashtra. Parsiana has been unable to access the data from either.

As per the limited information available with Parsiana, there were 74 births in 2020 as compared to 86 in the previous year, a decline of 12. There were 42 boys and 32 girls born in 2020 as compared to 37 boys and 49 girls in 2019.

The data on those consigned at Doongerwadi

is provided by the Bombay Parsi Punchayet and for those cremated by the Worli Prayer Hall Trust.





TRUSTEES STOP CAMPAIGNING **FOR ELECTION 2021.**

Last week the Trustees had given permission to all candidates to canvass and hold election meetings in all its Colonies and Baugs in conjunction with each colony's Welfare Association. In fact some meetings had already been held especially Anahita Desai, the foremost candidate in this election due to the huge sympathy factor evoked in her favour due to the stroke and subsequent resignation of her husband Yazdi Desai from both his Chairmanship and Trusteeship of BPP.

However looking at the current Covid situation, the Trustees have now decided to forthwith stop all canvassing and holding Election meetings in any of its Colonies till situation stabilises and decided to inform all the candidates by an email requesting them not to carry out any campaigning and election meetings and activities till further notice.

Trustees Mr. Viraf Mehta and Mr. Xerxes Dastur suggested postponing the Election for sometime with a suggestion that at a later date the elections could be held with the same nomination already received and announced in the Parsi Press of 21st February 2021.

Mr. Dastur stated that as it is the voter's attendance is low and in the present situation it will be still less. Mr. Dastur further argued that he is for postponing the elections for atleast two months. God forbid if someone is infected who would be responsible.

However Mr. Randeria was against any postponement probably because he had been side lined and made ineffective to get anything done the way he wanted and hence in his usual cunning way informed the others not to hurry in this matter and wait till further notification is received from the Government authorities.

Mr. Dadrawala as usual parroted Randeria and suggested to restrict ourselves at present and advised that the matter could be reviewed again next week after fresh Government directions are received.

Mr. Dastur was specific that in these pandemic times specific permissions from the authorities would be necessary for conducting the Elections in this current situation and desired to move the authorities to seek such guidelines to hold elections. But once again Randeria poured cold water to this sensible advice and informed that if required we will go through it and obtain the same.

If NO election meetings or campaigning are now to be allowed, THEN THE OTHER CANDIDATES ARE BOUND TO SUFFER DUE TO THE LATE START OF THEIR CAMPAIGNING.

Respected Sir,

Please refer to your aforementioned letter. Your request to keep the Sir Cusrow Wadia Pavilion (including Badminton Court) free for the usage of the BPP elections to be held on 14th March 2021 has been noted.

As you may know, due to sudden increase in COVID-19 cases, the Government of Maharashtra has issued fresh guidelines which prohibits Political, Religious & Social gatherings. Any violation of the Government rules will lead to legal action against organizers and concerned management of the premises.

Past experience has shown that at any given time there are nearly 200 to 300 people around voting stations. In addition to these, there are a large number of volunteers, candidate representatives and staff conducting the elections.

In the current situation, it is to inform you that the Managing Committee of the CBUSWL does not have permission from the relevant authorities to conduct an event on such a large scale at the Cusrow Baug Pavilion premises.

However, since the Parsi Panchayat are the organizers of the event, we presume that all the necessary permissions will be acquired by you from the concerned Government Authorities to conduct the BPP Trustees Election at the said Cusrow Baug Pavilion. The Managing Committee of the CBUSWL will not be liable in any manner in case of any issues in this regard, which please confirm.

Further, we would like to draw your attention to the rapidly rising cases of COVID19 in the Colaba area, some of which has been covered in the recent news as well. Given the scale of the event, we feel compelled to express our serious concerns for the safety of over 2000 residents of our colony, many of whom are senior citizens.

We request you to please inform us about the safety precautions that will be put into place to safeguard the well-being of our tenants and to also reassure them in these difficult and stressful times.

Jimmy Pochkhanawala



Jimmy Pochkhanawalla was educated at St. Xavier's High School and St. Xavier's College Bombay where he completed his B. A. (Hons). He

earned his LL,B. degree from Government Law College Mumbai and was called to the Bar in 1973, enrolled with the Bar Council of Maharashtra as it then was. Mr. Pochkhanawalla deviled under Mr. Burjor H. Antia, Solicitor and Advocate at the law firm of Mulla & Mulla And Craigie Blunt and Caroe. He candidly claims that "Mr. Antia is my true Guru".

graduating in the 2007. Immediately upon graduation, Firoz fulfilled his lifelong dream of following his uncle, Senior Advocate Mr. Edul . P. Bharucha's footsteps, whose chamber he joined in the year 2007, as his junior.

Firoz appears in matters on both; the Original and Appellate side of the Bombay High Court and has a solid arbitration practise, apart from appearing even in some criminal matters. His tenacious personality has led to him appearing in several matters involving the Parsi community and he also successfully argued matters for sitting BPP Trustee Mr. Xerxes Dastur, when Xerxes was constrained to approach the Bombay High Court more than once, in the lead up to his election.

Firoz has also represented the then minority trustees in the matter between Bombay Parsi Punchayet and Aderbad Cooperative Housing Society Ltd. The minority trustees had filed an intervention Application to secure the interest of the Punchayet. In that matter, he successfully protected the interest of the BPP by getting the court to not accept the Consent Terms sought to be filed by the then majority Trustees with Aderbad Society and dispose of the matter. Based on arguments advanced by him, the court referred the Consent Terms to the office of the Charity Commissioner, so as to ensure that the BPP's interest is not jeopardized in any manner.

Dear Sir,

We Indians had just begun to come out of the long lockdown and were getting back to resume our normal lives including the announcement of elections to four large states and one Union territory when the Virus started to flex its muscles.

The National Press was readying its pages for their "Dance Of Democracy" with interviews profiles, past performances, and results. I wonder if given the present national scenario it would be more appropriate to rename such pages as "Rape of Democracy"! Such a title would be more appropriate!.

Closer home in our community too, the BPP announced elections for two seats vacated by trustees on the board resulting in a situation that reminds me of the famous quote from Shakespeare's Hamlet: "To be or not to be", which was the dilemma faced by Prince Hamlet!

Today our lady Chairperson of the BPP faces a similar situation: To hold or not to hold elections for the two vacancies for trustees? Hold and be damned or not hold and still be damned! Should we say it is a true test of her tenacity and determination?

Let us discuss the pros and cons.

The question may not have arisen in the first place had the two Desai's been acceptable to the community without them having to face the electorate. But given the history of elections for BPP trusteeship, even a kindhearted noble and helpful gentleman, perhaps the last of "Sethias" in the truest sense, Mr.Jamshedji Guzder had to face an election. The result was foregone that he would win hands down.

The undersigned feels that going by their track record both the Desais have in their kitty something worthwhile to contribute to the welfare of the community. Berjis Desai would bring with him his legal and corporate expertise while Anahita her social and grassroots knowledge. On the face of it, both these are relevant and important for the community.

But alas that was not to be! As one who had in hindsight rightly or wrongly advocated Adult Franchise I do agree with those who feel in a democracy it is only fair that elections are held. But as discussed in a petition signed by this writer too, are we prepared to hold these under the present circumstances?

The question is now complicated further with the disqualification of a qualified lady who has been disqualified for not having a qualified proposer. Apologies for the multiple intended uses of the word 'Qualified'!

Readers will perhaps be aware of the exchange of several WhatsApp messages on this issue. Surprisingly, a candidate who had earlier been proposed by the same proposer in 2015 did not result in a disqualification, but this time the lady candidate was not so lucky as I understand this very candidate who was proposed earlier in 2015 is the one who has objected now!

I have just been informed that the disqualified lady has now approached the High Court for relief and reinstatement of her candidacy. This will allow the warring parties to represent their respective viewpoints. Her Originating summons is proposed to be heard on Monday 1st March 2021 in the Court of His Honor Justice Menon at Serial No. 32 and by lunchtime the community will know whether she has been allowed to contest subject to the outcome of her Originating Summons.

Till then the community has to wait and watch!

Statistics of funeral ceremonies conducted at prayer hall, worli, Since its inception on 7th september 2015 upto 20th February 2021.

At our request we have received details of obsequies performed at prayer hall from 07-09-2015 till 20-02-2021 which coincidentally numbered exactly 500 in all over the 65 months the prayer hall has been in operation, which means an average of less than 8 bodies per month and hence it is less than 10% who prefer cremation while still 90% of our community prefer to be consigned at Doongerwadi under dokhmenashini, which is a heartening finding from the statistics provided to us.

Abiding by the confidentiality clause of the family members of those consigned at the prayer hall, we had total 33 bodies cremated in 2015 after inauguration of the prayer hall and commencement on 7th september 2015, then 97 bodies were cremated in 2016, 77 in 2017, 73 in 2018, 90 in 2019, 116 in 2020 and just 14 in 2021 upto 20th february 2021.

It is worth mentioning that of the 116 bodies cremated in 2020-21 as many as 48 bodies were covid infected and were compulsorily cremated as per BMC guidelines, much to the chagrin of their family members who wanted them to be consigned at Doongerwadi. Whilst the high priests had conveyed to the community sometime in june-july 2020 that they would obtain expert views and proof that covid cannot be transmitted through dead bodies so that our covid infected dead could also be consigned at Doongerwadi under Dokhmenashini, unfortunately the high priests seem to be so busy in their professional activities that the promised literature and expert proof that covid cannot be transmitted through dead bodies has not been sent to the BPP trustees who are therefore unable to move the statutory authorities and/or the high courts to

allow covid infected dead the benefit of Dokhmenashini.

At least the family of the covid infected dead can take solace that as many as 34 dead had their four days prayers performed at the prayer hall and even out of the 14 who only had their paidust performed at the prayer hall managed to have the four days prayers performed at their respective agiaries. Further it was heartening to find from the statistics provided that out of 48 covid infected dead only 3 were less than 60 years of age whilst all the other 45 were over 60 with most being in the range of 75 to 95 years with one at 101.

We give below the attached yearwise details of funerals at prayer hall from inception till 20-2-2021 and for the year 2020-21 we have inserted covid infected dead in red as under

The same pattern used in different colors and sizes with one pattern dominant. Men do this all the time. Imagine a charcoal pinstripe suit







with a burgandy pencil stripe shirt and a red stripe tie in charcoal, burgundy and black. The larger stripe on the tie is dominant.

Different patterns in similar size in same or related color scheme with one pattern dominant. Imagine a herringbone jacket with a paisley skirt.

Different patterns in different sizes in the same color scheme with one overall pattern dominant. Imagine a Glen plaid suit with a checks shirt and a polka dot tie all in the same black and white color.







You can use these guidelines in several different ways but the general guidelines remain. Always remember one pattern has to be dominant and stand out.

I personally started with simple achromatic colors like black and white and then advanced to more complex color schemes.




