

## MAY 23RD ELECTIONS POSTPONED DUE TO COVID/LOCKDOWN

By its Order of 12th March 2021, the Division Bench of the High Court had fixed 23rd May 2021 by mutual consent the date to hold elections for the two Trustees vacancy in the Board of BPP, for which all the five Trustees were directed to move the Chamber Judge on 17th March 2021.

However the infighting among the two warring groups of Trustees continued whilst preparing the petition to be filed before the Judge in Chamber. One group led by Kersi Randeria and Noshir Dadrawala wanted no reason to be given for postponement in the Application to be presented to the Chamber Judge whilst reporting the postponement of the 14th March elections whilst the majority group of Armaity Tirandaz, Viraf Mehta and Xerxes Dastur wanted to include that the sudden surge in spread of Covid infection was the reason for the postponement.

### EXTRACT OF THE MINUTES OF THE MEETING OF THE TRUSTEES OF THE PARSI PUNCHAYET BOMBAY HELD ON TUESDAY, APRIL 06, 2021

RESOLVED THAT the Trustees have unanimously decided to postpone the election which is to be held on May 23, 2021. This is as a result of the escalated COVID19 situation in the city of Mumbai and the SOPs issued by the Government of Maharashtra Notification No. DMU/202/CR92/DisM-1 dated April 4, 2021 wherein it has been stated that as of 8PM on April 5, 2021 (i) all private offices and religious places of worship are to remain closed. (ii) no religious, social, cultural or political functions of any kind are allowed; (iii) only district elections can be held with the permission of the District Collector and (iv) there will be a restricted movement of no more than 5 people in any public place between 7AM and 8PM; and (v) from 8PM to 7AM on weekdays and from 8PM on a Friday to 7AM on Monday, there is a complete lockdown wherein no one is permitted to move in public places without valid reasons or permissions. The above restrictions are in place till April 30, 2021. As a result of the above notification, the offices of the BPP shall be closed till further directions from the State Government. As per the current proposed election schedule, candidates are to file theirnominations on or before April 12, 2021 and withdraw nominations by April 26, 2021, however, in view of the notification, the same is no longer possible. Further, the rise in COVID in BPP colonies has been exponential with currently close to 40 cases in Rustom Baug, Byculla, with many more infected in other colonies. Accordingly, the Trustee RESOLVE THAT to postpone the elections by two or more months

FURTHER RESOLVED THAT MR. Dandiwalla, Advocate appearing for the Bombay Parsi Panchayat who has filed the Originating Summons before Hon'ble Justice Mr. Gupte of the Hon'ble Bombay High Court be requested to seek and file an amendment of the Originating Summons seeking to postpone the elections proposed to be held on May 23, 2021, by two or more months as per Article 16 of the Election Scheme, governing the Trust.

### BPP ELECTIONS POSTPONED DUE TO COVID-19

On Tuesday, April 6 2021, the BPP Trustees convened a Board meeting chaired by Mrs. Armaity Tirandaz and attended by Trustee Xerxes Dastur and Trustee Viraf Mehta

Trustee Noshir Dadrawala and Trustee Kersi Randeria did not attend.

At this meeting, given the escalated COVID19 cases in Mumbai and the SOPs issued by the Government of Maharashtra on April 4 2021, the Trustees present unanimously resolved to propose to postpone the elections which were proposed to be held on May 23,

The Resolution and above facts were placed before the Hon'ble Justice Gupte on Wednesday, April 7 2021 and Hon'ble Justice Gupte passed an Order postponing the May 23, 2021 elections.

As per the directions of the Hon'ble Justice Gupte, attached are copies of the Resolution passed on April 6, 2021 by the Trustees of the BPP and the Order of the Bombay High Court dated April 7, 2021 so that the community is aware of the steps taken by the Trustees to ensure the spread of COVID is curbed.

The BPP has been directed to propose a new program of elections, including a fresh time line, before the Hon'ble Bombay High Court on the next date on April 30, 2021.

The Trustees once again urge all community members over the age of 45 to please get vaccinated and stay safe.

Ultimately a compromise was done and the Misc.Petition (L) No. 8074 of 2021 for holding elections on 23rd May was filed only on 24th March 2021 by Advocate Dandiwala of Mulla and Mulla.

The petition came up for hearing on 6th April 2021 before HH Judge S.C. Gupte when one day's time was sought by BPP Counsel as the meeting of the Board of Trustees was fixed for that very evening.

At the Board meeting on 6th April 2021, the Trustees took note of the increase in the cases of Covid, the dramatic resurgence of the pandemic and the state lockdown announced including closure of all private offices and unanimously decided to postpone the elections. The two dissenting Trustees did not think it necessary to attend the said meeting and then not-surprisingly took offense that the postponement decision was not unanimous as they were not in its favor. Having decided not to attend the meeting then how can the two dissenting Trustees, Kersi Randeria and Noshir Dadrawala claim that the decision was not unanimous. Their logic is beyond comprehension.

On 7th April, the matter was taken up for hearing by the High Court when an Intervention Application (L) No. 9631 of 2021 filed by Phiroze Amroliwalla, Kersi Sethna and Zeree Jehangirji was also taken up. Junior Counsel Jamshed Master argued the matter well on behalf of the Intervenors.

Ultimately the 23rd May elections were postponed by the High Court but a fresh date of elections was kept in abeyance and they were asked to report back on 30th April in view of the restrictions imposed by the State due to the current Covid pandemic.

### <u>P.C. :</u>

Learned Counsel for the Petitioners informs the court that a meeting of the trustees of Petitioner No.1 trust took place yesterday; this meeting was attended by three trustees who passed a resolution proposing postponement of the elections of the board of trustees by a period of 2 to 3 months having regard to the current restrictions due to Covid-19 pandemic.

- 2 Learned Counsel for the Applicants in Interim Application (Lodging) No.9631/2021 has no objection if the elections are postponed, since, in any event, that is one of the prayers of the Applicants themselves.
- 3 Though the Division Bench, which passed the order fixing the present schedule of elections, by consent of parties, has required the timeline laid down by it to be strictly followed, considering the subsequent events which have brought about a significant change in the circumstances including restrictions imposed by the State due to the current Covid-19 pandemic, applicable till 30 April 2021, the proposal of the trustees seems to be in order.
- 4 Accordingly, the misc petition is stood over to 30 April 2021. The petition to come up on the next date along with the interim application taken out therein. The Petitioners are permitted to propose a new programme of elections, including a fresh timeline, and place the same before the court on the next date so that appropriate orders towards fixing the rescheduled election programme can be passed.
- 5 These new developments, that is to say, the resolution passed by the trustees of Petitioner No.1 trust yesterday and the order passed by this court today, should be communicated by a public notice by the Petitioners herein to all members of the community so as to keep them abreast of these developments.

## **LATEST GOVT GUIDELINES**

## **Government of Maharashtra**

**DMU 2020/ CR 92/ DM 1** 

Frequently asked Questions concerning Orders issued by the State Government for imposing of restrictions to prevent the transmission of COVID I!! 9th April, 2021

1	Can supermarkets or malls like D-Mart, Big Bazar, Reliance remains open?	Any establishment selling essential items as per the Government orders dated 4th and 5th April, 2021 can remain open between 7 AM to 8 PM subject to strict adherence to COVID 19 appropriate behavior. If it is selling multiple items some of which do not fall under essential items, that section may remain close.
2	During weekend lockdown which activities will remain open, and which will remain closed?	All activities categorized under Essential Services can remain open. No person can move without a valid reason, which includes reasons specified in the order as well - as reason for requirement of performing an essential service.
3	Can APMC market be kept open during weekend lockdown?	Yes. subject to strict adherence to COVID 19 appropriate behavior. If the local authorities feel that indiscipline in any APMC can lead to further transmission of the virus, then they may close the same after seeking permission from the State Government. It is expected that local authorities will keep an strict vigil over these.
4	Can shops providing construction materials remain open?	No.
5	Can garages servicing transport services remain open? Can shops of automotive spare parts etc remain open?	Garages being incidental to requirement of transportation may remain open. Shops shall remain closed. Local authorities are keep strict vigil on these and if any garage is found defaulting the COVID appropriate behavior, it may be closed till the operation of COVID 19 disaster notification remains in force.
6	Can employees of Central Government, PSU etc. be treated as an essential service provider?	No All employees of Central Government and PSU's cannot be treated as essential service providers. However, Central Government/ PSU employees belonging to sectors categorized as essential services fall under ambit of essential service providers.
7	Can citizen buy liquor?	Yes. In accordance with the Government order dated 4th April, 2021, citizens can buy liquor from bars (on take away basis) or as home delivery from the bars as per the time window provided in the said order for restaurants and bars. This is subject to rules of the Excise Department.
8	Can Liquor shops remain open/ do home delivery	No
9	Can roadside dhaba remain open?	Yes. But the rules applicable to restaurents will apply - No seating- only take away/ delivery allowed.
10	Can electrical home appliance (e.g. AC, Cooler, Fridge etc.) repairing shops remain open?	No
11	Can telecommunication devices (e.g. Desktops/Laptops, mobile etc.) remain open?	No
	Can Aaple Sarkar Seva Kendra; SETU CSC Centers; SETU Kendra, Passport Seva Kendra etc. which provide one window system for various government services be treated under essential services?	Yes. They can remain open on weekdays between 7 AM to 8 PM.
13	Can restaurants supply home parcels post 8 PM and before 7 AM and on weekend?	Restaurants and bars are functioning as per the timings given by local authority, with the constrain that there is no seating dining allowed.  Parcels are allowed to be picked up from restaurants by customers themselves during weekdays from 7 AM to 8 PM. No parcels can be picked up by the customer beyond these times and on weekends. However home deliveries through e-commerce are allowed beyond these times and on weekends subject to regular timings as decided by local authorities.

# JUNIOR PARSI COUNSELS SHOW THEIR METTLE Our Future is in safe hands!

Month of March 2021 was a record-breaking month for BPP with five Petitions being filed in the Bombay High Court in a span of just five days, all concerning the then now cancelled 14th March 2021 elections for vacancy of two Trustees elections.

Two of these Miscellaneous Petitions were by a candidate Dr. Zuleika Homavazir against the whole Board of Trustees challenging the Trustees action removing her as a candidate on technical grounds, whilst two Misc. Petitions were inter-se the Trustees due to the proposed postponement of the March 21 elections by the majority of Trustees citing Covid surge which was unimaginably opposed by the two Minority Trustees-Kersi Randeria and Noshir Dadrawala and the fifth filed by two candidates, mainly Anahita Desai opposing the postponement as long as she got elected no matter the risk to the voters. More noteworthy was that all the five Writ Petitions were disposed off in five days based only on their Lodging numbers.

## **Background**

A little history is necessary to be given at this stage. The community is aware that after the October 2015 elections, the then four Majority Trustees (led by the defacto Chairman Kersi Randeria, along with the de jure Chairman, Yazdi Desai, Noshir Dadrawala, and late Zarir Bhathena, (Slum Developer Partner of Randeria) treated the three Minority Trustees-present Chairman Armaity Tirandaz, Muncherji Cama and Viraf Mehta-as untouchables denying them any papers, Minutes, documents, etc so that they could not effectively function as Trustees though all three of them were duly elected Trustees by the Parsi Community at large.

Ultimately in 2016, the three Minority Trustees fed up of being denied their rights as Trustees moved the Bombay High Court seeking Justice and the HIGH Court not only rapped the knuckles of all four of the Majority Trustees but admonished them to stop behaving like Dictators in the Boardroom and forced them to sign Consent Terms that the Minority Trustees have the same rights and privileges as the Majority Trustees.

During this dispute in Court, the sad part is that Kersi Randeria employed the most expensive Senior Counsel in Mumbai to argue the matter in the High Court costing the BPP close to Rs. 40 Lakhs.

Since Kersi Randeria nor the Majority Trustees were paying from their OWN pocket but using community charity funds of the Trust to boost their egos, they were least bothered about the legal costs. The matter went on and was settled only in May/June 2017 by filing Consent Terms by which time the Majority Trustees had spent almost a Crore of rupees as legal charges for this futile and meaningless litigation. Senior Counsels

legal costs borne by the BPP alone came to around Rs. 40 Lakhs.

It is not understood why Trust funds should be used for a dispute among the Trustees which should preferably be borne by the Trustees themselves.

The three Minority Trustees, Armaity Tirandaz, Viraf Mehta and Muncherji Cama, had to personally bear their own legal costs and willingly paid the same.

## **DECISION TO DISQUALIFY ZULEIKA HOMAVAZIR & HER SUCCESSFUL CHALLENGE**

Based on an opinion of Yazdi Dandiwala, partner of Mulla and Mulla, the BPP disqualified Zuleika Homavazir as a candidate on the ground that she was proposed by Rustom Jeejeebhoy, a Parsi who had subsequently converted to Christianity. It was at most a technical error which could have been rectified but Kersi Randeria was adamant that Zuleika Homavazir be disqualified.

Zuleika moved the High Court against the disqualification. Zuleika filed an Interim Application (L) No. 6147 of 2021 in O.S. Suit (L) No. 5425 of 2021 which came up for hearing before His Honor Judge Mr. A. K. Menon who by his Order dated 8th March 2021 refused to grant any ad-interim relief and rejected her Application. Zuleika filed an appeal being Appeal (L) No. 6826 of 2021 before the Division Bench of Justice Mr. S. J. Kathawalla and Justice Mr. Vinay Joshi JJ who by their Order dated 12th March 2021 allowed the appeal of Zuleika Homavazir by ordering that since the name of her proposer Rustom Jeejeebhoy continued to be shown as a Voter on the electoral roll of the BPP, her nomination was valid and she could contest the 14th March 2021 elections.

Both matters were argued 'probono' on behalf of the Trustees of BPP by ex-Partner of J. Sagar Associates, SENIOR Counsel Somashekhar Sunderesan.

Thus except for Advocate Dandiwala's fees of Mulla and Mulla this litigation will cost the BPP nothing.

### UNTHINKABLE **CHALLENGE** TO THE DECISION TO POSTPONE THE **ELECTIONS**

Though the elections were fixed for 14th March 2021, due to resurgence of the Covid Pandemic, the Trustees by majority on 9th March 2021 rightly decided to postpone the elections by two months (though discussions for its postponement was going on since February 2021). The postponement came after the BPP first stopped all campaigning in all BPP Baugs by its Resolution of 23rd January 2021 and thereafter received a letter dated 17th February 2021 signed by over 40 signatories from all colonies all over Mumbai seeking postponement.

### Petition by Kersi Randeria to stay postponement of elections

Unfortunately, Kersi Randeria and Noshir Dadrawala instead of abiding by the decision of the majority Trustees, to sooth their bruised egos, filed Miscellaneous Petition (L) No. 7007 of 2021 calling upon the Court not to allow postponement of the elections.

### Petition by Anahita Desai to stay postponement of elections

Instead of looking after the well-being of the community over her own pride to be Trustee, Anahita Desai also filed a separate Misc. Petition (L) No. 7039 of 2021 not to allow postponement of elections, along with a dummy candidate put up by Kersi Randeria.

### Petitions of Kersi Randeria& Anahita Desai dismissed by the Bombay High Court

The said Petition (L) No. 7007/21 and 7039/21 was dismissed by the Hon'ble Justice Mr. A. K. Menon on 11th March 2021.

### APPOINTMENT OF PARSI COUNSEL

It is important to note that since BPP Trust was not paying Kersi Randeria's litigation fees, Kersi Randeria could not appoint high

flying Senior Counsels to argue the matter. Nevertheless, he appointed Karl Tamboly to argue the matter and Anahita Desai appointed Sarosh Bharucha, both of whom are well respected at the Bar.

At the same time the Majority Trustees led by Armaity Tirandaz could have followed the precedent set by Kersi Randeria and appointed a Senior Counsel charging Rs. 8 lakhs a day as his fees with an equally high flying Advocate on record and used charity funds to contest this litigation.

**But the Majority Trustees of Armaity** Tirandaz, Viraf Mehta and Xerxes **Dastur appointed J. Sagar Associates** who worked on the matter pro bono. They in turn appointed Counsel Firoz Bharucha to argue the matter who did a commendable job to get the Court's verdict in favor of the majority Trustees.

Similarlyin the Petition of Anahita Desai, (which was also dismissed by the High Court), the Majority Trustees appointed J. Sagar Associates who again offered their services free to the Majority Trustees. They in turn appointed Junior Counsel Cyrus Ardeshir to argue the matter, who also succeeded in getting orders in favor of the Majority Trustees.

Being frustrated at the rejection of their Petition, Kersi Randeria and Noshir Dadrawala went in Appeal before the Division Bench of Hon'ble Justice S.J. Kathawalla and Hon'ble Justice Vinay Joshi who by their Order dated 12th March cancelled the 14th March elections and by consent of the Trustees fixed a fresh date of election as 23rd May 2021.


All in all, all the Parsi counsels who argued for and against the Trust have indeed shown that the future of Parsi lawyers is in great hands. Firoz Bharucha has time and again come to the aid of the community and his calmness with which he handled the matter at hand is commendable.

It is in fact now been brought to light that despite being in majority, Majority Trustees of Armaity Tirandaz, Viraf Mehta and Xerxes Dastur have decided that charity funds should not be mis-used in disputes inter-se Trustees and hence they will pay the three Junior Counsel's fees from their own pocket and not mis-use community funds.

## POLICE WANT TO RETURN THE CASH RS.20 LAKHS FOUND IN LATE CEO'S CABIN BUT KHOJESTE MISTRY AND KERSI RANDERIA WON'T TAKE IT BACK

As the community is aware, Kersi Randeria and Arzan Ghadially by making false and fabricated charges that the Rs. 20 lakhs found in the late CEO's cabin was the same misappropriated transfer fees out of Rs. 65 lakhs and though released by the police after investigation in May 2015 ensured that the same was confiscated by the police and taken under its charge in 2017-18 in Khojeste Mistry's FIR.

However on 27th January 2021, MRA Marg police informed Khojeste Mistry, who claims to be a HOLY MAN by calling himself A Parsi Preacher, to come to the Police Station to complete formalities and collect the cash Rs. 20 lakhs found in late CEO's CABIN lying with the MRA Marg police but deposited in his FIR filed by him.

Under normal circumstances one would have expected the Trustees to be proactive on a urgent conference call to depute some senior staff the same day to go to MRA Marg police station to collect the badly needed cash Rs. 20 lakhs belonging to BPP just rotting away in the police safe without any return.

But once again the criminal mind of Kersi Randeria went into overdrive and he realized that his accusation that this Rs. 20 lakhs found in the CEO's cupboard was the same misappropriated transfer fees would no longer hold good and hence Kersi Randeria advised his colleagues as well as Khojeste Mistry that since matter was subjudice to take no urgent steps to collect the Rs. 20 lakhs cash but to await further discussion at next Board meeting to be held on Tuesday 2nd February 2021 and decide further course of action...

In the Parsi Junction issue of 7th February 2021, we had reported that according to police the Rs. 20 lakhs Cash deposited in the 38th Magistrate's Court has been deposited in MRA Marg Police Station Locker in Khojeste Mistry's Complaint No. MECR 02/2014 u/s 406, 420 and 34 IPC as seized property amounting to Rs. 20,01,000/=. Hence the amount can only be returned to Khojeste Mistry and no one else though the money does not belong to **Khojeste Mistry but to BPP Trust.** 

We further reported that only Khojeste Mistry has to file an Application in the 38th Magistrate Court at Ballad Pier for Return of Seized Property in his pending Complaint No. SW/3800027/2014 (MERC Complaint No. 02/2014) and the money will be returned to Khojeste Mistry who will then have to forward the Cash of Rs. 20.01.000/ back to the BPP Trust.

**HOWEVER ALTHOUGH ALMOST THREE** MONTHS HAVE PASSED SINCE THE POLICE INFORMED KHOJESTE MISTRY TO COME TO MRA MARG POLICE STATION TO COMPLETE FORMALITIES TO COLLECT THE CASH RS 20 LAKHS NOT ONE STEP HAS BEEN TAKEN EITHER BY KHOJESTE MISTRY OR BY KERSI RANDERIA TO RECOVER THE CASH RS. 20 LAKHS FROM THE POLICE IN SPITE **OF THEIR REQUEST.** 

**BOTH OF THEM REALIZE THAT IF THEY COLLECTTHECASHOFRS20LAKHSTHEN** THE CHARGES OF MISAPPROPRIATION **LEVELLED BY THEM AGAINST DINSHAW** MEHTA WOULD NO LONGER SURVIVE.

The witch hunt of Yazdi Desai, (due to loss of his wife Anahita Desai to Dinshaw and Kersi Randeria supported Muncherji Cama), Khojeste Mistry (Wapiz Kersi Randeria and Arzan Trustee). **Ghadially to somehow discredit Dinshaw** Mehta in the eyes of the community so that the community stops electing candidates put up/supported by Dinshaw Mehta was so strong that they were willing to sacrifice Rs. 20 lakhs of community charity funds to get their revenge on Dinshaw Mehta.

I am Dr. Zuleika Homavazir, aged 39 years presently residing at B-8, Jerbai Baug, Byculla, Mumbai 400027. I am a renowned Professor and Head of Department at Wilson College and have been part of the educational fraternity for over 12 years and social work of over 10 years.

It has come to my attention that

defamatory. false and wilfully misleading statements without merit, about me and my family members have been published on page 5 and page 8 of the illegal newspaper publication "Poll Khol Sacchu Bol" dated 30th March 2021 by the Editor, Printer, Publisher -Mr. Kaikhushroo Irani, Mobile number +91 98201 59916; email: pksbol2020@ amail.com.

The false statements that have been made are reckless and highly defamatory and has caused me to suffer:

- 1. Substantial harm in face of the World Zoroastrian Community
- 2. Economic harm



# Parsi Heritage

## The Bomanjee Hormarjee Wadia Clock Tower

The Bomanjee Hormarjee Wadia Clock Tower was erected in 1882 at Bazaar Gate Street (Perin Nariman Street), Fort, Mumbai.

Seth Ardeshir Hormusjee Wadia, brother of Late Bomanjee, obtained the large clock from England for the Tower and also presented the bust of Late Seth Bomanjee installed at the centre of the fountain.

On three sides of the fountain, are engraved few lines from the ancient Behistun rock inscriptions (Iran) in Old Persian Cuneiform script, which when translated read:

- 1. "Ahura Mazda, the wise Lord, who created this earth, who created the sky, who created dwellings of human beings."
- 2. "The reach (nejo) of Parsis (Persians) is spread far and wide, will that now remain unknown!"
- 3. "O man! Ahura Mazda has decreed do not forget the path of righteousness, do not spoil that path, do not close that path."

This monumental fountain and Clock Tower, popularly known as "Bomanjeeba-no Fuvaro", was recently renovated and restored to its original glory thanks to the efforts of the Kala Ghoda Association.

## **How to dress for your body shape- Part 3**

In my last article, we discussed an inverted triangle body shape and how we could counter your inverted triangle silhouette to make it look ideally balanced and attractive. Today, we shall discuss about the triangle body shape.

People with triangle body shape tend to have narrow shoulders, wider hips &/or thighs, slimmer arms compared to their legs, average to small bust/chest and smaller waist. They typically have rounded buttocks and appear bottom heavy.

### **Clothing styles for females:**

In triangle body shape in women, one must try to visually minimize the lower torso and lay emphasis on the upper torso.

Fill out the shoulders with fullness and design details. We have to try to balance out the lower body with the upper body and accentuate the waist.

- Boat neck, round or heart shaped tops and off shoulder tops would be an ideal
- Blouses or shirts with decoration on shoulders like puffed sleeves or frills on sleeves would add the volume required.
- Blazers and jackets with shoulder pads would work great. Double breasted jackets and blazers are advised.
- T-shirts with lighter colors and bolder brighter prints would be ideal.
- Avoid tops or blazers to fall at the widest part of your hip. Let them fall either above

or lower to draw eyes away from that area.

- Wrap dresses or tops that accentuate the waist can draw attention towards your slim waist.
- Go for tops and T-shirts with horizontal stripes to add width on the top.
- Avoid tight fitting trousers or pants with frills, pockets, decoration s or

details. Let your pants be basic and plain as far as possible.

- Straight cut or fitted trousers that flare at the bottom are ideal.
- Avoid bottoms that taper down.
- High-rise pants or jeans will accentuate your slim waist.
- Choose darker colors at the bottom and avoid large prints or horizontal patterns. Vertical striped pants work best.
- Go for smaller prints and patterns and make sure your bottoms have muted, darker colors as compared to the top.
- An empire waist dress or a fit and flare dress is a good choice.
- Wear a slim belt below the bust.


