FACTS OF THE 750

Dear Community Members,

Over the last few months, under the Chairmanship of Mrs. Tirandaz, the BPP has been functioning efficiently and smoothly.

However, with the intent to derail the smooth functioning of the BPP, in the last month's issue of Parsi Times Trustee Kersi Randeria attempted to create a storm out of a ripple (as he always does) by making baseless allegations against the Board in respect to the recovery of Rs. 750 service charges from the Occupants of BPP Baugs. Subsequently in the Parsi Junction issue of May 30, I clarified the same.

You will recollect the burden of service charges of Rs. 750 – which was the brain child of Kersi Randeria, was revoked by the current Trustees (Kersi Randeria opposing this).

- Of the approximately 4400 flats under the control of the BPP, 1600 are in the Wadia Baugs and 2600 are in BPP colonies.
- Of these 2600 flats, as per information given by administration, about 2530 had been made to pay the 750 service charge increase.
- Of the balance 70 residents, 45 have made partial payment towards the 750 rupees increase.
- Only 25 residents have not paid this increase since 2017
- Of these 25 residents, 8 residents are from Palmlands, 9 from Gamadia Colony (to whom no services of security was given until recently), the remaining 8 are spread across Khareghat Colony, Bharucha Baug, Khan Estate, Godrej Baug and Dhunbai Wadi.

Considering the non-payment by 25 residents, my colleague Mr. Randeria made illogical yet sweeping statements against the Board and demanded we refund this incremental Rs. 750 to all residents. His statements come as a shock considering

it is Kersi Randeria himself who fought with us (when we were in minority) and insisted we burden the residents with service charges.

Mr. Randeria enforced this increase on the residents of BPP Baugs by instilling the fear of eviction on residents. Not only that he instilled such a fear in most residents through the Colony Managers and Custodians but instructed them not to accept rent and other lawful dues unless the same was accompanied by this extra Rs. 750/pm.

The unfortunate part is that all this stems from Mr. Randeria's angst against Mr. Phiroze Amroliwalla, a community activists who has exposed various nefarious activities of Mr. Randeria in an SRA development. In the recent issues of the Parsi Junction Mr. Amroliwalla has been exposing Mr. Randeria's duplicity when it comes to handling matters of the BPP for his own family, not to mention the allegations of financial impropriety against innocent slum dwellers.

Mr. Randeria's suggestion was so mindless that initially I thought it not fit to respond to. However, considering his attempt to malign every positive deed of this Board, I felt it my duty to bring this to light. Mr. Randeria is pushing the case that since 25 residents have not paid the extra Rs. 750/ pm, the BPP should refund around Rs. 8 crores to all the 2530 residents who were enforced by Kersi Randeria himself to pay up. This senseless logic is obviously nothing but an attempt by him to correct his wrong before the community.

Many may not be aware of the vindictiveness of Mr. Randeria, however, the community should know that he has been pushing the Board to file a case, against Mr. Amroliwalla, to recover Rs. 31,500 (Rs. 750 per month for 42 months from 1-2-2017 to 31-8-2020). He is willing to spend Lakhs of community



funds just to teach Mr. Amroliwala a lesson.

I will repeat that the increased service charge has NOT been waived for anyone. The same will be recovered from all 25 of these residents.

While Mr. Randeria would like us to file cases against those who have not paid, one has to question if the logic of spending more in legal fees just to recover Rs. 31,500 rupees from an individual is worth the time, the effort, the nuisance value and the legal fees of the advocates. That being said, efforts will continue to have these individuals clear their outstanding dues soon..

As is now commonly known in our community, Mr. Randeria has been using the BPP to settle his personal scores with many individuals and unfortunately was even able to do so in the past with the support of his majority. I am glad to say that in the last one year, that has been put to a halt under the Chairmanship of Mrs. Armaity Tirandaz.

Hence now, more often than not, we see Mr. Randeria use his Parsi Times to influence members of the community with his untruthful twisted/fabricated version of the facts.

Mr. Randeria is well aware of the financial crunch at the BPP,

primarily due to his decision of stopping auctioning of flats and cutting off the BPP life-line. Mr. Randeria along with his majority stopped this for almost five years, unless of course a case was brought to him by one of his aides or personal friends. Now, with the BPP struggling, Mr. Randeria claims the Board should refund almost 8 crores just because twenty five individuals, totaling Rs. 6 lakhs, haven't paid the increased service charges. These acts of pettiness is what is dragging the BPP down and we need to move beyond it.

While Mr. Randeria tries to mask his vengeful acts but claiming a need for financial aid to community members, I would once again bring to the attention of all that we have had under 20 requests for financial aid and all of these requests have been aided by the BPP. The BPP Covid helpline continues to be available to anyone in need of help.

It is quite unfortunate that my colleague continues to work against the Board instead of standing beside us raise funds for the BPP and allow it to prosper. I can only hope and pray this changes.

Kersi Randeria continues To Hate..

Within my property at 6A, Jamshedji Petit Street, Off Balaram Street is a landlocked plot admeasuring about 600 sqft which is in my exclusive possession, enjoyment and use since decades (including earlier Owners) but belonging to the Trustees of N. M. Petit Charitable Institution and bearing CS NO. 20B/152 OF Tardeo Division.

The Petit Trustees were not even aware of its existence or its location as the only access to it was through my property and the said Petit Trust Property was not even reflected in Schedule I Register of the Charity Commissioner.

After my term as Chairman of Bombay Parsi Panchayet ended in October 2015, I did not want to continue as a Trustee as I had decided to develop my various properties all over. Because of the Supreme Court conditions of 18 ft side open space for a fire brigade entry I could not develop this property alone and had to go with adjoining properties for development.

I approached the Petit Trustees to purchase this landlocked plot who were surprised that they owned a very small landlocked plot abutting my plot. On inquiry they informed me that this plot is not even registered on Schedule 1 Records of the Charity Commissioner.

The said plot being landlocked and its only means of access was through my plot and since it was in my possession, use and enjoyment since decades (including earlier owners) the 600 sqft property was not even worth Rs. 10 lakhs but the Petit Trustees playing on my Parsi Charity emotions got me to offer them Rs. 20 lakhs for it with further condition that I helped the Trust to bring this property on Schedule I of CC Register. After a few days late Advocate Katy Mehta, partner of Mulla AND Mulla came over and requested me to increase my offer as a few lakhs would make no difference to me but would help her charity and ultimately emotionally forced me to agree to pay the Trust Rs. 30 lakhs in interest of charity for such a small landlocked plot.

On 28th August 2017, the Petit Trustees ultimately filed a Change Report to bring this property on its Record. After several hearings at all of which I attended on behalf of myself and the Trust, we got the approval Order dated 7th May 2019 and Plot No. 20B/152 of Tardeo Division was brought on record of Schedule I of CC Register.

Thereafter the Trustees started the process of issuing Public Notice calling for offers for purchase of this plot, which was done on 20th November 2020 and auction was conducted on 24th December 2020 and the co-developer was the highest bidder at Rs. 31 lakhs.

Ultimately Application for CC's sanction u/s 36(1)(a) was filed on 27th April 2021. At the last hearing held on 25th June 2021, Kersi Randeria turned up in the CC's office and handed over

an unsigned Intervention Application, a copy of which was also given, which I am publishing in toto so that the community can become aware of how low Kersi Randeria can sink in his hatred and his frustration that he has lost his majority to lord over all in the BPP Boardroom.

I humbly submit that I am a necessary party and I should be impleaded and served a copy of the Application made by the Applicant Trust u/s.36 (1)(a) of the Maharashtra Public Trusts Act, 1950 ("the Act").
- 2) I say that the said Application is a conspiracy hatched by a builder, V. M Homes, a neighboring property owner Mr Dinshaw Mehta, his partner Mr Berjis Desai, his family members and the trustees of the Trust including the Chairman, to cheat this Hon'ble Authority, defraud charity and profit from the community property.
- 3) I say that I have filed a caveat, which is available with this Hon'ble authority and duly served upon the Trust.
- 4) I say that I need a short date to collect the relevant documentary proof including documents which will clearly establish that the Trustees have played a fraud on this authority at various levels, the valuation reports

are bogus and deliberately under valued and that the so called auction was a sham and a fraud perpetuated by the parties on this Hon'ble authority with the view to defraud charity and profit from the same.

- 5) I crave leave to produce and rely upon the relevant documents and file a detailed intervention application.
- 6) It is humbly recorded that given the lockdown restrictions, the pandemic and the SOP in place for judicial hearings this Hon'ble authority be pleased to accept and allow this application, provide the copy of the application and its annexures and allow time to file a detailed intervention application along with all documentary proof and submissions.

In view of the above circumstances and the above mentioned facts, the present intervention application be allowed and the intervener be provided with a copy of the Application and it is humbly prayed that no orders be passed until the intervener has been heard in the present application.

PARSIANA PROTECTS ITS LANDLORD PLIH MANAGING COMMITTEE



Many community members may not be aware but Parsiana has a huge office of around 1500 to 2000 sq.ft on the ground floor of Parsi Lying in Hospital premises (PLIH). Parsiana are alleged to be encroachers in the Hospital premises and the appeal filed by the Managing Committee (MC) in the High Court has been pending since last over 25 years with hardly any side taking steps to have it heard and decided expeditiously.

Naturally Parsiana in gratitude would hardly be expected to play a neutral role in reporting the misdeeds of the present Managing Committee of PLIH when it Leased for sixty years its full property for a pittance in a private deal without inviting Offers from the Public with Khubchandani of Krimson Health Ventures Ltd., who is the partner of Yazdi Bhagwager in many ventures.

Not just that but Parsiana remained non-committal when the MC members applied to the Charity Commissioner (CC) by falsely pretending to be the Owners of the Property, who actually are the Trustees of the BPP, and got CC's post facto sanction to the Lease in a

private deal without giving Public Notice due to the influence of the Parsi Community's biggest Fixer, the South Bombay Chartered Accountant, who is in the news at present for similar deals as reported by Nauzer Bharucha in the Times of India.

Whilst most of the MC members are innocent bystanders in the PLIH drama including the conscientious Noshir Dadrawalla as well as Dinshaw Tamboly and probably several others, the two most influential and vociferous MC members **Yazdi Bhagwager and Kersi Randeria** are still keen to encash the monetary value of the PLIH property, at which they failed in 2015 as the matter was taken to Supreme Court, instead of keeping/using it for community welfare.

Thus when the present BPP Trustees requested the MC to give a part of its usable area from the total area of around 25000 sq.ft., for setting up Quarantine centre for Parsis affected by the Covid Pandemic, **Kersi Randeria very cleverly ensured that the whole PLIH structure was taken up for survey by a structural engineer and was present all the time**

advising and telling the engineer what and how to prepare the report and the required repairs. It was therefore as expected that the Structural Engineer gave a report of repairs exceeding Rs. 5 crores for carrying out repairs to the whole 25000 sq.ft. structure, though not required.

It is our submission that out of 25000 sqft only about 10000 sqft requires maximum repairs and that about 15000 sqft can be used with minimum repairs and **at least 10000 sqft can be immediately used without any repairs and without any risk to life or limb to any occupant/user.**

But then the criminal mind of Kersi Randeria anticipating this, ensured that the whole structure is denounced as unsafe so that his plan to lease/sell the property and earn funds from it is achieved.

Not being satisfied with cheating Rs. 30 lakhs from Vikram Jagdale and over Rs. 10 crores from the transit rent of the slum dwellers, Randeria is desperate for new funds and this is prime property from which to make some fast money.

Remember in 2010 Yazdi Desai and Kersi Randeria took lakhs of rupees from the then Chairman to get a favorable Order from the High Court and by Consent of both of them got favorable Orders both for sale of Panthaky Baug Ownership flats as well as in the 104 allotment cases after distributing the lakhs between the two of them.

As mentioned earlier, Parsiana uses about 1500 to 2000 sqft for its office, another 1500 sqft is given to JJ College of Commerce whose driving Force, Mrs. Homai Mehta is no longer alive. Another about 700 to 1000 sqft is used as office by the MC.

Hence around 10,000 sqft is available even today in a safe and sound condition for use as a quarantine centre for Parsis without any risk to life or limb to the users. But very



cleverly Kersi Randeria by his machevillain tactics has ensured that even the available 10000 sqft is denied for community use and the innocent Noshir Dadrawala too has fallen for this Randeria's sly tactics.

If the whole structure is in a dilapidated condition, as stated by Noshir then it is about time the MC sent Notices to Parsiana and JJ College to vacate the premises for their safety which they will obviously not do as they are in no danger.

Coming now to the main issue of Parsiana protecting its landlord, the MC of PLIH.

In the 21st May 2021 issue of Parsiana, Jehangir Patel published for the twentieth time the same charge of one Piroja Jokhi that the MC were right in giving the property to Khubchandani of Krimson Health infra without Public Notice for developing a super speciality Hospital and which Dinshaw Mehta had wrongly stopped by moving the Supreme Court of India.

In reply to the false and baseless charges of Piroja Jokhi, Dinshaw Mehta sent his clarification to Parsiana after first confirming with Jehangir Patel that he would publish the same in the 21st June issue of Parsiana.

But to the shock and surprise of Dinshaw Mehta that his clarification though published in the 21st June 2021 was so badly amputated and edited that it came out in praise of Piroja Jokhi that what she stated was correct.

To ensure that the community is well informed of how the PLIH was sold for a song to his Partner Khubchandani without the knowledge and permission of the actual Owners of PLIH, who are the Trustees of BPP, **we are republishing Dinshaw Mehta's clarification in toto so that the truth of the swindle attempted of community asset of PLIH by Kersi Randeria is brought before the community.**

Those portions of Dinshaw Mehta's letter which has been edited by Jehangir Patel and not deliberately published in Parsiana is shown in red and the rest published in Parsiana is in black.

LETTER OF DINSHAW MEHTA FOR PUBLICATION IN PARSIANA:

DINSHAW MEHTA REPLIES TO PIROJA JOKHI ON PLIH

In the Parsiana issue of 21st May 2021, you have once again for the umpteenth time published a similar letter from the same senior citizen Piroja Homi Jokhi regarding the same Parsi Lying in Hospital episode.

Once again Mrs. Jokhi gives her same monologue that Managing Committee with best interest of PLIH in mind, was planning its revival through Krimson of Khubchandani who wanted to set up a world class healthcare centre for orthopedics and neuro surgery and then she once again wrongly blames me for approaching the Supreme Court to get the deal cancelled.

I once again repeat that I was not against the revival of PLIH per se if it was for community welfare but against the method employed by the Managing Committee for it.

As per the law laid down by the Supreme Court for Charitable Trusts, no Trust can sell or lease its property through secret private deals but only after issuing Public Notice in newspapers and calling for bids from interested parties and sell or long term lease to highest bidder on similar terms after CC approval.

In this case the Managing Committee led by Yazdi Bhagwager, issued no Public Notice nor called for offers from the general public but entered into a Private deal with Khubchandani who is a partner of Yazdi Bhagwager in various property deals and both have offices in the same building.

Thus the law laid down by Supreme Court was not followed in this case.

Further as Mrs. Jokhi rightly points out, the Hospital is owned by the BPP Trustees, whilst the Managing Committee (MC) looks after or is supposed to look after only the administration of PLIH. **But the**

MC made application before Charity Commissioner (CC) pretending to be the Owners and post facto obtained CC approval by this dishonest means to its Lease to Khubchandani and then approached the Trustees of BPP also for its post facto approval.

If this is not criminal Malfeasance of the MC to pretend to be Owners and get orders from CC on this false basis, then I do not know what is. Besides with the PLIH being in a state of disuse and decay since last 40 to 50 years, one wonders what exactly the MC were administering for decades.

In any case thank God that Khubchandi was not given the Hospital project to construct and run as since last few years, he has suffered huge monetary losses and all his projects are in half abandoned condition.

Mrs. Jokhi than makes a suggestion to use PLIH as a Home for Senior Citizens. Whilst her objective is indeed laudable, such a home is not required at present by our community due to our steep decrease in population. At present we have Parukh Dharmashala at Khareghat Colony and Pallonji Home in Parsi General Hospital Compound, which are utilized at less than 50% of its intake capacity.

Previously we had over 100 occupants at Parukh Dharamshala but with passage of time at present there are less than 50 occupants in both the Male and Female wings of Parukh Dharmashala.

There is also vacancy in Pallonji Home. Further we have Senior Citizen Home very well run by Dinshaw Tamboly at Navsari and another such home at Surat equally well run by Yazdi Kasad. Hence there is no need for further Homes for Senior Parsi Citizens.

I had proposed that the recently repaired portions of PLIH could be directly used as a Quarantine Centre for Covid affected families. Certain portion has been repaired by Maneck Engineer recently due to



prosecution by BMC but other portion which also require repairs has not been touched.

Out of 25,000 sq. ft. PLIH structure, about 15,000 sq.ft. is in a good condition whilst about 10,000 sq.ft. require major structural repairs. **Parsiana itself has been using around 1500 to 2000 sq.ft. in the Hospital premises for its office, since decades without any risk to life or limb to its several office staff and about 1000 sq.ft. is used by J, J. College of Commerce of late Mrs. Mehta for her student training since last more than 15 years and hence a portion of PLIH which is in a good condition can be safely used for Quarantine purposes.**

However Kersi Randeria insisted for a Structural Engineer to survey the whole structure and repair the whole structure even if a part could be safely used. Both of them are keen to dispose off the PLIH property by sale or lease to make money and not use it for community welfare.

Thus when the Structural Engineer gave a Report of Repairs Cost of over Rs. 6 crores for the whole property disregarding that a part of it could be immediately safely used at minimum cost, **the whole project of Quarantine use very cunningly went for a toss.**

In fact they then suggested that we approach the Trustees of Petit Sanatorium at Kemps Corner **where again Yazdi Bhagwager is the main adviser to the Petit Trustees and as expected Petit Trust** also rightly did not want to give its Sanatorium for Covid purposes, citing major repair requirement of the dilapidated structure

Hence the two big Institutions of the community are lying vacant but unused and deteriorating **due to non use instead of being used for community welfare especially in these pandemic times.**

If the Managing Committee sincerely wants, then the portion which was repaired recently after BMC prosecuted the Architect of PLIH with minimum repairs cost, can be brought to community welfare use in these desperate times.

But then will Yazdi Bhagwager and Karsi Randeria allow it for community use instead of their aim/dream to encash by Sale/Lease the value of the property.

It is now for the Trustees to decide either way.

From the above it can be seen that more than 50% of the clarification of Dinshaw Mehta given to Parsiana for publication has been deleted making it a lame duck reply. And what is more if one reads the deleted portions in red then one realizes that the most important information of the misdeeds of the MC were deliberately withheld so that community is not made aware of its diabolical attempt of trying to lease the PLIH to Khubchandani only.

If Dinshaw Mehta had known of Parsiana's concern of its office premises then we are sure he would not have wasted his time to correctly inform the community of the tragedy of PLIH not coming to community use as long as Yazdi Desai and Kersi Randeria control the Managing Committee, whose actual role came to an end in 1923 when the whole property lock, stock and barrel including all its assets was transferred to the BPP.

But that is another story for another day.

No wonder Parsiana has protected its landlord, PLIH MC and never let the community know the full truth of the PLIH episode even when it was sought to be wrongly and falsely alienated instead of using it for community welfare.

Jim Sarbh honoured to pay tribute to India's brightest scientists as he plays Homi Bhabha in Rocket Boys; Ishwak Singh steps into Vikram Sarabhai's shoes.

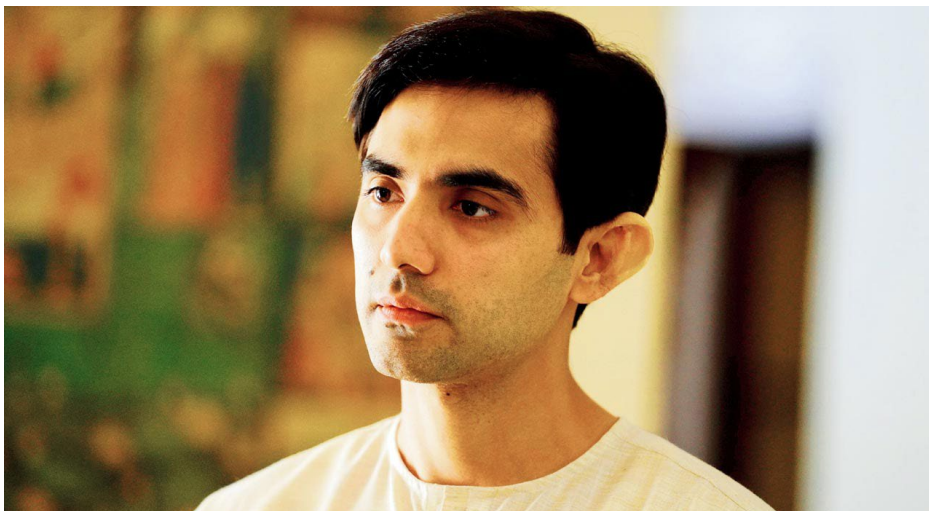


First look of Jim Sarbh as Homi Bhabha in the web series

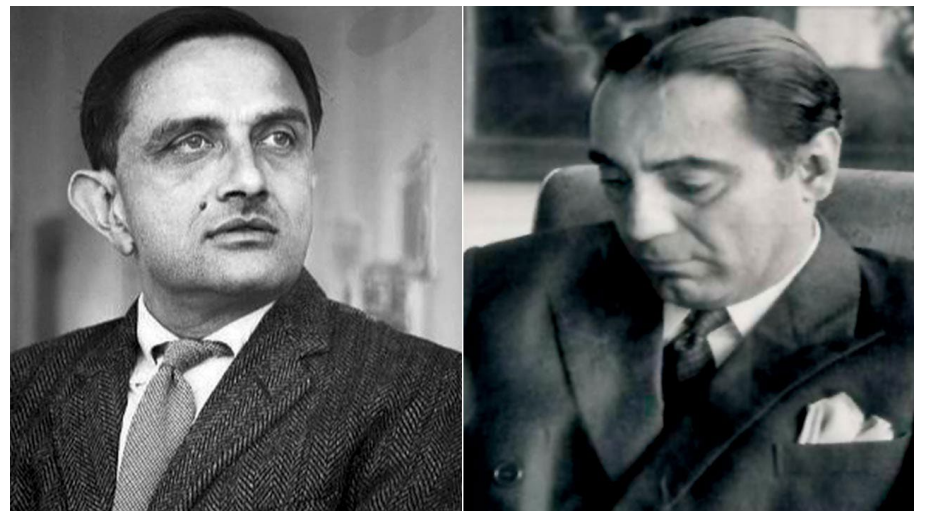
Bollywood has had more than its share of biopics on athletes, war heroes and freedom fighters, but little screen time has been devoted to the scientists that the country has produced. With 'Rocket Boys', director Abhay Pannu intends to show that scientific discoveries make for stimulating stories as he offers a dramatised retelling of the lives of Homi Bhabha and Vikram Sarabhai, thus celebrating their contributions to the fields of atomic and space research. Finding actors who can do justice to the geniuses could not have been easy, but the director has found his leads in Jim Sarbh, and Ishwak Singh of Paatal Lok fame.

As he shares his first look as Bhabha in the SonyLIV series, Sarbh says that stepping into the celebrated nuclear physicist's shoes was an honour. "Taking on the role of Homi Bhabha is special, partly because of our shared Parsi heritage. But more importantly, it is [a privilege] because he was an interesting, driven, Renaissance man. His dedication to scientific process and discovery, his notes on arts and culture, and his ability to have a good laugh make him a delicious character to play," says the actor, who began shooting for the Nikkhil Advani and Siddharth Roy Kapur-backed series in late 2019.

A story about India's brightest minds is incomplete without Sarabhai, considered the Father of the Indian space programme. The show will study his early years of research. Singh remembers saying an enthusiastic 'yes' to the project right after the narration. "The concept of [remembering] India's science heroes grabbed my attention. As a youngster, I was fascinated by stories of space and what lies beyond. By playing Vikram Sarabhai, who established the Indian Space Research Organisation, I will help other enthusiasts know more about his accomplishments." The series, shot across Mumbai, Pune and Rajasthan, marks his second project with Advani after Unpaused.

When Soli uncle passed away, Darayus wanted the accommodation but his uncle hadn't bequeathed it to him. Darayus was living alone and wasn't keeping well. I have memories of him and his mom, Banu aunty, coming down from Bombay to spend their holidays with us. This sudden silence is unnerving and every day I dial his numbers. Questions arise in my mind, "What's happened to Darayus?" Through your page I have hopes of hearing from him. Please help me.

I had been directed to Mr Yazdi Tantra by someone who I interviewed for the project. Let me also take a moment to introduce myself. I am working in the History Department of the SNTD College and am working on a project for the K.R. Cama Oriental Institute on Parsi Physical Culture Clubs in Bombay. I am looking at **Parsi body builders**, strong men, athletes and wrestlers as well as some of the institutions that they had founded in the early twentieth century.

I am particularly interested in the career of 1) **Tehmsap Sarkari** (who also founded a physical culture home which was certainly functional upto 1949) 2) **Bomansha Coverji Gazdar** (b. 1876) who founded the Guzder Health Home. [References to both these men are found in Darukhanawala Parsis and Sports]. The only thing I have been able to trace is a picture of Gazdar from Darukhanawala (Parsi Lustre Vol 1). 3) **Dinshah Mistry** who ran the Mistry Physical Culture Institute in Bandra. I have had some success on Mr. Sarkari but none at all on Gazdar and Mistry. However I haven't been able to track the exact location of Gazdar's Health Home or even find any information about these remarkable men despite my scouring of archival material both in Gujarati and in English. I'm also interested in the history of the Marker's Health Home and have spoken to some old timers and got some information. I have also had some success with the Petit Gymnastic Institute on which there is much material in the State Archives and newspapers. So broadly I am looking at recovering the histories of Parsi physical culturists and institutions, which have not been documented in detail in the existing community histories. The Registration Fee for each participant was Rs. 500/- for the whole programme, which included a free HPY Tshirt too.

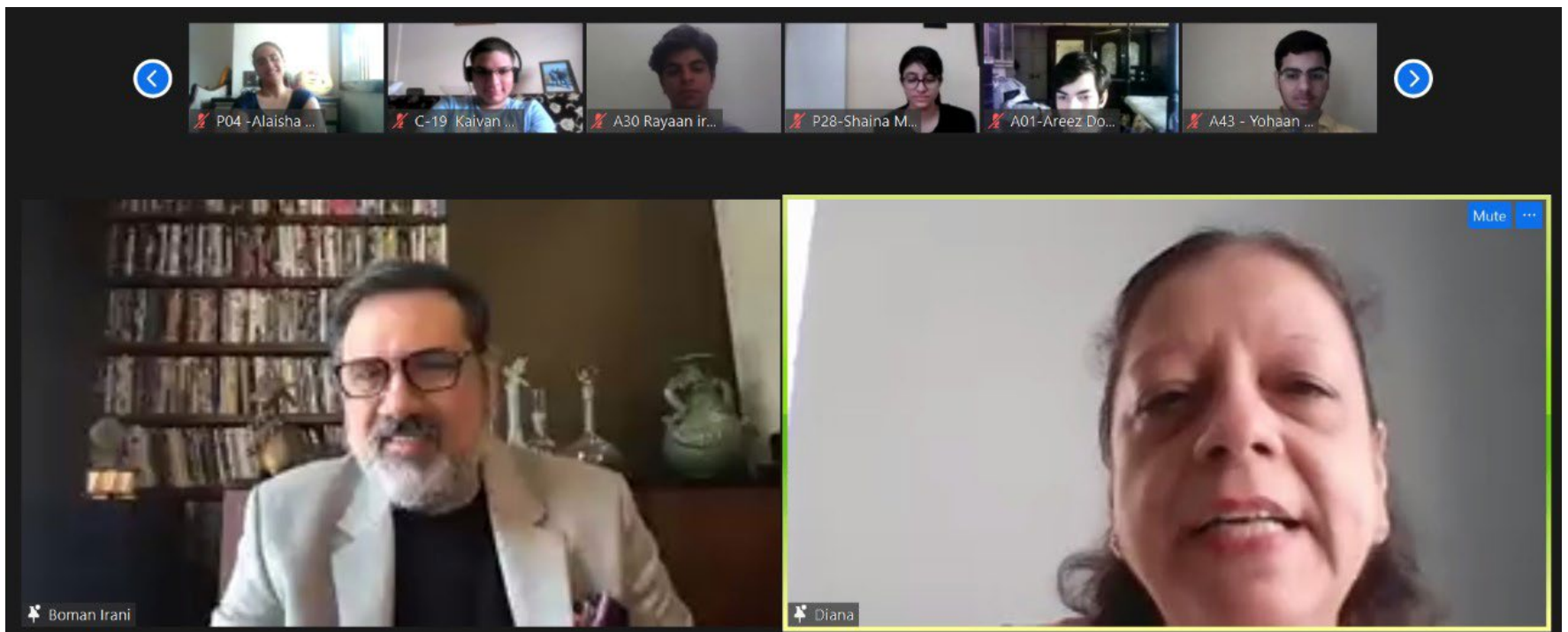
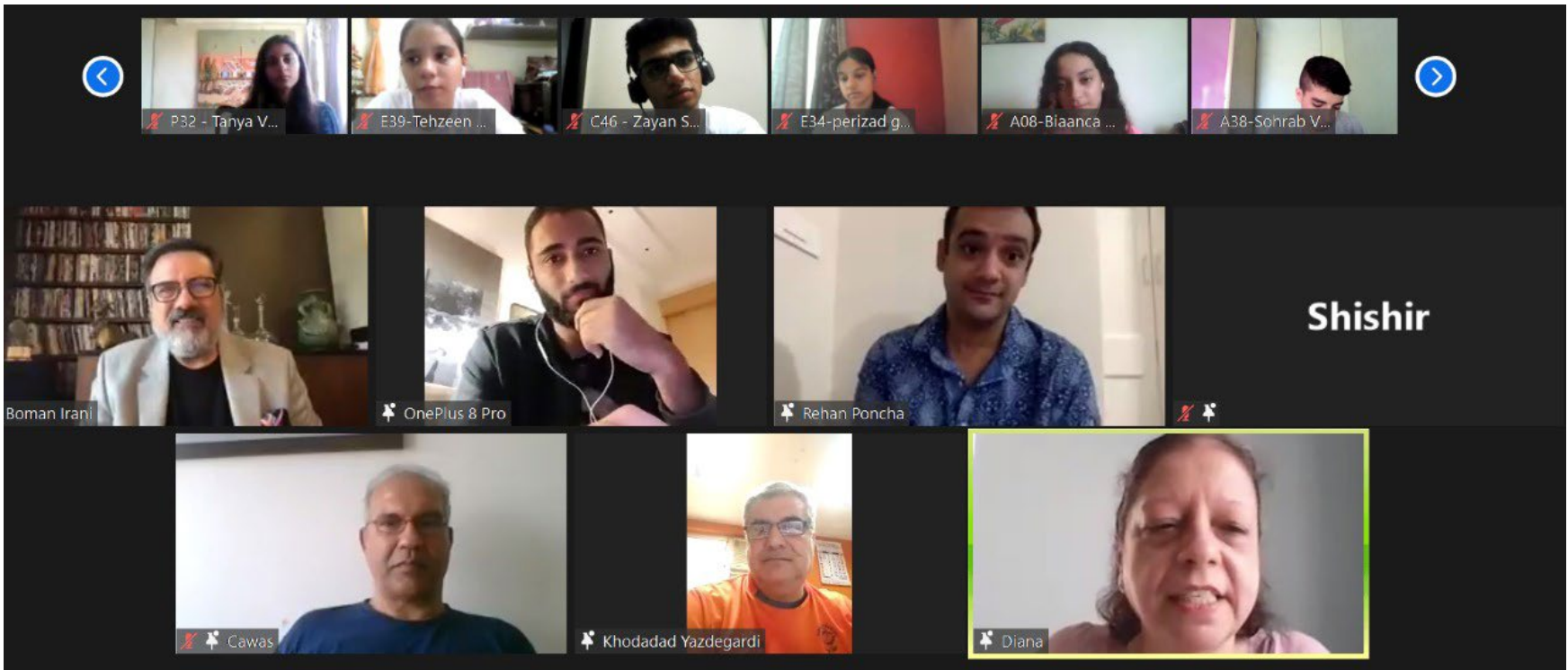
