Today, he has gone to a place where he can enjoy his waltz, love for dogs and his food without any worry. Munchi today is in a happy place. However, for us all, he will be missed deeply.

## FACTS OF THE 750 DISSECTED

Last Sunday 27th June 2021, Trustee Viraf Mehta had in Parsi Junction under the bi-line "FACTS OF THE 750" GIVEN A VERY SUCCINCT AND JUSTIFIED EXPLANATION AS TO WHY THE EXTRA SERVICE CHARGES OF RS. 750/ PM LEVIED BY THE BPP DICTATOR KERSI RANDERIA SINCE FEBRUARY 2017 AND PAID BY 2530 RESIDENTS UPTO AUGUST 2020 CANNOT BE REFUNDED JUST BECAUSE 25 RESIDENTS (INCLUDING YOURS TRULY FOR THREE FLATS) HAVE NOT PAID IT SINCE FEB 2017.

#### **MY RESPONSE ON 750!**

The world is witnessing an unparalleled pandemic and suffering a health and financial crisis which is unimaginable, and here our community, hitherto known for helping and saving lives is today hell bent upon 'killing' each other! Vindictiveness has overridden wisdom!

The irony of the levy of the steep increase in service charges is that the main culprit Randeria, through sly and devious means, forced this levy upon the community and today, with an eye on elections, has taken a complete U turn and is instead instigating and provoking through his own PARSI TIMES paper and his cronies, to demand a refund of those very charges he extorted from the community TO THE 2530 RESIDENTS PAID "JUST BECAUSE 25 WHO **RESIDENTS DID NOT PAY THE SAME".** Wah Randeria what logic!!

I, as one who has survived this onslaught at great cost to my personal reputation and integrity as also that of my family, now

appeal that the community should rightly demand a refund; not from the BPP, but from Randeria who imposed this levy in the first place, despite his own panel majority colleagues having a different view, of the amounts extorted from the residents, by refusing to accept rents and other legal dues which was solely at the instance of Randeria. If he refuses to refund, I am prepared to lead the crowd into booting him out from the trusteeship of the BPP.

THIS MAN HAS TO QUIT SO THAT SOME PEACE PREVAILS IN OUR AUGUST INSTITUTION! He is the cause of all the turmoil which is his sole creation and contribution in the five years that he has been on the board. There are none so blind as those who will not 'see'.

Last week through the PARSI JUNCTION, Trustee Mr Viraf Mehta has laboured to put the 750 service charges issue in the correct perspective before the community and ended with a "hope and pray this changes."

I would like to remind Viraf of what we all learnt early in life: "ONE ROTTEN APPLE CAN SPOIL THE WHOLE BASKET!" In Gujarati there is a saying "KUTRA NI **PUCHDI VAKI TEH VAKI".** 

Kersi Jamshedji Randeria cannot and will not change. Viraf keep praying! It appears that except for Viraf there is none on the board who is strong enough to take on this vindictive dictator who is known to terrorise and subjugate all who dare to speak or oppose him and his grand plans of capturing and controlling our community funds and properties for his personal gain and aggrandizement of himself and his cronies to whom he throws a few crumbs as they beg for his favours.

Viraf, I disagree with you on one point: "that all this stems from Mr. Randeria's angst against Mr. Phiroze Amroliwalla." It is NOT his angst against me but it is his sworn enmity towards Dinshaw Rusi Mehta who he had vowed to "send to jail" two decades ago; long before even Musharaf arrived on the scene! Musharaf is only an excuse!

This was amply proven when Randeria met me on that Sunday afternoon in March 2017 at Cafe Coffee Day, Farmer Bros. Dadar, and called Dinshaw a "chor". Ironically while the police have exonerated Dinshaw Mehta of Randeria's charge of misappropriation of Rs. 20 lakhs out of alleged Rs. 65 lakhs transfer fees, he himself is now charged with cheating a Govt servant of Rs. 30 lakhs in 2015 for booking a flat in a Slum Development project as well as not paying Rs. 10 Crores to slum dwellers as transit rent in the same project.

Randeria then offered me that he would waive all the Extra Service Charges on my three flats and even help me Encash their tenancy values ONLY if I withdrew my protest against this unjust, unfair and steep increase in service charges since, according to him Dinshaw was using "my shoulders to fire his gun" to ward off and divert the community's focus from the Musharaf episode. These offers to silence me were thereafter repeated twice, once in the presence of the late Zarir Bhathena and Noshir Dadrawala at ITC Grand Maratha, Lalbaug on the 24/25 May 2017 at around 9 am.

I have not opposed this unjustified increase for any personal or financial reasons as can be witnessed from the fact that the moment this INCREASE was withdrawn, my family and myself along with payment of over three years full arrears of rent, original service charges, water charges, parking charges, etc also donated, by cheque, an extra Rs. 50,000 to the BPP as also for the welfare of its security system at Khan estate.

Randeria now exhorts his colleague trustees to file a case against me. I ask if he was so sure and confident about the legality for this unjust, unfair and steep increase, then why did he not file such cases against me and others similarly placed when he was "ruling" the board with his majority from Feb 2017 till April 2020?

The history of this levy stems from the circular dated January 2017 of then-Chairman Mr. Yazdi Desai who had appealed to the community to "willingly agree to the proposed increase." He had expressed the hope "that the occupants in keeping with the tradition of cordial relations, will certainly co-operate in the matter."

NOWHERE IN THIS CIRCULAR WAS THERE A MENTION OR INDICATION OR A DIRECTIVE THAT RENTS AND OTHER **STATUTORY LEVIES AND PERMISSIBLE INCREASES WILL NOT BE ACCEPTED** FROM RESIDENTS WHO DO NOT PAY THIS STEEP INCREASE IN SERVICE CHARGES FROM Rs. 150/- pm. to Rs. 900/-pm irrespective of the size of the flat or the number of rooms, the area. location and services provided? It was basically this 'one- size-fits-all' policy and duplication of charges such as property tax, water charges, security charges, which any case were already being collected separately, though these were also made grounds for the increase in service charges.

For how long does the community and his colleagues on the board want to suffer the double standards of this vindictive Randeria? Can anyone be more mean and vindictive, when this Randeria can deny one free meal to a senior Parsi whose only fault was that his case was represented by Amroliwalla with whom Randeria has a score to settle. I call upon Randeria to face me head on to settle personal scores and not to be vengeful on those who cannot defend themselves.

Randeria's double standards can also be gauged from the fact that, whereas he demands others to vacate flats occupied by their parents and relatives and wants them to look after these seniors in the family by getting them to reside with them, he transfers a large BPP charity flat in a genuine charity building standing in the name of his late Kaka to that of his mother who is a director in his Rs. 100 crore company but lives with his sister in Godrej baug despite Randeria himself living in a large flat at Dadar Parsi Colony! Randeria should practice what he preaches and surrender this charity flat in the charity Contractor building at Byculla for some needy Applicant. Noshir, I hope you are reading and digesting the criminal acts of your colleague Trustee.

One can understand the ulterior motives in this well thought out plan as he has also added the name of his nephew (his sisters son) as residing in this flat though the nephew resides in Godrej baug with the mother and sister. WHAT DOUBLE STANDARDS, THIS RANDERIA EXHIBITS!!

Randeria professes and pretends that he is against 'selling'/encashment of tenancy

rights and to this end he prints/publishes notices below every BPP auction notice of his dissent in gross violation and contempt of the consent terms by which he is bound to accept majority decisions of the board.

Yes I say he professes because he is interested in settling such deals privately so that he can work out terms favorable to him and NOT the trust. This gives him an opportunity to reduce his financial troubles in his business and professional losses. To better understand this I suggest that a committee or an auditor be appointed to scrutinize all deals of Randeria including but not limited to the number of cases before all tribunals and law courts where Randeria is mostly a defendant including the one where Randeria is the Slum developer in which Vikram Jagdale was duped of Rs.30/- lakhs flat booking amount and where Randeria owes the slum dwellers more than Rs. 10 crores by way of outstanding TRANSIT rents for the homes TO BE BUILT AND REHOUSE THE SLUM DWELLERS by Randeria for redevelopment and which are due over several years.

His favours to his friends and business partners are out in the open: One cannot forget the allotment of a house in Godrej baug to the nephew of his lady partner. This house for which there was an Offer of Rs. 60 lakhs was allotted to this nephew of his lady partner for a mere donation of Rs. 8 lakhs, though the nephew himself was willing to deposit Rs. 40 lakhs for it. WHY?

Why was Kaikhushroo Irani of Pol-Khol infamy allotted a flat in Palm lands at Contractor Baug BY RANDERIA LYING TO THE Board about the status of Petit TRUST's application before the Competent Authority and even today AFTER FIVE YEARS enjoys both a charity flat in a Petit trust as well as in BPP's Contractor Baug. And for this allotment Randeria promised the board on behalf of Irani a sum of Rs.40 lakhs which as per my information has NOT yet been paid.

In the very first year of his term, Randeria was primarily responsible for compelling Armaity and Viraf to move the High Court at their PERSONAL expense to assert their right to BPP documents/minutes etc. which were wrongly denied to them. This resulted in an avoidable wastage of BPP funds of nearly Rs. 1 crore as legal costs litigating with

ones' own colleagues. Randeria should be made to pay for this wastage.

From October 2015 till March 2018, Randeria along with Yazdi Desai and his wife Anahita Desai ensured that Mr. Muncherji Cama, sitting Trustee of BPP, was denied entry into the BPP BY FILING FALSE Change Report in June 2015 though Yazdi Desai was not the Chairman but enjoyed majority support -- of his Wapiz Trustee Khojeste Mistry, the mother of his lady partner Arnavaz Mistry and the enigmatic Jimmy Mistry before the Charity Commissioner due to his majority on the Board.

To sum up, whereas Dinshaw Mehta, with his own personal wealth, both financial and knowledge wise helped enrich the coffers of the BPP with his pragmatic policies from just Rs. 16 Crores in 1994 to over Rs. 250 crores in 2013 when the honeymoon of Dinshaw Mehta with Wapiz came to an end as he opposed the unreasonable and unjustified ambitions of the wife of a sitting Trustee to become a Trustee by supporting Mr. Muncherji Cama, Randeria in just a few years due to his vindictiveness and anti community policy of not allowing Tenants to encash the Tenancy value of their flat or stop the auction of high Value flats but gift them for free to his friends and relatives, has reduced the BPP to bankruptcy partly due to his own failures in his housing projects etc. Further Kersi Randeria has brought shame to the whole Parsi Community by fooling Jagdale to part with Rs. 30 lakhs for booking a flat in his Slum Redevelopment project by commenting that "I am a Parsi and we Parsis never cheat people" to gain his confidence and now refuses to refund the Rs. 30 lakhs with Interest till today.

The community for its own good and survival of the apex body needs to get rid of Randeria from the trusteeship! And in this I hope and pray that the Lord helps us!

# DOKHMENASHINI FOR PARSI COVID DECEASED HIGH COURT HEARING COMPLETED

As the community is aware, instead of the Bombay Parsi Punchayet, it was the Surat Parsi Punchayet who had taken the lead to file a Petition in the Gujarat High Court seeking approval for Dokhmenashini for Parsi Covid victims.

Noshir Dadrawala in his usual suave way would not let the BPP similarly move the Bombay High Court till authentic research papers were received from abroad that dead bodies cannot transmit Covid any further. He was not in favor of Dokhmenashini for Covid affected Parsis and brought up various pertinent objections against it which swayed the other Trustees as he is perceived as the most knowledgeable on such matters.

In the meantime, the Surat Petition was heard in detail by the Ahmedabad High Court and arguments were completed on Thursday 2nd July 2021. It has now been fixed for Judgment for which date will be announced later on.

It is unfortunate that the biggest Anjuman, BPP nor FEDERATION OF PARSI ZOROASTRIAN ANJUMANS OF INDIA (FPZAI), could not support Surat due to the continuous in fighting indulged in by Noshir Dadrawala and Kersi Randeria ever since they lost their majority on the Board of Trustees and Armaity was declared as Chairman, to frustrate the new majority and try and stop their functioning at all

Dear all,

What a week it has been!

Some points to note on this topic of discussion.

 According to the Zoroastrian religion where there exists a dokhma, Dokhmenashini is the religious mandate for funeral ceremonies. Neither burial nor cremation is allowed, especially on Dokhma lands.

The above rule applies irrespective of the current Covid situation or not.

No temporary burials on Dokhma lands.

Those Anjumans in Gujarat (like Pardi?) who are contemplating such a step of performing burials on Dokhma lands **are breaking both religious and legal rules**. Beware.

- Since the religion does not permit burial or cremation on Dokhma lands, it is imperative that all Vada Dasturjis must be in consonance with this cardinal tenet.
- 2. The mainstream newspapers carried headlines like "Virus in nasal, oral cavities dies 12-24 hours after death"
- 3. Regards the Surat Parsi Punchayat's appeal to allow Dokhmenashini for Parsi Covid victims, the Ahmedabad Mirror carried an article saying "Centre seeks more time from Gujarat HC to file reply May 2021"

The hearing has been postponed to June 8, 2021.

I, Dastur Keki Cawasji Ravji, aged 77 years and residing at Readymoney Bldg., No 3, 3rd floor, Sir Ratan Tata Road, Opp., Kappawala Agiary, Mumbai 400 034., do hereby state on Oath as under:

- 1. I, Dastur Keki Cawasji Ravji Meherji Rana, am the President of The Navsari Samast Jarthosti Anjuman General Fund, Dasturwad, Navsari 396 445. I say that the Anjuman inter alia, carries out several activities by providing monetary / medical aid, educational aid to the poor and needy members of Zoroastrian Community. Moreover, the Maintenance of the Properties vested with the Anjuman including the Towers of Silence is also one of the main objectives and functions of the Anjuman and in this capacity, I am authorized to file the present affidavit in support of the Petition filed by Surat Parsi Panchayat Funds & Properties, Surat and I am also competent and entitled to file this affidavit on behalf of the Anjuman.
- I come from a Priestly family from Navsari (Gujarat). My forefathers have been Priests serving the Fire Temple (AHURA MAZDA) since ages. I was appointed as the Panthaki (Head Priest) of the Cama Baug Agiary at Mumbai in 1987 and since then I continue to do so till date.
- I have been Adorned the Title of VADA DASTURJI MEHERJI RANA at Navsari since June 2019 (Highest seat of Priesthood and Head of the Zoroastrian Religious teachings over the world.)
- 4. I graduated from the DADAR ATHORNAN MADRESSA at Mumbai specialising in Zoroastrian Teaching.
- 5. As a priest I have Performed innumerable Pav Mel (Religious) Ceremonies all over. I have attained the position of the Senior most (YozDathregar) Mobed (Priesthood) in the world.
- I have studied deep in to the ZOROASTRIAN studies and am totally devoted and dedicated myself very humbly for the Religion and its studies. I have therefore been considered as Head of the Zoroastrian Religion.
- 7. It is for all the above reasons I have been requested to file the present affidavit to enlighten Your Hon'ble Lordship on the reliefs sought for in the present Petition.
- 8. It is a known fact and has been a motto that Parsees are known for their Benevolence and Charity to Others during their life time and even thereafter. Exposure of the body is very essential from a spiritual point of view, as it's through the rays of the sun that the spirit is drawn upwards. It also harnesses the powers of disinfection of the sun and the wind.
- In several States of India, the Settlors of the Trust have created places known as "DOONGERWADI" where the Body of the deceased Parsee Zoroastrian is laid to rest after his/her demise.
- 10. According to the tenets of the Zoroastrian Studies, Dokhmenishini (Disposal of the Body of the deceased Parsee Zoroastrians) is considered as the best and most sacred way for the disposal of the deceased Parsee Zoroastrians. Dokhmenashini is the process of exposing the corpse of a Parsi Zoroastrian in a ritually prepared open, circular funerary house called Dakhma, exposed to the rays of the sun (Khurshed-nagirashni). For Zoroastrians it is the best mode of disposal

- of the dead. It not only ensures the speedy and ecological disposal of the physical constituents of the body, it also enables the early release of the semi-spiritual constituents of a human being, and prompt deliverance of the spiritual constituents. This is because Dokhmas are places of great sanctity as they are consecrated with elaborate religious ceremonies.
- 11. Dokhmenashini is based on 4 principles: (i) Disposal of corpse away from human habitation, (ii) Disposal on an elevated place, (iii) The corpse exposed to the rays of the sun, and (iv) The corpse exposed to birds of prey. Dokhmenashini is not just a method of disposal of the dead body of a Zoroastrian, it is also an integral part of the Zoroastrian religion. The speedy release of the soul from the earthly bonds largely depends on it. Dokhmenashini is an economical as well as ecological method. It does not use any resource from the ecosystem and also safeguards the environment. Dokhmenashini, even in its weakened form, is still the best among all the methods of disposal of the dead available to Zoroastrians today, from the points of view of the living, the dead, as well as the environment.
- 12. Cremation, or burning the body, either through the traditional mode or electric mode, is considered incorrect in the Zoroastrian tradition for several reasons. Fire is given great reverence in the Zoroastrian religion, and so is air. Cremation (even electric cremation) is responsible for polluting fire as well as air. The Avesta talks about at least six different fires. Latent energy in all matter is considered as fire hence, electricity is also a form of fire.
- 13. Every Parsee Zoroastrian is a Beneficiary to the said mode of disposal and also as a matter of right. It is considered as the most sacred and most respectful for the deceased's soul to attend peace and purity.
- 14. To sum up, every Parsee Zoroastrian has a right to get his/her body laid to rest at the Dokhmas (Doongerwadi).
- 15. I may state that I am in total conformity with what has been stated and explained to me in the Petition filed before this Hon'ble Court by the Petitioners. My affidavit be considered as part and parcel of the Petition filed before this Hon'ble Court by the Petitioners.
- 16. I humbly pray that this Hon'ble Court be pleased to grant the reliefs as Prayed for by thePetitioners and as stated in the Petition as also the relief stated therein.

## A Story Of A Journey Of One Random Act Of Kindness

What I am about to share is a testimony of how one *Random* **Act Of Kindness** 

can change the trajectory of one's life.

And how "A Prayerful Life Has More Meaning Than A Life Full Of Prayer."

About 13-years ago, with a spark of inspiration to preserve a Zoroastrian heritage site, a 15-year old boy from India posted a few photographs of the Bahrot Caves on Ushta-Te Book - Zoroastrian Social Media Platform, asking for guidance. I messaged him back offering to introduce him to Zoroastrian Scholars in Mumbai, who at that time were working to preserve the Bahrot Caves.

He was introduced to my good friend and prominent Zoroastrian Scholar, Dr. Homi B. Dhalla - the Founding President of World Zarathushti Cultural Foundation. And the rest became history.

Homi took him under his wing - another Random Act Of Kindness, and asked him to help with a petition campaign appealing to the Archaeological Survey Of India to commence preservation work at Bahrot that Homi had initiated. This became the springboard for his pursuit to acquire more knowledge about Zoroastrianism.

As a token of gratitude for helping Homi with the petitions, Homi invited him to be part of the Zoroastrian delegation for an Interfaith Congress in Kazakhstan in 2012.

This facilitated his understanding of how joint efforts of religious-intercultural scholarship and policy makers is important in the twenty first century. His continued association with Homi, who has an experience spanning three decades in the interfaith movement and his exchange program with AFS Intercultural Program to Italy in 2010-11 provided him with an unprecedented ability to think beyond the conventional career choices. Being inspired by Homi's contribution in the interfaith movement and having realised its importance, he got involved with the International Association for Religious Freedom and subsequently travelled to UK, in 2014 to attend their Congress as a young Zoroastrian.

He believes that it was his lasting association with Homi and AFS that propelled him in this direction. Especially when during his stay in Italy, he had to give presentations on Zoroastrianism to those who had never heard about it. Since we are emphasizing on how one Random Act Of Kindness can have a lasting effect, his scholarship to Italy fructified due to a kind act by a Parsi lady in Ahmedabad who recommended him for the programme, and a visit to Bahrot - which became a trigger for his future pursuits - was a result of another Parsi lady's offer to accompany her on the journey to the caves.

During the 10th WZC in Bombay he heard about SOAS and discovered that SOAS offered an MA in Iranian Studies with a combination that suited his interests!

He received a scholarship which stemmed from a generous endowment gifted by the Fereydoun Djam Charitable Trust to SOAS- another Random Act Of Kindness - to look after his fees for Master's in 2016.

This was followed by another Random Act Of Kindness by my good friend Dinshaw Tamboly's valuable guidance to him on acquiring funds for his academic pursuits. His meeting with Dinshaw gave him hope that he will be able to pursue his dreams to study Iranian Studies at SOAS. Dinshaw's magnificent guidance opened up an avenue providing him with a series of Random Acts Of Kindness from several Zoroastrian Trusts.

Again through the kind courtesy and abled guidance of my Good Friends from United Kingdom, Rusi Dalal, Past President ZTFE, Dorab Mistry, Past President ZTFE, and Malcolm Deboo, ZTFE President; and 'others at ZTFE', that he was showered by a series of Random Acts Of Kindness that provided him the key funding for his doctoral studies and continued support since 2016 during his studies in London. ZTFE's Zartoshty Brother's Scholarship and SOAS' Kamran Djam and Shapoorji Pallonji Scholarship made it possible for him to think about realising his Ph.D. goals. He was fuelled with another series of Random Acts of Kindness in the form of scholarships from The Vakhshoori Foundation; FEZANA; The Pirojshah Godrej Foundation; Bai Maneckbai P.B. Jejeebhoy

Charity Fund's Scholarship; WZO - UK; Hong Kong Charity Funds among others.

Another Random Acts Of Kindness were bestowed on him by my good friend late Sammy Bhiwandiwalla of WZO-UK, who became another guiding source for him; and Former Presidents of FEZANA, Homi Gandhi and Dr Dolly Dastoor who helped him pave his understanding on Zoroastrian Discourse in North America. My good friends, the FEZANA President, Arzan Wadia and PARZOR Director Dr Shernaz Cama gave him the opportunity to join the Zoroastrian Return to Roots Tour in 2020, another Random Act Of Kindness.

His interest in contemporary Zoroastrian Studies developed around 2012-14 when the internet was regularly flooded with material on people accepting the Zoroastrian identity. This roused curiosity among lay Zoroastrians but also resulted in information asymmetry.

In 2015, he contacted a Norway based organisation instrumental in initiating people into the Zoroastrian faith. He was invited to attend a Summer Camp in the Netherlands, where members would meet, which was an opportune occasion to interact with the new adherents. Having graduated recently and unable to fund his trip from India, his acquaintances in Italy offered to pay him if in return he would clean dishes in a communal kitchen during an annual retreat. That was another Random Act Of Kindness.

His parents in India lend him the seed money for his travel. Thereafter, he embarked on a trip to the Netherlands to meet the new adherents and to Italy to do the dishes and help the chef in the kitchen.

All of the above and numerous other random act of kindness marked the beginning of his academic pursuit in the form of an MA program and finally a PhD project that he is currently undertaking at SOAS under the supervision of Professor Almut Hintze and Arshin Abid-Moghaddam.

In case you are wondering, who is the blessed recipient of these amazing Random Act Of Kindness - that person is Ruzbeh Hodiwala, from India.

## So how can we wear leather shoes specially while praying?

Q) Leather is Dry Naso! So how can we wear leather shoes specially while praying?

A) Animal skin which has gone under the process of tanning becomes leather. The process of tanning stops the decomposition of the animal skin. (1)

So leather is not considered Naso (નસી). Our Parsi Zarthostis Priest for centuries have used leather mattresses (ચાકરા) and leather footwear (સપાત, ચાચીયા જોડ).




