BPP moving in the right direction under Chairman Armaity Tirandaz

As per Trustee Noshir Dadrawala - "The BOARD has unanimously decided to file a petition in the Bombay High Court requesting permission to consign Parsi/Irani Covid victims to the Towers of Silence."

Editorial Comments: A few months ago, the Surat Parsi Panchayat (SPP) asked the BPP for a letter of support to consign Parsi / Irani Covid victims to the Towers of Silence, however unfortunately the BPP was not able to provide a letter in time due to the obstinate stand taken by two Trustees, mainly Kersi Randeria.

Today, we are glad to see the BPP is finally following in the footsteps of the SPP and moving the Bombay High Court in this matter. We wish them Best of Luck.

We are informed that Trustee Viraf Mehta has been asked to obtain the services of Advocate Prakash Shah who the BPP had used to get the permission for the Fravandian Parab prayers at Doongerwadi.

As per Trustee Viraf Mehta - "The BOARD has unanimously decided to write to the BMC that no pipes should run through the Doongerwadi Property!"

He informed us that Mr. Bilal Baig, BPP's Head of Projects, has sent an email to the Board clarifying a few points on last Friday's meeting.

- Mr Baig has confirmed that NO proposal of the BMC has been agreed to. On the contrary Mr. Baig asked the BMC to prepare a detailed document & present it to the Board of Trustees who would visit the site, understand the request & then **jointly** take a decision.
- Mr. Baig confirmed that he had not spoken to Trustee Kersi Randeria or any Trustee before the meeting with the BMC however he did mention that he had seen the email from Trustee Kersi Randeria 'unilaterally' instructing staff not to attend any meeting with Trustee Viraf Mehta.
- Mr. Baig rightly stated that the Board should avoid such unilateral instructions by one Trustee as it becomes very difficult for the BPP staff when they receive conflicting orders from two different trustees. This puts the staff in a dilemma. Trustee Viraf Mehta agreed.

The Board of Trustees informed Mr. Baig and his team that henceforth instructions will be given by the Board and no individual Trustee decisions (like the one made by Kersi Randeria) are to be followed. The BPP is now waiting for the BMC to revert with a layout of the existing water pipes as well as a fresh proposal.

Editorial Comments: But what about the already existing underground pipes and overhead pipes that run through the Doongerwadi and have been providing water to the Kemps Corner and Peddar Road area for over a century?



BPP TO MOVE HIGH COURT TO HOLD ELECTIONS FOR TWO TRUSTEES VACANCY

As the community is aware, earlier elections were scheduled to be held on 14th March 2021 to fill the vacancy of two Trustees—Zarir Bhathena who expired in July 2020 and Yazdi Desai, who ultimately resigned in December 2020 though he had suffered a stroke in April 2020 and unable to attend or take part in any BPP Board meetings or its multifarious activities since April 2020.

However the recurrence of the second wave of the Covid pandemic forced the Majority Trustees to move the Court for postponement for safety of its Senior Citizens till most of them had been vaccinated.

However this was not appreciated by two Trustees—Kersi Randeria and Noshir Dadrawala—who were keen to restore their majority which they had been enjoying from October 2015 till April 2020 irrespective of the cost to human lives by the Covid virus. Of course the impatiently long waiting Trustee aspirant Anahita Desai, without any qualification except being the wife of the Chairman, was also keen to wear the Badge of Honor of a Trustee of the Bombay Parsi Punchayet.

All three of them moved the High Court in March 2021 to stop the postponement, which was rightly ruled to be correct under the Circumstances of the resurgence of the Covid virus and their Petition was dismissed. Immediately the two Trustees moved the Division Bench of the High Court which ordered in March 2021 that the Elections should be held on 23rd May 2021 provided there was no restrictions due to the Covid pandemic and ordered that the Trustees move the Court of the Judge in Chamber for finalizing the date of elections.

Unfortunately the two Trustee candidates proposed by Noshir Dadrawala and Kersi Randeria were Anahita Desai and Berjis Desai. But because Berjis refused to support them in the postponement of the March 2021 elections he was hounded out by Kersi Randeria who promised that he would ensure that Berjis would never be able to enter the BPP as a Trustee. What a huge loss to the BPP and the community just because of the highly inflated ego of one Trustee.

By then the second wave of the Covid pandemic was in full swing and hence there was no way the Elections could be conducted on 23rd May 2021.

The Trustees moved the Chamber Judge of the Bombay High Court in April 2021 for fixing the date of elections but

the Hon'ble Judge postponed the Application to 30th April 2021 as the Second wave was increasing day by day and the State Govt. and the BMC had put various stringent restrictive guidelines.

Since then the matter has not been put up on the Daily Board of the High Court. Since the second wave now seems to be receding, the Trustees have unanimously decided to move the High Court to fix a fresh date of election.

It is hoped that the Chamber Judge will list the Petition and direct the Trustees to come back with a properly framed Schedule of Elections.

Since the monsoon ends only in September the elections will probably be held in second or third week of October 2021 provided the anticipated Third wave of Covid does not strike the nation, in which case this election too will go for a toss and will then have to be held in October 2022 by which time the whole community will have received the double dose of the vaccine and Covid virus will at last be eradicated.

Subject: Legal Notice on behalf of Mr. Khushman Jal Tamboli, Trustee – Secretary, Rajkot Parsi Zarthosti Anjuman Trust, Rajkot in respect of Newspaper Article dated 9th June, 2021 published in “Soneri Surat” alleging purported irregularities in the functioning of the Rajkot Parsi Jarthosti Anjuman Trust, Rajkot.

Dear Sir,

I am concerned for the interest of my client, Mr. Khushman Jal Tamboli, Trustee – Secretary, Rajkot Parsi Zarthosti Anjuman Trust, Rajkot (hereinafter referred to as “Trust”), having residence at: Paldi, Ahmedabad. At the very outset, we bring to the attention of you, the Addressee No. 1 and 2 of your wrongful and illegal acts, knowingly and intentionally committed by you, the Addressee No. 1 and 2 against the interests of my client by having spread false, malicious, baseless, damaging, unjustifiable, and defamatory information in the newspaper named “Soneri Surat” against my client in respect of the functioning of the Trust. It is stated that the following are the true and correct facts:

1. That my client is the Trustee – Secretary of Rajkot Parsi Zarthosti Anjuman Trust, Rajkot since last more than one decade.
2. It is stated that it has come to notice of my client that you, Addressee No. 1 has alleged various purported irregularities in the functioning of the Trust via newspaper article dated 9th June, 2021 at Page 5 published in the newspaper named “Soneri Surat”, wherein and whereby you, the Addressee No. 1 has made certain false and baselessly accusatory, scandalous, defamatory, disrespectful, and demeaning comments against my client to a public at large.

3. It is stated that in the Meeting of the Trust dated 9th December, 2008, it was unanimously decided to appoint one Mr. Vispi Baria as Trustee – President, Mr. Khusman Jal Tamboli as Trustee – Secretary and Mr. Kersi Khansaheb, Dr. Darayas Dastoor and Mr. Jehangir Cassad as Trustees of the Trust. It is stated that in the said Meeting, it was also decided that Mr. Vispi Baria and my client would operate the Bank Account of the Trust held with State Bank of India, Rajkot. It was further decided in the said Meeting that in the absence of Mr. Vispi Baria and my client, Mr. Kersi Khansaheb would be authorized to operate the said Bank Account.
4. In pursuant to the above Resolution and mutual understanding between the members of the Parsi Community, Rajkot, Mr. Vispi Baria and my client operated the Bank Account for and on behalf of the Trust from time to time.
5. It is stated that in or around April, 2016, Mr. Vispi Baria, Trustee – President of the Trust passed away. It is noteworthy to mention that before Mr. Vispi Baria passed away in the April, 2016, Mr. Vispi Baria had signed various post-dated cheques to be utilized for and on behalf of the Trust.
6. It is stated that subsequently, my client had duly informed the Bank to strike off the name of Mr. Vispi Baria from the records of the Bank on account of his death. It is stated that despite the above letter by my client, the Bank did not modify / alter its record and the name of Mr. Vispi Baria continued to be on the record of the Bank.
7. Considering the above, in the year 2020, a post-dated cheque was utilized bearing Cheque No. 879141 dated 18/03/2021 signed by Mr. Vispi Baria for the beneficial interests of the Trust. It is stated that the said post-dated cheque was presented and submitted to the Bank and the same was cleared by the Bank without any objection whatsoever. It is further stated that details of the said post dated cheque signed by Mr. Vispi Baria which was presented and utilized have been accounted for and audited from time to time and no irregularity whatsoever, as alleged, was found and hence, the allegations leveled against



my client are vehemently denied. It is also noteworthy to mention that on further scrutiny of the Accounts, it is clear that all the post dated cheques signed by Mr. Vispi Baria and which have been utilized by the Trust have been accounted for and audited from time to time and no irregularities **whatsoever** was found. Thus, it is stated that the purported allegation is nothing but an attempt to bring disrepute to my client in the entire Parsi and Gujarati Community.

8. It is stated that my client has not forged any signature of any individual as alleged. It is stated that such allegations by Addressee No. 1 are without any evidentiary proof much less any cogent evidence. It is stated that my client has diligently and honestly served the Trust since last many years. It is stated that such accusations by you, Addressee No. 1 which was published by Addressee No. 2 in its newspaper on 9th June, 2021 has maligned image of my client in the entire society. It is further stated that such malicious and defamatory is also uploaded on the official Facebook Page of "Soneri Surat" having following Uniform Resource Locator (URL) - <https://www.facebook.com/news1319/photos/pcb.828365931121991/828365801122004>. It is stated that such accusations has brought immense disrepute and disrespect to my client followed by severe and mental and psychological agony. It is stated that not only this, but after publication of the above article, my client has also received numerous WhatsApp messages and communications which has caused huge dent in the image of my client. It is stated that such newspaper article is casting wrong aspersion on my client. It is reiterated that my client has remained dutiful to the functioning of the Trust. It is further reiterated that all the accusation leveled by you, Addressee No. 1 is frivolous and vexatious.
9. That the aforementioned downtrodden and deeply shameful acts undertaken by you, Addressee No. 1 and 2 invite initiation of legal proceedings against both of you seeking reparation, compensation and redressal of the damages as experienced by my client. Further, my client will with utmost certainty lead to filing of a Criminal Complaint against you, Addressee No. 1 and 2 seeking criminal action and prosecution under the provisions of Section 499 and 500 of the Indian Penal Code, 1860 punishable with criminal sentence of up to 2 (TWO) Years and fine, or both. It is stated that if you, Addressee No. 1 and 2 attempt to evade from taking the reparatory measures as specified herein below and refrain from ceasing and desisting to spread such false and malicious information about my client or any other such and similar unethical acts, the same shall have to be dealt, addressed, and redressed with stern action and heavy hands by my client.
10. That my client on the basis of his valued business and social relations and esteemed reputation built over decades in the community and now tarnished by the severely condemnable and punishable acts committed by you the Addressee No. 1 and 2. My client over the years has successfully nurtured the Trust and these concerted and serious efforts of my client made towards the benefit and welfare of the trust were derailed and stalled owing to the wrongful, illegal, and illegitimate conduct and acts of You, the Addressee No. 1 and 2.

11. It is stated that my client has invested years in nurturing and enhancing the Trust. It is stated that my client commands serious regard, appreciation, and respect owing to the goodwill of my client that has so developed over years through mindfully determined efforts and honest, trusted, and ethical conduct of my client, which have been seriously jeopardized vide newspaper article dated 9th June, 2021 at Page 5 in Soneri Surat.
12. It is stated that none of the allegations as made by you, the Addressee No. 1 in the above newspaper article are true and the same are a desperate attempt on part of you, the Addressee No. 1 to demerit the stature of my client for your illegal and illegitimate interests, and in furtherance thereof to harm the bona fide and honest venture of my client in the Trust.
13. It is stated that it is brought to the attention to you, the Addressee No. 1 and 2 that my client has had to make significant, substantial, and swift efforts to resolve and overcome the challenge as raised by you, the Addressee No. 1 and 2 by having thrown the reputation of my client in the way of harm through newspaper article circulated amongst members of Parsi and Gujarati Community.
14. In light of the aforesaid facts and circumstances, I hereby direct you, Addressee No. 2 to unconditionally tender apology in the respect of the above article published in "Soneri Surat" to my client within next 15 (Fifteen) days from the receipt of this Notice, failing my client shall initiate appropriate proceedings in the court of law. It is further directed to you, Addressee No. 2 to unconditionally withdraw/take down Facebook post immediately having the URL as mentioned above. I further direct, you Addressee No. 1 to tender unconditional apology for wrong and malicious accusations against my client causing huge dent to his image and transmit an amount of INR 25,00,000/- (Rupees Twenty Five Lakhs only) as compensation within next 15 (Fifteen) days on account of disrepute brought to my client by you, Addressee No. 1 in the entire Parsi and Gujarati Community and towards mental and psychological agony faced by my client.
15. It is stated that in case you, Addressee No. 1 and 2 fail to act in favor of my Client within the time specified hereinabove, the consequences of the same shall be initiated against both of you. My client shall also be entitled to undertake any legal action necessary, civil or criminal, for the malicious and defamatory article and for recovery of the compensation along with interest specified or otherwise, as well as damages sustained by my Client due to your failure to comply with the above directions.

We therefore call upon you to discharge your liabilities towards my Client at the earliest and within the time specified.

It is our fervent request that the New International Airport at Navi Mumbai be named after the legendary industrialist and 'Father of Indian Aviation', Mr. J.R.D. Tata.

J.R.D. Tata is an **International Icon** whose name is synonymous with Indian Industry and **India Aviation**. It would therefore not only be a fitting tribute to JRD, but naming the International Airport after him would resonate positively with the international community world-wide.

As you are aware, **in 1992 JRD received India's highest civilian honour, the Bharat Ratna.**

Mumbaikars are very excited about this new state-of-the art airport which will surely become a **Mumbai Ratna** or jewel in Mumbai's crown. Naming it after *Bharat Ratna* JRD would further enhance the value of this Mumbai Ratna.

History records that on 10th February 1929 JRD qualified as **India's First Pilot with License No. 1**. This license was then called an 'aviators' certificate' and issued by The Aero Club of India and Burma, an associate of the Royal Aero Club of Great Britain, which was authorized to issue licenses by the British Empire's Federation Aeronautique Internationale. The Aero Club of India and Burma was recognized by Federation Aeronautique Internationale as a sporting authority.

J.R.D. launched India's first airmail service in 1932, when he flew into Mumbai in a De Havilland Puss Moth from Karachi's Drigh Road Aerodrome to the Juhu Airstrip via Ahmedabad on the basis of this flying license. **This later became the country's national carrier, Air India.**

The airline was founded by J. R. D. Tata as Tata Airlines in 1932. After World War II, it became a public limited company and was renamed as Air India.

Kalpana Chawla, the Indian-born astronaut who perished in the Columbia space shuttle disaster, cited JRD and his pioneering airmail flights as her inspiration for taking up aeronautics. He touched the lives of countless others, rich and poor, manager and worker, as he became the embodiment of the principles and philosophy of the House of Tata.

JRD was awarded the Padma Vibhushan (1957), **the Daniel Guggenheim Medal for aviation (1988)**, the United Nations Population Award (1992).

Under JRD's guidance, several institutions were established to promote scientific, medical, and artistic endeavors in India. These included the Tata Institute of Fundamental Research, Tata Memorial Hospital, the Tata Institute of Social Sciences, the National Institute of Advanced Sciences, and the National Centre for the Performing Arts.

JRD was an early advocate of family planning and in 1971 he created the Family Planning Foundation of India.

In our humble opinion, it would be in the fitness of things to name the new airport after a true pioneer (of aviation) and patriot like JRD Tata.

On behalf of the Parsi Zoroastrian community and all proud Mumbaikars and admirers of JRD Tata, we the Trustees of the Bombay Parsi Panchayet, urge the Government of Maharashtra to consider our request favorably and gladden the hearts of thousands of admirers of JRD and your government.

The Community is aware that since decades Meherwan Irani, ex-President of Irani Anjuman and his wife had waged a single handed battle against Land Sharks to save the Tithal Sanatorium property from being sold to some Developer but to retain it for community use and enjoyment and after years of effort got the property back for community benefit.

Since their age and health was not upto mark as when they started their struggle against the Land Sharks, they decided to hand it over to Valsad Parsi Anjuman on the clear understanding that the Trustees would restore the Sanatorium to its pristine glory and maintain it for community use and benefit.

Imagine their shock and dismay when they found out that the Valsad Anjuman was preparing to sell but due to the vigilance of two residents of Valsad, the matter is being heard in the Office of the Charity Commissioner at Mumbai. It is not understood why Sam Chothia registered Tithal Sanatorium at Mumbai and not VALSAD, Gujarat.

It seems our disclosure of the attempt of Sam Chothia to sell this very valuable sea facing property for a pittance in one of our issues of Parsi Junction has so jolted the wife Mrs. Binafsha Meherwan Irani that she has complained to the President of the Federation to immediately take steps to stop the sale on behalf of FPZAI and restore it for community use and benefit. We reproduce below her letter sent to BPP Trustees for its restoration and to stop its sale.

Dear Madam/Sirs:

Whilst reading the Parsi Junction, it came to my attention that Mr Sam Chothia whom my husband Mr. Mehrwan Homi Irani and myself had trusted and had entrusted to

look after the Tithal property because of health issues and advanced age, was trying to sell off the property.

Going back in time, the first time when I got to know about our property at Tithal lying in a bad shape with the then persons in know trying to dispose it off to one Bipin shah, my husband and I started our endeavour to save the property by first approaching the Charity commissioner, then various courts including the Hon'ble High Court and Supreme Court by filing petitions to safeguard this property.

During the ensuing period, as Mr. Bipin shah was getting frustrated because he could not lay his hands and grab our property, he filed a criminal case against the erstwhile trustees, one of whom was solicitor Mr Pardiwala at Girgaon Court, Mumbai. This was strongly opposed by us with the assistance of advocates Mr. Rummy Mirza and Mr. K. N. Tavakkuli. After several hearings, the case was finally dismissed as Bipin shah withdrew the case.

It is therefore shameful that the present day caretakers are just interested in disposing off this goldmine. 35 years of our struggle to save this property by dipping into our own resources is being sold without even thinking of our struggle to safeguard our property for our future generations. I strongly feel that we can surely collect funds and rebuild our sanatorium /dharamshala instead of selling it off and the same being lost forever.

Kindly note that this is Zoroastrian community property was being sold to a Jain Trust by the then Trustees in the early eighties.

This tithal sanatorium was built by members of the Zoroastrian community a century ago and when on our visit to Tithal we saw it was being pulled down. On reading about the agreement to sell the land by the then Trustees my husband and I had taken on the onerous task of saving the property from land sharks.

We started by moving the Charity Commissioner's office and afterwards the matter was argued in the City Civil Court and thereafter in the Supreme Court after which the matter was referred back to the Charity Commissioner's Office.

It was our lone battle but divine help came from our legal fraternity who appeared for us in various courts without charging a single rupee. Afterwards they participated in our struggle starting with Advocate K N Dastoor (who later became the Meherji Rana Vada Dastoor of Navsari) at the Charity Commissioner's Office and ending with Mr Fali Nariman winning the matter in the Supreme Court. This would not have been possible without the help of Legal Luminaries like Nadir Mody, Bomi Zaiwala, Aspi Chinoy, Mr. Soli Morris and Mr Behram Vakil both of Little and Company.

For years the IRANI Anjuman paid the taxes Since all the then Trustees had died.

When the matter was back in the Charity Commissioner's office and as we were party in this matter, we requested Mr. Sam Chothia to get involved in the matter as he was Valsad based, due to health reasons. **We did not realise then that he himself was a land shark and would dispose off the property.**

We have put in 35 years of struggle into this and we request the Zoroastrian Community not to allow Mr Sam Chothia to sell this property.

Meanwhile you are requested, to take up on war footing, to ensure this property is not sold off by Mr Sam Chothia n letting all the honorary hard work of all the Legal Luminaries n ourselves put in during the past 35 years go to waste.

This legacy left behind by our forefathers has not to be sold to benefit any individual but must be maintained for the benefit of our community now and in future. Please note this is a prime property which once sold will be impossible to get anything like it ever.

KERSI RANDERIA'S HYPOCRISY EXPOSED

In Parsi Times issue dated 10th July 2021, an article in honor of **MUNCHERJI NUSSERWANJI CAMA** was published by its Owner Kersi Randeria under the heading "Muncherji Nusserwanji Cama Passes Away". Randeria praises Munchi as a much respected philanthropist, especially committed to the cause of education and medical treatment for the under privileged.

What a hypocrite this criminal Kersi Randeria actually can be.

After reading the praises bestowed above, the readers will be shocked at the behavior of the same Masoor Pav Kersi Randeria towards the Aristocrat Muncherji Cama. **Of course the jealousy of the failed businessman that Kersi Randeria is with his huge debt burden compared to the billionaire Munchi Cama is also a factor to be considered.**

In the last issue of Parsi Junction, we had pointed out how Yazdi Desai and his wife Anahita extracted their revenge on Muncherji Cama for the loss inflicted on Anahita by taking advantage of their Majority on the Board in April 2015 –Yazdi Desai, Khojeste Mistry, Arnavaz Mistry and Jimmy Mistry–by filing a bogus Change Report based on a false improper Resignation letter with the Charity Commissioner for his removal.

In November 2013, Charity Commissioner had issued a Stay Order against all seven Trustees from dealing with any property of BPP.

Munchi Cama was getting frustrated at the number of **DESERVING** applicants coming every week and in spite of having over 100 vacant flats in Trustees possession they were unable to help them.

In disgust ultimately in April 2015 Munchi Cama submitted his resignation to the Board of Trustees which **LUCKILY** was not in

accordance with the Scheme of Elections and as CHAIRMAN Dinshaw Mehta refused to accept the same.

But Yazdi Desai taking advantage of his Majority filed his inapt improper resignation letter with Change Report before the Charity Commissioner and refused to allow him to attend BPP office till the Charity Commissioner gave his findings on the Change Report.

Thus the Masoor Pav Trustees –Yazdi Desai, Khojeste Mistry, Jimmy Mistry and Arnavaz Mistry were able to block the entry of the last of the Sethia Trustee Munchi Cama for at least more than three years. **The hearing of the Change Report went on and on with Anahita Desai coming with her bodyguard Kayresh Patel at every hearing and delaying the proceedings as much as she could.**

The bodyguard later was rewarded by Yazdi and Anahita Desai with a large flat in Dadar Parsi Colony though he had a vacant flat of his late father Cyrus Patel in Godrej Baug C-10 which is now reserved by Yazdi Desai and Anahita Desai for the brother who is settled in USA and married to a Muslim. Due to their influence this flat is not even shown as an unoccupied/locked flat in the BPP records.

Ultimately in March 2018, the Change Report was rejected by the Charity Commissioner as being illegal and not in consonance with the terms of the Scheme of Elections and Munchi Cama's right as a Trustee of BPP was restored but he could attend only one Board meeting as his seven year term expired soon thereafter.

Thus the husband and wife team of the Desai's did extract their revenge against Munchi Cama who was deprived of almost half his term as a Trustee by the cunning Yazdi and Anahita Desai.

In October 2015 fresh elections were held for five Trustees vacancy and the new Board in October 2015 now consisted of Yazdi Desai as Chairman, Noshir Dadrawala, Zarir Bhatena, Kersi Randeria and Viraf Mehta along with continuing Trustees Armaity Tirandaz and Muncherji Cama whose Change Report was being heard in CC office and hence could not attend BPP office.

Munchi Cama approached the new Board members with request to withdraw the **FALSE** Change Report for his improper resignation. Armaity, Viraf and Zarir were ready and willing to withdraw by Majority, the false Change Report in December 2015 itself but Kersi Randeria who was acting as the Defacto Chairman realized that if Munchi started attending BPP Board meetings, his rule as the Defacto Chairman would get affected and hence he was not in favor of allowing Munchi to attend Board meetings till July 2018. When Munchi approached Noshir Dadrawala to



allow him to attend Board meetings, initially Noshir agreed but on being told by Kersi Randeria not to allow Munchi to attend, the poor Noshir had to obey Kersi's instructions, even though his heart was not in it. But Kersi convinced Noshir that the six of us—their four majority Trustees and the two others Armaity Tirandaz and Viraf Mehta who were treated as untouchables were working well but if Munchi came in then he would not allow the four of them to function in peace and hence convinced Noshir that it was in their interest to keep him out.

Thus from October 2015 till the CC's Order of March 2018, Kersi Randeria in collusion with Yazdi Desai would not allow Munchi to attend any Board meeting fearing that Munchi would stop his Dadagiri as Defacto Chairman. **This was how the last of the Sethia was deprived to function as a Trustee by the Criminal minded Kersi Randeria.**

In April 2016, the seven year term of Armaity Tirandaz came to an end and she recontested supported by Dinshaw Mehta and Munchi Cama and defeated Arnavaz Mistry who was supported by Yazdi Desai, and Kersi Randeria.

In July 2018, the official term of Munchi Cama came to an end and Xerxes Dastur supported by Dinshaw Mehta was elected defeating again Anahita Desai who was supported by the Chairman and Kersi Randeria. Once again the vengeful Yazdi Desai did not file Xerxes Dastur's Change Report as required **WITHIN TWO MONTHS** but for over a year refused to file and ultimately he was forced to file Dastur's Change Report for which Penalty was imposed on Yazdi Desai for the delay.

Anahita Desai also filed an Appeal before the Board of Trustees alleging all kinds of irregularities but as she could not get any proof of the same hence she did not proceed further and let her Appeal die a natural death and then Yazdi had no choice but to

file Xerxes Dastur's Change Report after more than a year.

Thus the vindictive and vengeful ways of the husband and wife team is now proved and should this kind of people who are vindictive be allowed to become Trustees is for the community to understand and decide. There is no doubt in our mind

that the vindictive Anahita Desai is bound to take her revenge on those who opposed her or did not support her and hence let the community beware for.

POSTPONED - PUBLIC AUCTION: RUSTOM BAUG BLDG NO. 1 FLAT NO.7 - 4RK, 3RD FLOOR (Tenant Mrs. Nergish Lakdawalla / Mr Zend Lakdawalla - migrated to USA)

On Wednesday 14th July 2021, Zoom Auction of above Rustom Baug 4RK Flat No. 7, 3rd floor of Bldg. No. 1 was scheduled at 6.00 p.m.

But here was NO RESPONSE from any Bidder to the auction. Under the circumstances, the BPP Board of Trustees perforce had to Cancel the Auction for Flat 1/7 in Rustom Baug.

Since the flat was on third floor, the base price fixed by the Administration and Trustees at Rs. 3 Crores Deposit on Leave and License basis was a little too high for most bidders. The Trustees need to be practical and not be too greedy to expect such high Deposit for higher floor Leave License flats.

The Trustees have to further bear in mind that since November 2013 when the Charity Commissioner issued Stay on Trustees

dealing with property and after October 2015 thanks to Kersi Randria as the defacto Chairman did not allow any flat to be auctioned but given free to his close friends and relatives which continued till middle of 2019 when Yazdi Desai belatedly realized that Kersi Randeria was leading the BPP to bankruptcy and took over the Chairmanship burden himself and even threatened Kersi Randeria that he would move the Charity Commissioner for his removal u/s 41D of the Bombay Public Trusts Act 1950 as well as move the High Court for Contempt if he did not stop placing his Dissent Note below the Auction Notice.

Unfortunately before Yazdi could carry out his threat, he suffered a debilitating stroke which led to his confinement at home from April 2020 and ultimately resignation in December 2020.

Another aspect is that between November

2013 to August 2019, for almost 6 years needy Parsis who wanted the safety of the enclosed gated colony as well as more chances of their children finding Parsi life partners were deprived by the depraved policy of Kersi Randeria had no alternative but to buy Ownership homes outside in cosmopolitan Societies by taking loans from HDFC and Banks and hence the demand supply ratio was twisted in favor of supply to the detriment of our community.

It is therefore surprising to find his wife, Anahita Yazdi Desai, an Orthodox, taking the support of the Reformist Kersi Randeria to ensure her entry after two failed attempts into the BPP Boardroom. Such pseudo Orthodox need to be punished by the community who are willing to sell their souls by deserting her husband's moral stand to oppose Kersi Randeria in exchange of getting a Trustee chair in the BPP Boardroom.

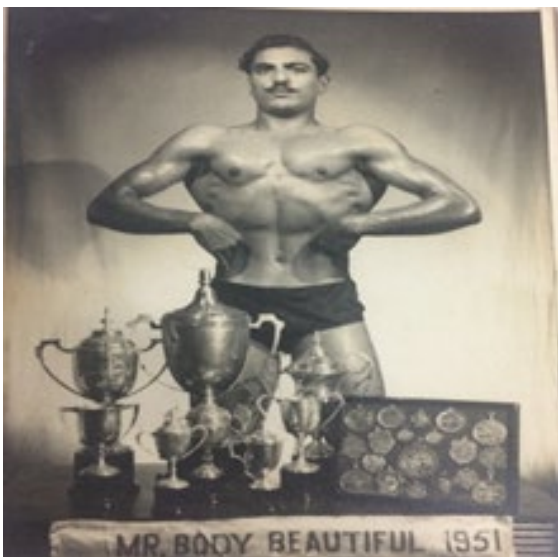

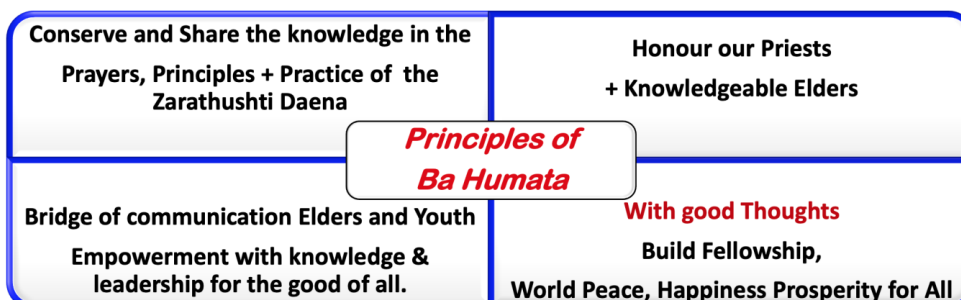
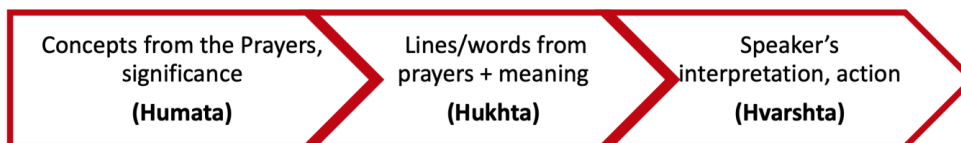
