

BPP ELECTIONS IN MARCH 2022 Will It Be Under The New Scheme?

On Wednesday, October 20, all 5 trustees signed consent terms (attached on page 3) as well as an undertaking to produce the same in Court. When I signed these documents I repeatedly told Noshir Dadrawala that I was doing so under duress and the only reason

I was signing was to get him to eat and drop the farce of a fast he was on. He was blackmailing us because he was unhappy being in a minority and only out of concern for his health, Mrs. Tirandaz, Xerxes and I were willing to sign too. In fact Adv Berjis Desai repeated the same to Noshir that all this was being done only to get him to eat and nothing else. It was a new low for the BPP and unfortunately we had to bow down to Noshir's blackmail just to preserve his health.

It is important to note that in September 2021 Kersi and Noshir were advised that if they were so confident that the Court would permit elections, to move a petition calling for early elections before a Single Judge. However, after realizing that elections were NOT PERMITTED UNDER THE PREVALENT SOPs, they realized moving the High Court would cause them further embarrassment and hence, they chose to go on a hunger strike and blackmail us into holding elections.

One has to realize that Noshir and Kersi wanted to hold elections now for only 2 seats under the old scheme costing the BPP Rs. 40 lakhs, even if it meant spending another Rs. 40 lakhs in ten months on another election. But even if they wanted to hold elections today it would not be possible as the August SOPs restricting electioneering are in play. Instead Mrs. Tirandaz, Xerxes and myself agreed to cut short our terms to ensure elections for all 7 Trustees would happen together.

I would like to let the community know that never have I said I would not sign nor have I wriggled out of any commitment as was mentioned by Kersi and Noshir in the Parsi Times yesterday. I intend to stand by what I signed on October 20 '2021. I have repeatedly mentioned that I have shown my bonafide by signing those consent terms.

The reason all Trustees decided to step down early, curtailing our lawful term of office was to ensure that the scheme of elections is not only amended but also applicable to all perspective candidates who stood for elections in March '22 elections.

In yesterday's Parsi Times Kersi and Noshir have once again made baseless allegations against me and conveniently have not disclosed the facts.

On Oct 20 '21, when the consent terms were being typed out, a very important clause was missed out. Despite that, I was being pressured to sign the consent

terms with that crucial clause missing and unless I had pointed it out, the consent terms would have surprisingly been filed in Court without it.

This important clause mandated the BPP to amend the scheme of elections by a certain date (originally Nov 1 now revised to Nov 15 '21) and subsequently have the new scheme apply to the March '22 elections. This was pointed out to the Board by me at our Board meeting on Tuesday, Oct 26 and a revised draft was sent to all to settle.

On Wednesday, Oct 27, I informed the Board that the revised draft was missing the date by which the scheme had to be amended. Without a date being set the amendment process can be dragged on for years, just like it was dragged along for the last 5 years despite Kersi and Noshir having the majority on the Board.

Please note that despite having signed the Consent terms last week and giving a press statement, Kersi and Noshir wrote against us in the Parsi Times last Saturday (Oct 23). More so, Kersi in his usual style decided to take advantage of what we had signed and added that he wanted the Trustees duties and responsibilities also to be curbed. This was never discussed by us nor should it have even been considered. Knowing that Kersi always has a tricks up his sleeve we were forced to clarify and were advised to include in the consent terms that the Trustees will continue to function unfettered till their term ends. To this request of mine Kersi replied that this was understood and didn't need to be added in the consent term, contrary to what he wrote in the Parsi Times last weekend. This seemed like another attempt by Kersi to limit our decision making and hence made it even more necessary to include in the Consent terms. This transpired through Thursday, October 28 and was finally incorporated in the Consent Terms.

This sequence of events clearly indicates that there is more than meets the eye to Kersi and Noshir's sudden insistence to immediately file the incomplete Consent Terms. Whether the signed consent terms were filed last week or this week would not make a difference but the pressure tactics adopted by Kersi and Noshir definitely makes one wonder.

Never in a single correspondence of mine have I gone back on my word nor have I done anything against my conscience. I have always maintained that the March '22 elections should be under the new scheme but Kersi and Noshir refused to insert a clause mandating that. If the Court does not allow for the new Scheme of Elections to apply to the March '22 elections, then these elections will happen under the old scheme, exactly how Kersi and Noshir wanted it to be.

Now it is for us to ensure the newly amended scheme will be applicable for the March '22 elections.

Noshir talks about honestly and being a true Zoroastrian however he will not admit that Kersi and he wanted early elections only for two seats under the old scheme only to benefit their candidates Hoshi Jal and Anahita Desai (openly admitted by Kersi in our Board meeting). Noshir will not tell the community that they were advised to move the Single Judge Bench of the Hon'ble high Court and yet he chose to go on an illegal hunger strike to blackmail us to give in to his demands. Noshir will not tell you that such was their angst to get us out of the BPP that they would rather have an administrator take over in March than us continue our terms and he has the audacity to question my integrity.

I will repeat myself. I intend to honour what I signed on Oct 20, 2021. We will move to get the scheme of elections amended and will work hard to ensure it is applicable for the March 22 elections. I will not play word games like Kersi and Noshir and try and mislead the community with half-truths and innuendoes. I will ensure our early resignation pays off in the larger interest of the community and unlike some of my colleagues, this won't be mere lip service.

CONSENT TERMS

- 1. The Parties agree that elections for all seven trustees will be held on 27th March 2022.
- 2. The Parties agree to file a petition to amend the Election Scheme (including but not limited to, limiting the term of office of a Trustee to five years (from the present seven years) and a maximum of two terms during the lifetime of a trustee; as also a suitable mechanism to prevent frequent mid - term elections).
- 3. The term of office of the present five trustees namely, Mrs. Armaity Tirandaz, Mr. Noshir H. Dadrawala, Mr. Kersi J. Randeria, Mr. Viraf D. Mehta & Mr. Xerxes V. Dastur will be deemed to have expired on the date upon which the seven new trustees assume office, after the elections under Clause (1) above.
- 4. Notwithstanding anything contained herein, the timetable for holding the elections (27th March, 2022) as stated in Clause (1) shall not under any circumstances delayed/derailed/postponed/extended, save and except if the holding of such elections becomes impossible on account of a government/municipality ordered pandemic lockdown.

LIES OF NOSHIR DADRAWALA AND KERSI RANDERIA EXPOSED

As the community is aware, the 23rdMay 2021 elections proposed by the Division Bench of the High Court by its Orders of 12TH March 2021 with directions to go before the Chamber Judge for his confirmation, were postponed in April 2021 by the Chamber Judge due to the severe onslaught of the second wave of the Covid Pandemic without fixing any further date of elections.

In July 2021 when the Trustees were unanimously considering moving the Chamber Judge with a fresh Petition for an Election date for Two vacancies sometime in October 2021. the Govt. and BMC issued fresh SOPs dated 3rd August 2021 not permitting elections, electioneering, holding meetings and rallies or canvassing, the Trustees had no choice but to further postpone the elections to November 2021.

Since the two Trustees. Noshir Dadrawala (ND) and Kersi Randeria (KR) were frustrated at their sudden loss of power from January 2021 when Armaity Tirandaz was elected as Chairman/Chairperson of BPP, THE TWO DISSENTING Trustees surreptitiously behind the back of the three majority Trustees moved an Application/Appeal before the **Division Bench of Hon'ble Justice** Kathawalla and Justice Jadhav and by Praecipe dated 17th September 2021 sought urgent hearing of their **Election Petition without serving** the other three Trustees.

The Division Bench of Justice Kathawalla rejected their Praecipe and directed them to approach the concerned Chamber Judge with their Election Petition. A copy of their

Praecipe dated 17th September 2021 and the Court's Order to go to single judge in chamber is reproduced below.

We are concerned for the Applicants/Org. Appellants in the above matter.

Kindly find attached herewith the Praecipe dated 17th September 2021.

By an Order dated 12th March 2021, this Hon'ble Court by consent of the parties fixed a schedule for conducting the election of the Bombay Parsi Panchayat. The parties also gave an undertaking to hold elections on 23rd May 2021 and that the same would not be cancelled on any ground whatsoever including on ground of the prevailing pandemic, except a lockdown being declared by the State Government. By the said Order, the above Appeal was disposed off. This Honble Court had granted parties Liberty to Apply. The Applicants have on several occasions requested the Respondents to hold the election/give a fresh timeline to conduct elections as per order dated 7th April 2021. However, till date the Respondents have not taken any steps for proposing a new programme for election and have not given a timeline for holding elections which is in the last week of November 2021. The Applicants have learnt that the Respondents are making attempts to postpone the elections to be held in November 2021 also. Hence the urgency.

The praecipe sets out in detail the urgency.

In view thereof, be pleased to circulate and place the above matter on board before His Lordship Justice S.J. Kathawalla and His Lordship Justice Milind Jadhav on Tuesday i.e. the 21st day of September 2021 for grant of urgent adinterim/interim reliefs.

ND and KR did not move the Chamber Judge with their Election Petition and whatever grievance they had about not holding Elections for two vacancies but kept quiet about their Election Petition without informing anybody of the directions of the Division Bench. If they were aggrieved by the majority not fixing a date of elections for two vacancies then they had the option to move Court on 20th Sept. 2021 as per the Court's directions.

Even otherwise under the Consent Terms of May 2017 signed by them before the High Court it was agreed by all that majority decision would be binding on all including the dissenting Trustee and would have to be obeyed by all unless the dissenting Trustee moved the Court against any illegal decision of the majority Trustees.

Inspite of two High Court directions, the two dissenting Trustees did not bother to move the High Court against any alleged wrong decision. And then they have the audacity and shamelessness to accuse Armaity and others of disobeying High Court orders. What a bunch of hypocrites!!

Due to the Govt. SOPs of 3rd August 2021 still continuing, the majority Trustees decided on 12th October 2021 board meeting to amend the Scheme of Elections promised by all Trustees in October 2015 and reconfirmed by KR in his interview published in Parsi Times of 14th November 2015.

On 12th October 2021, two groups, one led by, Phiroze Amroliwalla and Dr. Zuleika Homavazir and the other led by Anahita Desai and Arzan Ghadially met the Board of Trustees.

In the BOARD MEETING, Zuleika submitted that she had served a legal notice from her advocate dated 11th October 2021 to the Trustees to first amend the Scheme of Elections to reduce the term of office from 7 years to 5 years before holding any further elections as promised by KR and ND since last five years.

Mr. Pheroze Amroliwalla informed about the news that Elections for the two vacancies were to be held in the coming months. He informed that as three more seats would be vacated in October 2022, it was advisable to hold the Elections for all the five vacant seats together in October 2022, as, if an Election for two seats are held in the coming months then it would be a waste of community funds amounting to around Rs.40 lakhs being the cost of one Election.

On one hand the community is informed that since 2016 BPP is facing a cash crunch and for which an additional service charge of Rs.750/was levied upon the beneficiaries, but now the Trustees are ready to spend

around Rs.40 Lakhs to Rs.50 Lakhs for the two seats, it does not make sense at all, hence it was a request that the Elections for the total five seats be held in October 2022 only.

Mr. Noshir Dadrawala stated that Elections for the vacant seats and the term of the Trusteeship are two different issues. Mr. Rumi Zarir inquired that in 2015 all the prospective candidates had agreed / promised for a 5 year term, why is the term not reduced till date. Mr. Noshir Dadrawala stated that if in October 2022 all the Trustees resign at the same time then he was willing for the 5 year term. Mr. Kersi Randeria stated that actually the Scheme was drafted with two terms of 5 years each but it was not discussed and implemented. Mr. Noshir Dadrawala confirmed the same and stated that he pleaded guilty for the same.

Mr. Viraf Mehta stated that there was a majority on Board for a long time but the amendment was not considered at that time. Mr. Berjis Desai has opined that it would take around 3 to 4 months for amending the term of Trusteeship. After the amendment, if the Elections are held for the current 2 seats then there would be a very short gap of around 8 months only before the next coming Election in October 2022. Two Elections in such a small period would be a costly affair. At present there is a cash flow deficit of around Rs.11 Crores. It was advisable

to go for the whole amendment which could be done within a period of 8 months that is before October 2022, therefore, it would be better if the Elections for the present two seats are postponed till October 2022 where in one Election all the 5 vacant seats can be filled.

Mr. P. Amroliwalla stated that this group had visited the Trustees since the other group was forcing the Trustees to hold Elections for the two seats. Instead it was advisable to hold election for all the five seats in October 2022 which would save cost and within that period necessary amendment to the Election Scheme can also be done. Mr. Dadrawala stated that after October 2022 two more elections, one in 2023 and the other in 2025 are also to be considered for the cost factor, instead let all the Trustees resign together now and hold elections for all the 7 seats together.

The Group left and the other Group in favour of holding the Elections without waiting for amendments of the Election Scheme were called in. The Group was led by Mr. Hoshi Jal, Mrs. Anahita Desai, Mr. Arzan Ghadially and others.

Mrs. Armaity Tirandaz stated that she too was in agreement and that work to amend the scheme of elections should begin immediately and then the way forward can be decided. While KR kept pushing for early elections Mrs. Tirandaz stated that she was in favour of holding elections after the amendments were done. Mr. Viraf Mehta agreed with this proposal and a resolution was passed to amend the Scheme for reducing the Term of Trusteeship from 7 years to 5 years following due process.

Expectedly, ND disagreed and insisted on early elections. He kept referring to the High Court order of March '21 to hold elections in May '21 but refused to acknowledge that the order was set aside in April '21 by the Chamber Judge. He insisted on December or early January 2022 even though current SOPs still had restrictions on the election process and no Court would give permission. He kept insisting on having early elections and at the same time amend the scheme knowing full well that the new scheme would not be applicable if early elections were held. Important amendments like reducing the term of a Trustee from 7 to 5 years, two terms maximum, co-terminus elections and a code of conduct are necessary to be applicable to all new Trustees but ND and KR kept brushing that aside for early elections, for obvious reasons.

It is the duty of the Trustees to protect the Trust and its beneficiaries. If the trust has outstanding payments of Rs. 11 crores, how can KR and ND justify spending Rs 80 lakhs on two elections in just ten months apart. They have to start to think about the community and not their supported candidates.

When Anahita Desai, Hoshi Jal & others were called back in to the Board room, they were informed of the decision to hold joint elections for five seats after the scheme of elections was amended and made applicable to the March 2022 elections.

Not taking kindly to this decision, Arzan Ghadially and Shahrukh Billimoria began to argue with the Trustees and begun aggressively talking to the Chairman Mrs. Tirandaz.

In the midst of this, ND stated that he has resigned with immediate effect. He hand wrote and signed his resignation letter addressed to the Chairman and submitted the same to the Chairman. Kersi quickly took the letter from the Chairman and kept it in order to convince Noshir to change his mind.

AS EXPECTED THE TRIO WILTED UNDER THIS BLACKMAIL THREAT JUST OUT OF COMPASSION FOR ND AS HE IS A CANCER SURVIVOR AND SUFFERING FROM OTHER AILMENTS.

ON 20TH **OCTOBER** 2021. **CONSENT TERMS** ON **BPP** LETTERHEAD WERE SIGNED BY ALL FIVE TRUSTEES IN GOOD FAITH AND BELIEVING IT WAS THE **EXACT REPRODUCTION OF WHAT** WAS DRAFTED BY BERJIS DESAI AND AGREED BY ALL WHICH WAS PUBLISHED ON PAGE 4 OF PARSI TIMES.

ACCORDINGLY CONSENT TERMS THE **FORMAT** REQUIRED BY THE HIGH COURT WERE AGAIN PRINTED OUT AND AFTER **OBTAINING SIGNATURE** THREE TRUSTEES WAS SENT TO VIRAF FOR HIS SIGNATURE.

THE HASTE AND URGENCY TO GET HIS SIGNATURE RAISED THE SUSPICION OF VIRAFMEHTA WHO

STARTED COMPARING WITH THE ORIGINAL HANDWRITTEN NOTE OF CONSENT TERMS BY BERJIS DESAI AND TO HIS SHOCK **LACUNA** DETECTED SEVERAL AND DELIBERATE OMMISSIONS OF **IMPORTANT CONDITION** THAT **AMENDMENT WOULD** APPLY RETROSPECTIVELY TO THOSE ELECTED ON 27TH MARCH 2022 WAS COMMITED BY THE CRIMINAL MINDED KERSI **IMMEDIATELY** RANDERIA. HE CONTACTED BERJIS DESAI ON SUNDAY 24TH OCTOBER 2021 WHO CONFIRMED THAT THIS CONDITION WAS IMPERATIVE TO BE INCLUDED IN THE CONSENT TERMS.

ON SUNDAY **HENCE 24TH** OCTOBER 2021 VIRAF MAILED KERSI RANDERIA TO INCLUDE THIS LEFT OUT PORTION IN THE CONSENT TERMS.

REALISING **ERROR** THE IMMEDIATELY **AGREED** AND FRESH **CONSENT TERM** WAS TYPED OUT AND FRESH SIGNATURES OF THE OTHERS AGAIN OBTAINED AND SENT TO

VIRAF FOR HIS SIGNATURE

ONCE AGAIN THE HASTE AND URGENCY EXPRESSED BY KR RAISED VIRAF'S SUSPICION AND ON SCRUTINY HE DETECTED THAT THE DATE BY WHICH THE SCHEME WAS TO BE AMENDED AND FILED IN HIGH COURT WAS MISSING.

ONCE AGAIN THE CONSENT TERMS WERE SENT BACK FOR CORRECTION TO INCLUDE THE DATE AND AFTER DISCUSSION IT WAS AGREED TO FILE IN THE HIGH COURT THE SCHEME **AMENDMENT** 15TH BY NOVEMBER 2021. THE CONSENT TERMS WERE AGAIN AMENDED AND FINALIZED.

LAST SATURDAYS PARSI TIMES OF 24TH OCT2021, ONCE AGAIN HAD A NEW ANGLE BY KR THAT TRUSTEES WOULD NOT DO ANY AUCTION OR ALLOT FLATS, ETC. THIS WAS NOT ACCEPTABLE THAT THE RIGHTS OF THE TRUSTEES SHOULDBEFETTEREDINANYWAY AND INCLUDED A FRESH TERM IN THE CONSENT TERMS. ONCE AGAIN KR HAD TO AGREE THAT

THE RIGHTS OF THE TRUSTEES WOULD BE UNFETTERED FOR THEIR REMAINING TERM.

KR WANTED BPP ADVOCATE TO ALSO SIGN THE CONSENT TERMS FOR WHICH VIRAF REQUESTED KR TO FIRST APOLOGISE FOR HIS FALSE ALLEGATIONS AGAINST THEIR ADVOCATE THE FIRM OF J. SAGAR AND ASSOCIATES. LATE AT NIGHT, KERSI FINALLY AGREED.

OTHER PERHAPS DUE TO **COMMITMENTS** OF THE PARTNERS OF J. SAGAR AND ASSOCIATES, THEY HAVE NOT BEEN ABLE TO REPLY TO KR BUT IT IS VERY CLEAR THAT ELECTIONS WILL BE HELD ON 27TH MARCH 2022 WHETHER AND CONSENT TERMS ARE FILED BEFORE THE COURT VACATION OR AFTER THE COURT VACATION IS IMMATERIAL. THE REASON FOR THE UNHOLY HASTE IN FILING THE SAME IS NOT UNDERSTOOD AS LONG AS ELECTION SCHEME IS AMENDED WHOSE TERMS WILL BE APPLICABLE TO THE TRUSTEES ELECTED ON 27TH MARCH 2022 WILL APPLY.
