

THREE MAJORITY TRUSTEES FILE PETITION IN HIGH COURT TO AMEND THE ELECTION SCHEME

As the community is aware on 20th October 2021, all five Trustees had filed Consent Terms to have Elections on 27th March 2022 for all seven Trustees vacancies as well as to amend the Scheme of Elections to reduce the term of office of a Trustee.

However when the time came to move the High Court for sanction to hold elections on 27th March 2022 as well as Petition to amend the Scheme of Elections to reduce the term of office of a Trustee, Noshir Dadarawala and Kersi Randeria only opted to hold elections on 27th Mach 2022 but without filing Petition to amend the Election Scheme which application is pending hearing before His Honor Judge Menon of the High Court.

In the meantime the three Majority Trustees of Armaity Tirandaz, Viraf Mehta and Xerxes Dastur after signing the Petition to amend the Election Scheme through their legal Counsel DSK LEGAL sent the Petition to Noshir Dadrawala and Kersi Randeria for their approval and signature but the Duo refused to unequivocally endorse the same and hence a fresh Petition was signed by the three of them and forwarded to their advocate to file in the High Court.

We reproduce below the gist of the Amendment filed by them in the High Court:

THIS HONOURABLE PETITION OF THE PETITIONERS ABOVENAMED **MOSTRESPECTFULLYSHEWETH:-**

- 1. The Petitioners above named form part of the Trustees for the time being of the Funds and Immovable Properties of the Parsi Punchayet of Bombay. Mr. Zarir M. Bhathena, a Trustee, died on 24th June 2020; and Mr. 'Yazdi H. Desai, another Trustee, resigned on 23rd December 2020 (and subsequently died on 2nd November 2021).
- 2. Respondent No. 1 is the Charity Commissioner of the state of Maharashtra. Respondent Nos. 2 and 3 are also Trustees for the time being of the Funds and Immovable Properties of the Parsi Punchayet of Bombay. The Petitioners and Respondent Nos. 2 and 3 are hereinafter collectively referred to as 'Present Trustees'
- 3. The Scheme for the Election of Trustees of the Funds and Immovable Properties of the Parsi Punchayet of Bombay (hereinafter for brevity's sake referred to as "the Scheme") was originally sanctioned by this Hon'ble Court on 18-06-1910, in Suit No.689 of 1906 and was thereafter from time to time amended by this Hon'ble Court on 27-07-1931, 07-02-1935, 02-04-1970, 16-06-1992, 23-10-1992, 06-01-1993, 01-04-2005, 21-08-2006 and 05-04-2007. Hereto annexed and marked as **Exhibit "A"** is a copy of the Scheme as presently in force.
- 4. The necessity for filing this Petition to amend the Scheme

has arisen in the following circumstances:-

- (a) The Petition to carry out the last amendments to the Scheme was filed on 20th October, 2006, i.e. almost fifteen (15) years ago.
- (b) Public opinion in the community has turned in favour of limiting the term of office of a Trustee to five years (from the present seven years) and for a maximum lifetime period in office of ten years (as against the present twenty one years). This is to ensure that there is no complacency amongst the elected Trustees and they remain accountable to the electorate.
- 5 Clause 70 of the Scheme provides as under:

"70. It shall be competent to a majority of the Trustees at any time, to submit to a Judge of the High Court in Chambers for sanction of this Scheme provided that the Trustees shall have given to the Charity Commissioner four clear days notice in writing of any application intended to be made by the Trustees under this Rule setting fourth in full the proposals to which the sanction of the Court is intended to be asked and the Charity Commissioner shall be entitled to appear and be heard on any such application."

- 6 All applications under Rule 70 of the Scheme are to be made by a Petition to the Hon'ble Judge in Chambers. It is also provided under Rule 74 as under:-
 - "74. Notice of .every such application as in Rule 73 mentioned and of the day fixed for the hearing thereof shall be published by the Trustees once in a Gujarati daily newspaper published in Mumbai, at least 14 days before the day fixed for the hearing thereof and such notices shall contain brief particulars of the proposed alterations and additions.

The Trustees shall, on application in that behalf made by any Parsee and on payment of such fees as may from time-to-time be determined by the Trustees, furnish to such applicant the full particulars of the proposed alterations and additions.'

- 7. As already stated hereinabove the last of the amendments to the said Scheme was sanctioned on 05-04-2007.
- 8. As a result of the said discussions, the Present Trustees are of unanimous opinion that the proposed changes ought to be made to the Scheme for elections of Trustees of the Funds and Immovable Properties of the Parsi Punchayet of Bombay.

- 9 For the purpose of convenience, the gist of the proposed amendments are set out hereunder:
 - (a) Limiting term of office of a Trustee to five years and to provide that a person cannot be a Trustee for more than an aggregate period of ten years during his lifetime.
 - (b) Such other consequential amendments as are necessitated by the above amendments.
- 10. A copy of the said Scheme inclusive of the proposed amendments is for the purposes of convenience annexed hereto and marked **Exhibit "B".**
- 11. In the premises aforesaid, the Petitioners approach this Hon'ble Court pursuant to Clause 70 of the Scheme and under the inherent powers of this Hon'ble Court for the purposes of carrying out the said amendments to the Scheme.
- 12. As provided under Rule 70 of the said Scheme, the Respondent No.1 herein, the Charity Commissioner, has been given 4 days notice in writing of the present Petition which was intended to be filed by the Trustees, setting forth the full proposals to which the sanction of this Hon'ble Court was intended to be asked for. A copy of the said Notice dated 26' November 2021 is annexed hereto and marked as **Exhibit "C".**
- 13. As provided under Rule 74 of the said Scheme, Notice of the present petition and of the proposed amendments, for hearing thereof is required to be published by the Trustees in the daily newspaper in Bombay, at least 14 days before the date fixed for the hearing. The said Notice is also required to state in brief the proposed alterations and additions.
- 14. The Petitioners will publish in the "Mumbai Samachar" as aforesaid the Notice of the hearing of the Petition and brief particulars of the suggested alterations, on a returnable date being fixed by this Hon'ble Court.
- 15. The Petitioners also propose to publish the said Notice in the 'Jam-e-Jamshed' which is a weekly newspaper which has a wide circulation amongst the Parsi Community.
- 16. The Petitioners says that the office of the aforesaid Trust is situated at Mumbai, and the Trust is administered in Mumbai. Most of the beneficiaries reside in Mumbai. The Scheme was originally sanctioned and from time to time amended by this Hon'ble Court. The Scheme

specifically provides for the same being modified with the sanction of this Hon'ble Court. The Petitioners therefore submit that this Hon'ble court has jurisdiction to try and dispose of the present petition.

- 17. The Petitioners have paid fixed court fees of Rs____/.
- 18. The Petition is signed by the Petitioners, who being conversant with the facts of the case are able to depose to the same.
- 19. The Petitioners will rely upon the documents, a list whereof is annexed hereto.
- 20. The Petitioners therefore pray:-
 - (a) That this Hon'ble Court be pleased to sanction the amendments of the Scheme in terms of Exhibit "B" hereto with or without such modifications as to this Hon'ble Court may deem fit.
 - (b) For such further and other directions as the nature and circumstances of the case may require.
 - (c) For costs of and incidental to the Petition and the ordersto be made thereon be provided.

The captioned matter was then mentioned on 21st December 2021 before the Hon'ble Bombay High Court seeking circulation in the captioned matter for hearing, when counsel Mr. Firoz Bharucha along with DSK team remained present before the Court.

However when the time came to implement the Consent Terms, both of them dilly dallied and refused to submit Petition for amending the Election Scheme as agreed in the Consent Terms.

Naturally Viraf Mehta was not ready to be taken for a ride by the devious methodology adopted by the two Heroes to have elections without even filing the Petition for Amendment of the Election Scheme. Then followed a plethora of sermons from the blackmailing duo about the three of them not keeping their word and that they were not Zoroastrians who dishonor their commitment and so on and so forth.

Parsis want rules modified for last rites

New Delhi: The numerically dwindling Parsi community on Monday waged a battle in the Supreme Court to preserve 'Dokhmenashini', an integral part of their religious practice for disposal of bodies, and complained that Covid guidelines have made no provision for their ritual, reports Dhananjay Mahapatra.

Appearing for Surat Parsi Panchayat Board, lawyer Fali S Nariman argued before a bench of Justices D Y Chandrachud and ASB opanna that the guidelines allowed only burial or cremation of bodies, hence made no provision for the community to carry out Dokhmenashini, a ritual during which the body of a deceased is kept at a height and over a well (Tower of Silence), to be eaten by vultures and decomposed by the effect of natural elements.

Nariman said, "In our faith, even the family members cannot touch the body of a deceased. It is the Nasheshalars who handle the body and take it to the Tower of Silence." Justice Chandrachud issued notice to the Union government seeking its response by January second week.

This is the day when light overcomes darkness Tomorrow is the day of Khorram in the Zoroastrian calendar. The people of Iran and several other

countries stay this night together with the elders until morning and celebrate and wait for the sunrise and the angel of love.

We set the table next to the elders and eat the symbol of Mehr angels such as red apple, red pomegranate, red table and watermelon. On this day, the devil escapes with the birth of Mehr's

Know Zoroastrianism - Know Shab-e-Yalda _The Persian night of mithra, goodness, poetry and light_

- "Shab-e-Yalda" or Yalda night is an ancient Persian cultural festivity marking the last day of fall, the longest night of the year.
- It's also referred to as Shab-e Chelleh, a celebration of winter solstice on Dec. 21. Persians all around the world gather with friends and family to celebrate and welcome winter into their homes. Other countries such as Afghanistan, Tajikistan, Uzbekistan, and Turkmenistan also celebrate the festival.
- The word Yalda means birth in Syriac, a dialect that emerged two thousand years ago. The last day of the Persian month "Azar" is the longest night of the year, when the forces of "Ahriman" or evil are assumed to be at the peak of their strength.
- The next day, the first day of the month "Day" - known as "khoram rooz" (the day of sun) belongs to Ahura Mazda, the Lord of Wisdom. Since the days are getting longer and the nights shorter, this day marks the victory of sun over darkness.
- In the past, Iranians celebrated Mithra, the goddess of light. To keep evil away, they kept a fire burning all night. This was also an opportunity to honor their deities and help others.
- Today, Iranians welcome each other usually at the home of the elders to eat and drink until well after midnight. Elders read poetry from the two ancient Iranian poet Hafez. He belonged to Shiraz, a well-known city of gardens and poets. Not many know that Dastur Azar Kaiwan Saheb was born in a village called Istakhar in Shiraz and lived some years ago.
- Each member of the family makes a wish and randomly opens the poetry book and asks

the eldest member of the family to read it aloud. What is expressed in that poem is believed to be the interpretation of the wish and another way of fortune telling.

- Iranians believe by eating summer fruits they will defeat sickness in wintertime. Pomegranates, placed on top of a fruit basket, are reminders of the cycle of life - the rebirth and revival of generations. The purple outer covering of a pomegranate symbolizes birth or dawn; their bright red seeds, the glow of life. Talking about this sacred fruit with maximum Khoreh, flashes before the eyes a miracle performed by our Prophet Asho Zarathushtra by giving one seed of a Pomegranate to Aspandiyar (son of King Gushtaspa, Shah of the Kayanian Dynasty) which made his body of Bronze so that no weapon of war could hurt him.
- For Iranians, Yalda Night is also the time to celebrate the birth of Meher Yazad. In the Avesta he is called Mithra and in Persian Mehr- the symbol of light, friendship, love and kindness. Meher Yazad is connected with all high energy radiations originating in outer space, which include sunlight (Khorshed Yazad). For this reason, we recite Khorshed and Meher Niayesh together in our mandatory prayers before sunset. Thus, Yalda Night is also celebrated as the 'Rebirth of Sun'. Therefore, a Divo is also part of the Yalda Table and should burn throughout the night to celebrate the victory of light over darkness.
 - Persian poetry on Yalda night also serves as a metaphor for other special meaning in today's life: separation from a loved one, loneliness and waiting. But at the end, the waiting is over, light shines, and goodness prevails.
 - This is an opportunity to celebrate life and a reminder of stepping into a new season. Hope we, Parsis / Iranis/ Zoroastrians embrace these festivals, by celebrating them from wherever we are.

The little known brave and pioneering Parsi Battalion in World War I

Parsis, most hailing from Bombay, served as soldiers in Europe during World War I. A stone cenotaph at Hughes Road at Kharegat Parsi Colony commemorates the 46 known Parsi soldiers killed in action in that war in Europe.

During WW I operations in Europe and the Middle East, the Parsi Battalion was accorded distinct honour and privileges over any of the other regiments hailing from India.

Since The Parsi Battalion was the only fighting force hailing from British India that was granted the same status as the British Army units, and it had a sanctioned strength of 1,051 Officers & men. All the battalion's men also had a working knowledge of English for commands and signals. For all other Indian Battalions, the Commanding Officer was a British officer of the rank of Lieutenant Colonel (Lt.Col) but the Parsi Battalion, was headed by a Parsi Commanding Officer with the full rank of Colonel. Parsis comprised the entire range of Commanding Officer, other officer ranks and general infantry ranks, with no British officers holding any commanding oversight over the Battalion.

The Parsi Battalion also had a reserve force of 551 Officers & men that did not go overseas, but were fully trained and stationed at strategic locations at Bombay for local guard and reconnaisance duty lest the World War reach Indian shores.

The first two Indians ever to be awarded the DSO Distinguished Service Order medal were Parsis in World War I (1914 – 1918). Capt. (later Maj. Gen.) Cursetjee and Capt. (later Col.) Bharucha, both of the medical services unit of the Battalion.

The reason why not much is written or remembered about the Parsi Battalion formed in India, like the history of the other regiments from India that also took part in WW I is due to the fact that the Parsi Battalion was the only fighting force hailing from British India, that was actually granted the same status as the British Army units, and were always counted as a British force rather than a British Indian Army unit, and all the Battalion's records therefore were kept in England rather than India.

Unfortunately too, about 60% of the Battalion's soldiers' official service records were irretrievably damaged or lost completely as a result of enemy bombings in London in 1940 during the Second World War. The exact number of serving Parsi Battallion soldiers is not known because of the unfortunate irrevocable loss of these paper records. The Parsi Battalion was fortunate enough to be equipped with high power weapons, machine guns, extra ammo, & rations & supplies including woolen blankets, woolen uniforms, which were superior in both quality & quantity. The heavy fire power they carried to the battle front made a great difference on the battle field.

Most men in the Parsi Battalion carried a Lee-Enfield rifle. Staff-Sergeants were also armed with the swordbayonet. The new machine guns though were in short supply at the time, but the Parsi Battalion never felt the shortage and was well-equipped and trained in their use.

The battalion also carried a certain fixed amount of ammunition, which was replenished with re-supply, if needed. The initial supply per rifle came to 550 rounds per man. The battalion transport carried 32 boxes of 1,000 rounds, and each man could carry up to 120 rounds at a time. Food, water and rations had to be used very sparingly, until the supply was replenished.

The Parsi Battalion was actually the first among British forces to get THE LITTLE WILLIE, which was a "Mobile Fortress", an early version of a battle tank; so the Parsi Battalion soldiers became early pioneers of battle tank warfare.

The first tank was named "Little Willie" and it had a top speed of just 3 MPH. Tanks received their name because the British tried to conceal their identity by calling them water storage tanks, hence the name "tank". They originally were also called "landships."

Among the many inventions during WW I was the metal helmet. It was introduced by the French in 1915. All sides soon wore a metal helmet, and once again The Parsi Battalion was the first to be given the metal helmet by the British Army.

The Western Front, which ran from the English Channel in France all the way to Switzerland, had over 25,000 miles of dug trenches, of which many battle front forward-most trenches were occupied and held by the Parsi Battalion due to their fire power. The Parsi Battalion, immediately after their arrival in France, became involved in the thick of the battle in launching the initial front line attack against the Germans during the fierce Battle of the Somme in July 1916, with 19 of its soldiers killed in that initial action.

To join The Parsi Battalion one had to be at least 18 years old, but some Parsi boys lied about their true ages to enroll, and some were known to be as young as 16 years old when they joined the force.
