WAKE UP PARSIS. FILE YOUR OBJECTIONS/SUGGESTIONS TO BPP's ELECTION SCHEME BY 01-02-2022

In last week's Public Junction of 16-01-2022, we had published the Public Notice issued by BPP as per the High Court's direction, calling for Objections/ Suggestions from the Parsi/Irani community members to the amendments of the Election Scheme of Trustees of the BPP proposed by the present three Majority Trustees—Armaity Tirandaz, Viraf Mehta and Xerxes Dastur only on a very limited aspect of the term of a Trustee and the number of terms so as to get a very fast approval of the Chamber Judge to it.

But now that the Division Bench of HH Justices Kathawalla and Jadhav has taken over the Petition for Scheme amendment under its umbrella, the amendment of the election scheme will be approved within a month or two or even less knowing the speed at which they decide matters. Hence any community member if he has suggestion how to improve the working of the BPP to make it more favorable to its beneficiaries than now is the best time to suggest such community friendly measures to the Division Bench for the larger good of the community.

The Public Notice, which is published again in this issue of Parsi Junction after this write up, talks of the Misc. Petition of the scheme amendment being available on paying Rs. 100/ for it.

Order dated 12th January 2022, finalised after 7 hearings in the matter of Interim Application (L) No. 29161of 2021 in Appeal (L) No. 29157 of 2021 in Misc. Petition (L) No. 7007 of 2021 between 7th January 2022 and 12th January 2022 has also been published on page 8 in last issue of Parsi Junction of 16th January 2022 for any required reference.

Of course the two dissenting Trustees-Kersi Randeria and Noshir Dadrawala initially did not support this amendment and before the Chamber Judge with whom the matter was initially lodged they sought time to file their say/objection to the scheme amendment reducing the term to 5 years from 7 years and the total terms to two from three and thus effectively reducing the total term from 21 years to only 10 years.

Thus though t Consent Terms dated 20th October 2021 were signed by all five Trustees, no doubt

under duress and blackmail due to compassion for Noshir Dadrawala, specifically mentioned amendment of Election Scheme as above but knowing full well that they had no intention to reduce the term of office and hence no intention to honor all the terms of the Consent Terms dated 20th October 2022, except those that they found favorable to themselves.

Even before the Division Bench the two dissenting Trustees argued against the proposed terms of reduction of term of office and wanted elections to be held immediately irrespective whether the election scheme was amended or not. However the Hon'ble Justices were very clear that election could be held only after the Election Scheme is amended as desired by the Majority Trustees—Armaity Tirandaz, Viraf Mehta and Xerxes Dastur.

But the dissenting Trustees were adamant and it was only after 7 hearings in five days that ultimately they agreed to the suggestion of the Hon'ble Justices after which the Public Notice to be published in Parsi press on 16th January 2022 was ultimately finalized.

Since this victory has been a hard fought one it is incumbent on all affected community members to give their suggestions as to how to ensure that only the best Trustees are elected to the apex Trust of the community for the larger good of the beneficiaries.

The earlier Board under the leadership of Dinshaw Mehta had increased the funds available with BPP from a meager Rs. 16 crores in 1994 to well over Rs. 250 crores in 2013.

However in 2013 when a Dadi House flat was transferred to some Muslims, Yazdi Desai who was waiting to get revenge for the loss of his wife to Dinshaw Mehta supported candidate Muncherji Cama filed a criminal complaint to EOW, Crime Branch in November 2013 that out of transfer fees of Rs. 65 lakhs for a Dadi House flat, only Rs. 45 lakhs were received by BPP and Rs. 20 lakhs were misappropriated by then Chairman, Dinshaw Mehta.

EOW in December 2013 gave an all clear to Dinshaw Mehta on ground that transfer fees were only Rs. 45lakhs and not Rs. 65 lakhs as alleged and disposed off the false complaint filed by Yazdi Desai, Arnavaz Mistry, Khojeste Mistry and Jimmy Mistry as false.

Being frustrated by the EOW Order, the four of them then persuaded Khojeste Mistry to file another false complaint in January 2014 before the Additional Metropolitan Magistrate's Court at Ballad Estate on the same charge of misappropriation of Rs. 20 Lakhs out of Rs. 65 lakhs transfer fees for a Dadi House flat. The Court issued summons to MRA Marg police to investigate the complaint and report.

After extensive investigation, Mra Marg police gave its report in May 2015 clearing Dinshaw Mehta and holding that transfer fees of the flat were Rs. 45 lakhs and not Rs. 65 lakhs as falsely alleged. However Kojeste Mistry did not accept the police investigation and wanted reinvestigation of the complaint.

In October 2015 fresh elections were held when Kersi Randeria, another old enemy of Dinshaw Mehta got elected. In 2016, Yazdi Desai and Kersi Randeria called the Muslim tenant Musharaf Kader to the Writer Corporation office at Byculla and not to BPP office and threatened him to give false Affidavit or they would close down their Guest House business.

Musharaf convinced them that transfer fees were indeed Rs. 45 Lakhs but under blackmail threat he gave a revised Affidavit in 2016 which matter is pending in Court being sub-judice.

However the Trustees unanimously now accepted that transfer fees were Rs. 45 lakhs and never Rs. 65 lakhs as falsely charged. Based on this the Trustees gave Musharraf a signed Resolution in June/July 2016 transferring the flat to his name and issued rent receipt of Dadi House flat in his name.

Thus the charge of misappropriation of Rs. 20 lakhs out of alleged Rs. 65 lakhs transfer fees is now proved false in 2016 itself by all the seven Trustees but not a single trustee nor Yazdi Desai nor his wife nor the self proclaimed religious leader Khojeste Mistry nor self proclaimed social worker Arnavaz Mistry nor self proclaimed Mobed savior Jimmy Mistry nor the self proclaimed righteous Noshir Dadrawala have had the decency or courage to own up their mistake and apologize to Dinshaw Mehta till date.

However from 2013, Yazdi Desai along with his majority Trustees started ruling the BPP as the defacto Chairman and he moved the Charity Commissioner to bring all transfers and allotments of flats to a grinding halt till the new Trustees were elected in October 2015. Since over a hundred flats were available from the earlier Board they started allotting them free to their friends and relatives including high value flats to the detriment of the Trust.

Thus from November 2013 till date the Majority Trustees led by defacto Chairman Kersi Randeria, Yazdi Desai, Zarir Bhathena and Noshir Dadrawala brought BPP to the verge of bankruptcy from which they can recover only if those opposed to encashing the value of Tenanted high value flat are removed.

It is under these circumstances that it is important that community members now take this opportunity given by the Division Bench to amend the Scheme for Election of Trustees to ensure that good honest and law abiding Trustees are elected by the community and not Slum Developers who suck the blood of slum dwellers by not paying their transit rent of over Rs. 10 crores or refusing to pay Interest for 7 years on Rs. 35 lakhs taken from Vikram Jagdale in 2015 unless he gives Affidavit blaming Dinshaw Mehta as the Instigator.

This is besides the lakhs of bpp funds squandered in needless litigation or giving flats worth Rs. 50 lakhs to his partners nephew for a measly Rs. 8 lakhs or Editor of his paper Khol bol first after lying to the Board a flat and thereafter promising Rs 40 lakhs for it which even after three years remains to be paid or transferring his mama's flat in Contractor Bldg., Byculla to his mothers name wellhoused with him in Dadar Parsi Colony.

Hence we once again call upon all concerned Parsis to wake up and ensure that such terms are proposed to the Division Bench as amendments to the Trustees Election Scheme which will ensure that only good hearted, kind and knowledgeable Trustees are elected to serve our community especially at present when the earlier Majority Trustees drove BPP to bankruptcy.

This is the last chance to bring back our community to the Zenith it once enjoyed during the times of our forefathers or our community is doomed to go into oblivion if we do not act now before it is too late.

We are reproducing in the next page the said Public Notice calling for Suggestions/Objections to the proposed amendments of the Election Scheme.

All the Members of the Parsee/Irani Zoroastrian Community are hereby informed that the Petitioner Trustees of the BPP, Bombay, have jointly filed the above Miscellaneous Petition for sanction of proposed amendments to the Scheme for the Election of the Trustees of BPP. Respondent Nos. 2 and 3 Trustees have informed the Hon'ble Bombay High Court that they do not have any objection to the proposed amendments to the Scheme for the Election of the Trustees of BPP being permitted by the Hon'ble Court.

A gist the proposed amendments are as follows:-

- (a) Limiting term of office of a Trustee to five years and to provide that a person cannot be a Trustee for more than an aggregate period of ten years during his lifetime.
- (b) Such other consequential amendments as are necessitated by the above amendments.

The proposed amendments to the Scheme are as follows:

1.DEFINITIONS

- a. "Term" means a period of five (5) years from the date on which a Trustee assumes office (it is clarified that any time lost between the date on which the Trustee is declared elected and the date on which he assumes office due to any reason whatsoever including any court order will not be excluded in computing such period of five (5) years).
- b. "Term Limit" means any two Terms, with or without hiatus, that is, no Parsi can be a Trustee for more than an aggregate period of ten years, during his lifetime. Provided however, notwithstanding anything contained herein, every Parsi who was elected as a Trustee for the first time during his lifetime, anytime after 5.4.2007

(that is, the Effective Date under the present Scheme) but before 18.10.2015, shall be entitled to one further Term of five (5) years; irrespective of the period he has already been a Trustee.

- 2.1A Trustee will occupy office for the Term, subject however to the Term Limit.
- 2.2 Rule 13 of the Scheme stands deleted.
- 2.3 Rule 24 (b) of the Scheme stands deleted.
- 2.4 In Rule 25, the word 'seven' shall be substituted by 'five'.

3.TRANSITIONAL PROVISIONS

Notwithstanding anything contained herein, this Scheme, when sanctioned by the High Court, Bombay, will apply to a Trustee elected at any Election held after 1st January 2022 (irrespective of the Effective Date being later), so far as it relates to the Term / Term Limit of such Trustee.

The above Petition has been peremptorily fixed for hearing before the Division Bench of the Bombay High Court comprising of Hon'ble Justice Mr. S. J. Kathawala and Hon'ble Justice Mr. M. Jadhav on February 1, 2021 by way of video conferencing or physical hearing or hybrid as per the SOPs prevalent on the date. A link to attend the VC/hybrid hearing will be available on the website of the Bombay High Court (www.bombayhighcourt.nic.in).

Any member of the community who desires to be heard in respect of the proposed amendments to the Election Scheme, may be heard thereon either in person or through a duly appointed Counsel / Advocate before the Honourable High Court.

Last week saw what independent media can do! BBC World News fiercely followed up and reported the British Prime Minister's misdemeanor in attending a Christmas Party in his back yard in December 2020 while the country and the people faced a lockdown. The PM ultimately had

to apologise to his people and parliament on live television and is now likely to resign in the face of strong demand from the opposition in the British parliament!

BBC and other media did not spare even the British monarchy and reported factually. Prince Andrew was stripped of his titles and other royal duties after a Court in the US ruled that he must face the civil suit filed by a woman who allegedly was the victim of sexual assaults by the prince when she was a minor. Due to these revelations, the Prince will now face the civil suit as an ordinary citizen would.

Lastly, Novak Djokovic, who managed to obtain a visa without being vaccinated has now faced the cancellation of his visa and has been deported. The decision to grant Djokovic a visa was hugely controversial with the Australian

"No tennis player is bigger than a tournament," his coach Becker told BBC Sport. "We have to concentrate, as sportsmen or women, back on the action on the court, not what's happening in the court of justice.


A number of players have been critical of Djokovic, with Greek fourth seed Stefanos Tsitsipas saying he had **made vaccinated players "look like fools".**

This was following the Bharucha Baug residents request to their MLA/Corporator to repair and pave their roads.

After all BMC was using the money collected from the residents of their Ward through Property Tax to

disburse back to the residents of their Ward and hence they were entitled to its use like all other voters in their Ward.


It is time that all BPP colonies took advantage of these funds specially reserved for the voters/residents of their ward so that the burden on the colony residents as well as BPP is reduced thereby. We now understand that JERBAI BAUG ASSOCIATION through its President Mr. Sharukh Wadia and other office bearers had approached their local MLA Ms Yamini Yashwant Jadhav for help by funding the repairs of the internal roads to ensure that the tenants are not inconvenienced or hurt due to the dilapidated condition of the internal roads.

Having received a positive response from the MLA, the Office bearers of the Jerbai Baug Association had recently approached the Trustees for their permission to carry out repairs to their internal roads through MLA funds.

We hope permission will be promptly given by the Trustees without any procrastination as Elections are shortly due and before code prohibiting such activity comes into play.

We recollect that about 15 years back the roads were repaired through the funds of then Congress MLA Madhu Chavan through the good offices of then Chairman, Dinshaw Mehta who was consulted by Madhu Chavan about it.

AN UNFORTUNATE INCIDENT AT BHARUCHA BAUG



We have been informed though belatedly of a very sad and unfortunate incident that took place on the morning of 6th Jan 2022 in Bharucha Baug.

One of the senior resident of M-Block was advised to be hospitalized by his doctor for Covid treatment.

The ambulance was unable to reach his building as the road is very narrow due to vehicles parked on one side and large footpaths on the other side, so that any large vehicles like an ambulance, hearse or fire brigade cannot enter the lane and reach the inner buildings.

Hence the patient had to walk all the way to the parked ambulance on the corner of the main road.

Similar incidents have taken place in the past ambulance or a fire brigade to pass through. The footpaths adjacent to the buildings are too wide and not used by pedestrians but we are informed that





ground floor residents have occupied the footpaths by placing flower pots and having a private garden.

Over time the traffic has increased ten fold.

The residents have therefore requested the Trustees through the Bharucha Baug Welfare Association led by Vispi Irani to reduce the footpath width to about 2.5 feet to 3 feet so as to increase the size of the roads, so that large vehicles can ply-through with ease in order to help any tenant who would require these emergency vehicles in these Covid pandemic times.

Whilst we sympathise with the affected residents it would be in the interest of the Trustees to first find out the views of the affected ground residents to avoid being dragged into a needless controversy between two factions. Only after getting NOC from all affected tenants should the work commence to reduce the width of the footpath.

Further since elections are due any time it would be in our interest to take the help of the local MLA/ Corporator and get work done from use of his funds.

If this is not feasible than the Trustees should bear only 50% cost and the other 50% should be contributed by all the residents of buildings on both sides so that it becomes a fulfilling venture with contribution from all.

On the upside NIFTY will find it difficult to surpass 18100 and now the downside has opened up to levels of 16830 where the next support comes in. So expect the NIFTY to show further weakness especially with foreign institutions being on the sell side almost through the Last week. I expect them to be on the sell side even in the coming week.

Now lets come to our weekly call:

Divi's lab was given to buy at 4613 for tgts of 4750 levels. Divi's showed a high of 4668 thats about 1% returns for the week before selling off with the general market trend.

Our sell call on Axis Bank at 721 showed a low of 708 giving about 2% returns.

The coming week is going to be a challenging week for any buy calls because of the expected weakness but I will still give one quality stock where one can expect some upside for the week and my stock buy call for the week is Hindustan Unilever at cmp 2331. Even someone with a long term horizon can add HUL at every decline from current levels.

Our long term investment call will be on Coal India at cmp 158. Coal India is trading at a dividend yield of almost 10% so its a good attractive long term investment call even in this weak markets.

My sell call for the week will be on RBL Bank at cmp 148 for downside tgt of 141 for the week.


