Dear Sir,

Season's greetings and Best wishes for a Happy and healthy 2022 and with a prayer for those who have lost their loved ones!

On December 27, 2020 I wrote in Parsi Junction "Bye Bye 2020, Covid 19 and the virus affecting the country and the BPP, and welcome the Vaccine and 2021!"

With the Vaccine on the scene there was Globally a sigh of relief and we all felt that the worst was over. The world believed the pandemic had at last ended!

However in the BPP in Mumbai, the "Majority" v/s the "Minority" virus continued unabated! The situation here reminds one of the famous soliloquy from Shakespeare's Hamlet "To be or not to be? That is the question--". For the Parsi Irani community the question was **"To elect or not to elect trustees mid term?"**

The year began with a trustee of the **erstwhile** 'Majority', the defacto Chairman who ruled the BPP for over five long years from October 2015, who saw a ray of hope to regain his Majority status, insisting that elections be held immediately to fill in two vacancies caused by the untimely death of his erstwhile supporter, the late Zarir Bhathena, and the vacancy caused by the resignation of the then Chairman Yazdi Desai who had to resign due to his continuing ill health, which many believed was due to the stress and tension created by this very trustee.

carrying his resignation letter in his pocket at all times very much like a former Prime Minister of our country! And rightly known as the Pendulum of the community.

Unfortunately for these two and their destinies, even God and nature appear to have worked against them: From the word go the Virus raised it's head again and this time with greater fury than in the previous year and the elections were postponed at every attempt.

ONE MORE BPP COLONY TAKES ADVANTAGE OF CORPORATOR/MLA FUNDS FOR ITS INFRASTRUCTURE

Recenty Bharucha Baug at Andheri had requested the Politicians of their Ward to repair and pave their roads by use of Corporator/MLA Funds available for amenities for use of public/voters/ residents of their Ward. After all BMC was using the money collected from the residents of their Ward through Property Tax to disburse back to the residents of their Ward and hence they were entitled to its use like all other voters in their Ward.

Dhunbai Wadi taking heart for using Corporator/ MLA funds to improve its own infrastructure of their colony have written to their Corporator for funds to repair and pave the internal roads of their colony.

It is time that all BPP colonies took advantage of these funds specially reserved for the voters/ residents of their ward so that the burden on the colony residents as well as BPP is reduced thereby.

AFTER TRUSTEES, INFIGHTING NOW AFFLICTS NOWROZ BAUG RESIDENTS



We are disheartened to start the New Year of 2022 with Bad News, but in keeping with our commitment to inform true news to our community, along with increasing cases of Covid and Omicron likely to affect the Seniors comprising 70% of our community, the backtracking of Noshir Dadrawala and Kersi Randeria from their solemn commitment obtained by their blackmailing antics of signed Consent Terms of 20th October 2021 to

amend the Election Scheme to reduce the term of office of Trustees, their refusal to combine the March 2022 elections with the September 2022 elections to save Rs. 40 lakhs of cash starved BPP funds, we now have to inform the community of the bitter infighting affecting Nowroz Baug residents since last three months.

The rot started with Godrej Baug where duly elected Managing Committee member, Tehmtan Dumasia of Godrej Baug Residents Welfare Association (GBRWA) made charges on the other Managing Committee members receiving illegal payments by cheques which was partly repaid by cash back to the Association. He moved the Charity Commissioner for detailed inquiry when it was disclosed that GBRWA was de-registered about two years back and their application for re-registration was pending. Dumasia has made charges of GBRWA of illegally collecting funds though it had no authority to do so. The matter is being heard by the CC and his findings are awaited.

Then we Bharucha Baug Welfare Association combining the two Associations of Multi Storey building with the residents Association but the partnership lasted just a few months and we saw the President Mr. Karkaria resigning in disgust and disarray among the two factions. We hope it will be resolved soon and the Association will start functioning as one unit for the whole Barucha Baug or if they prefer to work for their domain only then the work of garden, internal roads, water supply should be looked after as one unit.

But Nowroz Baug which was a beacon for all Baugs whose maintenance and Development Committee was set up by the real Hero of Nowroz Baug, Nariman Mehta, is being maligned by a few disgruntled residents who owe allegiance it is alleged with the Trustee in waiting Anahita Yazdi Desai.

Nowroz Baug Maintenance and Development Committee (NBMD) comprises of Gayomard Kathawala, Jal Adajania, Hormuz Mehta, Chairman Emirutus Nariman Mehta, Yasmin Amrolia, Farzana Doctor and P. S. Jasawala. This paper is well aware of the integrity and honesty of all the members and can vouch for all of them. In fact the Mehta brothers—Rohinton and Hormuz—as Builders and Developers have done and completed several projects in Nowroz Baug with their own funds, expertise and their own labour than even the Wadia Committee of Management has done for Nowroz Baug.

With such an impeccable committee, it is shocking to learn of charges of embezzlement of reimbursement cheques issued personally to Kathawalla by Percy Sigantoria of Wadia Committee made by Bahadur Sanjana, D. Mohta, Nozer Sutaria, Hoshang Nekoo, Anahita Irani, Nowroze Mamlatdar and Hoshang Medhora along with several other charges.

The term of the present committee of NBMD ended in 2020 but due to Covid lock down status quo was maintained. They all now want to go **“because of the inhuman behavior, the uncouth language, the bricks and bats we had to face from a miniscule of tenants who were all led by a mindless head.”**

If good people back down from their responsibility than second class residents will take over to the detriment of all the residents of Nowroz Baug. Perhaps that is exactly what they want!

One more advise to the Committee. The Rs 35 lakhs corpus left with your committee, if you do not want to continue, should not be handed over to the Charity Commissioner but handed over to the BPP or kept as corpus for the committee.

We give below the letter dated 22nd November 2021 written by the NBMD to the tenants of Nowroz Baug on the charges levied by a few disgruntled residents:

Dear Tenants,

WE, the present Committee Members of the NOWROZE BAUG MAINTENANCE & DEVELOPMENT COMMITTEE, will take our last bow by the close of 2021, (or latest by early 2022). Notwithstanding that 90% of the tenants who will clap and say "once more" we individually and collectively have decided on "no more". This is because of the inhuman ^{behaviour} ~~behaviour~~ the uncouth language, the bricks and bats that we had to face from a miniscule of tenants who were all led by a mindless head.

Our term/tenure ended in 2020. But because of the lock down we had to comply with the official instructions of status quo.

In 2020 we put a notice for election of the new committee, and the response/Applications that we received for the same was one. Once again in 2021, for the Second time, we put up a notice for the election of a new committee, and the response / Applications that we received for the same was two candidates. We are not in a position to fathom the reason for the same, when all along the people who were sitting on the rear seat of the vehicle, were instructing us on how to drive, now prefer to walk away when the driver's seat is offered to them. Be as it may, the tenants,

either under a threat or a brain wash, ^{by the} mindless head, have refused to put in their Applications/ Nominations for future Committee Membership.

Friends, with this as the back ground, we have decided to extend the date of fresh acceptance of forms/ Applications/ Nominations to December 15, 2021. If we fail to get a minimum of 10 Applications for election of block representatives we will have to go the legal way.

WHAT IS THE LEGAL WAY :

- i. The NOWROZE BAUG MAINTENANCE & DEVELOPMENT COMMITTEE will be DISSOLVED.
- ii. After re-distribution to the tenants of their building repair and infrastructure contribution towards maintenance, we have a corpus of Rs.35,00,000/- (Thirty Five Lakhs), left with us comprising donation towards infrastructure.
- iii. The resolution of dissolution of the Committee together with corpus Rs.35,00,000/- (Thirty Five Lakhs) WILL BE HANDED OVER TO THE CHARITY COMMISSIONER.

IMPLICATIONS

Friends, it is OUR money which law enjoins has TO FINALLY BE IN CUSTODY OF THE Charity Commissioner, who is the ex-officio Chairman of all trusts registered with the Charity Commissioner IS THAT A BECOMING PROPOSAL ? WHICH DO



YOU THINK IS A BETTER OPTION – OUR MONEY TO BE HANDED OVER TO THE CHARITY COMMISSIONER OR OUR MONEY LYING SAFE WITH OUR NEWLY APPOINTED COMMITTEE MEMBERS WHO ARE OUR VERY OWN – OUR TENANTS ONLY.

THINK : And if you feel that our money should be in the custody of our own tenants and our own elected members THEN stand for elections – we all will select or elect them, but we the tenants will not reject them. Therefore, we have to save ourselves from the charters of the Charity Commissioner or An Administrator dictating terms and it is for you to select which of the two options is a lesser evil.

REMEDY

- I. Put in your candidature for the post of committee member of the NOWROZE BAUG MAINTENANCE & DEVELOPMENT COMMITTEE.
- II. We the present members, will most certainly be your pillars. You may safely lean on us for all guidance / directions.
- III. We belong to the same baug – then why be divided amongst ourselves.
- IV. Remember - A HOUSE DIVIDED AMONGST ITSELF CANNOT STAND. We have stood together for 110 years. WE WILL STAND TOGETHER FOR decades more.



V. Therefore ACT, for it is going to be NOW OR NEVER.

At the finale, we thank all our Nowroze Baug Tenants for the love, admiration and cooperation that you have extended to us we have worked in partnership ever – always. If we (the committee) have succeeded it is because of the co-operation of the tenants of Nowroze Baug, as a community. We, therefore, invite you to start writing a new chapter in the history of NOWROZE BAUG.

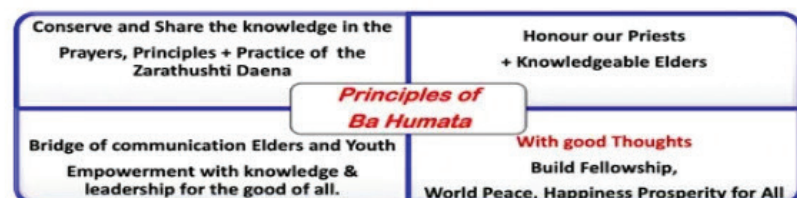
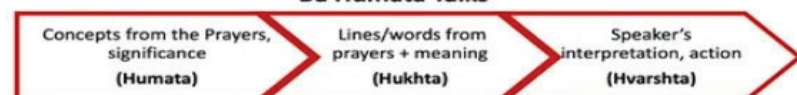

1. Don't call someone more than twice continuously. If they don't pick up your call, presume they have something important to attend to;
