In supersession of the Public Notice dated 22nd January 2022, and pursuant to the Orders of this Hon'ble Court dated 1st February and 3rdFebruary, 2022 all members of the Parsee/Irani Zoroastrian Community are hereby informed that the Petitioner and Respondent Trustees of the BPP, Bombay, have proposed further amendments to the Scheme for the Election of the Trustees of BPP, in addition to amendments notified in the Public Notice dated 22nd January 2022.

Accordingly, the Bombay High Court, by its order dated 4th February 2022, has directed a fresh public notice to be re-issued.

The following is a gist of the proposed main and substantive amendments to the Scheme proposed by the Trustees:

1. A detailed election Code of Conduct (CoC) will be mandatorily applicable to all Trustee elections;

its material breach may result in disqualification of a candidate / trustee. A copy of the CoC is annexed to the link below.

- 2. Election security deposit amount increased to Rs. 25,000/-. Any candidate that fails to secure 10% of the valid votes cast at such election shall have his Deposit forfeited.
- 3. The minimum age to stand as Trustee has been increased to 30 years.
- 4. The High Court to appoint an independent Election Commissioner and five Assistant Election Commissioners, for each election to oversee, supervise, conduct, and decide all matters, relating to a Trustee election, , whose term will expire 6 months after the completion of the election process. The Election Commissioners shall follow principles of natural justice.
- (EVM) having a paper trail (VVPAT machines)*

 [*Chairperson Mrs. Tirandaz and Trustee Mr. Viraf Mehta are not in agreement with the above and have proposed elections by paper secret ballot

Voting shall be done by Electronic Voting Machines

6. Definition of a "Parsi" subject to any decision of the Supreme Court of India, means:

with counting directly at each center]

- (i) a Parsi descended from the original Persian emigrants and born of both Zoroastrian parents, professing the Zoroastrian-religion;
- (ii) an Irani from Iran, professing the Zoroastrian religion, coming to India either temporarily or permanently;
- (iii) a child of Parsi father by alien mother, duly admitted to the Zoroastrian religion.
- 7. Term of office of a Trustee shall be 5 (five) years; and no Parsi can be a Trustee for more than 10 years, during his lifetime. This is a Term Limit. A Trustee, elected at a mid-term election, will hold office for the remaining term of the Trustee whose vacancy, resulted in such mid-term election. The period served by a Trustee elected to fill in a mid-term vacancy will constitute one (1) Term However, if any mid-term election is to be held in the last 12 months of the term than the candidate elected will have the option of two more full five-year terms and this short period served will not constitute one (1) Term.

- Eligibility criteria to be a Trustee includesthat he must be a (a) citizen of India and (b) resident of India.
- Resignation of a Trustee, once received, cannot be withdrawn, by him.
- 10. Trustees may, unanimously, appoint any qualified person as an independent external advisor, to advise the Trustees.
- 11. Amendments to the Scheme may be proposed either by the Trustees or upon a requisition signed by at least 1000 Parsis.
- 12. Only donors giving a donation of Rs. 10 lakhsor more to be admitted to the Donor Register and such Donors will have one (1) vote that will be counted as two (2) votes at any election. Persons whose names are on the Donor Register will continue to exercise the right of one (1) vote that will be counted as two (2) votes.
- 13. All decisions for alienation of immovable property will be taken by a simple majority of Trustees and will require permissions of the Charity Commissioner. By way of additional safeguards, if permission of the Charity Commissioner is granted, the same will not be acted upon for 4 weeks to enable any aggrieved person having locus standi to challenge the same. Decisions to alienate immovable property will also be advertised in Parsi Media so as to enable members of the community to object before the Charity
- 14. Trustees will be required to take important decisions such as removing persons from the Register or holding that a Trustee has vacated office by following principles of natural justice.
- 15. Trustees of the BPP who by virtue of such position are appointed ex officio trustees of any other Parsi trust will automatically vacate that position if they cease to be trustees of the BPP.
- 16. Unless it is not possible, the venues of the elections shall be:
 - (a) CusrowBaug
 - (b) Kharegat Colony
 - (c) Rustom Baug
 - (d) Dadar Parsi Colony
 - (e) Bharucha Baug
- 17. The candidature form will mandatorily require the following details to be provided by the candidate:
 - (a) Name of the candidate;
 - (b) The names and signatures of the proposer and seconder of such candidate;
 - (c) Biodata of the candidate;
 - (d) Signature of the candidate before a Notary Public;
 - (e) Any pending disputes with the Trust (which, it is clarified, is not a circumstance of ineligibility

or disqualification from contesting elections)

- The counting of all votes cast shall be undertaken immediately after the election and shall be completed on the same date. The result of the Election will also be declared on the same day. The votes from each voting centre will be counted at that respective centre by an Election Commissioner in the presence of the candidate or his/her representatives.
- 19. All costs of litigation for disputes among and between (inter se) the Trustees shall be borne by the Trustees and not by the Trust, subject to orders of the Court.
- 20. Such other consequential amendments as are necessitated by the above amendments.

The above Petition has been peremptorily fixed for hearing before the Division Bench of the Bombay High Court comprising of Hon'ble Justice Mr. S. J. Kathawalla and Hon'ble Justice Mr. M. Jadhav on February 22nd, 2022 by way of video conferencing or physical hearing or hybrid as per the SOPs prevalent on such date. A link to attend the VC/hybrid hearing will be available on the website of the Bombay High Court (www.bombayhighcourt.nic.in).

Any member of the community who desires to be heard in respect of the proposed amendments to the Election Scheme, may be heard thereon either in person or through a duly appointed Counsel/Advocate before the Hon'ble High Court after filing a statement in writing and signed or an affidavit setting out his/her views and objections, if any. Such application / affidavit shall be filed with DSK Legal, either in writing or by email, whose details are given below. The affidavit / application must include the name and the complete contact details of the applicant. All such applicants need to be present for the hearing either in person or through a duly appointed counsel / advocate, failing which their objections will not be considered.

COMMENTS ON THE ELECTION SCHEME ONGOING BEFORE THE HIGH COURT

As the community is aware the election scheme is going on before the Division Bench of the High Court led by His Honors Justice Kathawalla and Justice Jadhav and WhatsApp is replete with comments on its progress.

Some comments made on Facebook of Parsiana and Jame Jamshed are worth reproducing and the very first comment was made by Advocate Sarosh Zaiwalla.

Comments of Sarosh Zaiwalla

The Parsi Community is facing an existinal threat at the hands of a proposed scheme, put forward by Mr. Darayus Khambhatta and Burjes Desai for election of Trustees of the Bombay Parsi Panchayat as filed by them in the Hon'ble High Court.

The Most dangerous part of the proposed scheme is Para 14.6, where a blank cheque has been given to the Trustees to sell the Trust Property, or dealing with immovable property and liquidate the same by what the Authors have said "Simple Majority of the Trustees." and further declared that the said decision of Alienation, will be legally binding upon any dissident Trustees.

The insertion of a such a clause 14.6, under the guise of proposed election scheme, is a camouflage attempt to alienate all the Trust Properties of the Bombay Parsi Panchayat, including our Fire Temple, Doongerwadi, Sanatorium and every other property wherever situated, and is not only illegal but violative of the Constitution of India, and the Fundamental Rights gauranteed to all religious denomination including the Parsi Community, to manage its own affairs, in the matter of religion and religious properties and hence such a proposed scheme is void ab initio and the Learned Advocates have misapplied their mind and have attempted by impugned action to wipe out the Parsi Community, maybe to please some parties wherever they are.

Even more shocking has by its very first paragraph of the scheme defined Parsis in a novel method by stating in Para 1 (k)

"Parsi means a Parsi (including an Irani Parsi) whether male or female of the age of 18 years or upwards professing the Zorastrian faith and who shall, if so required by the Trustees, have filed in the Office of the Trust an affadavit in such form as may be prescribed or required by the Trustees that such male or female as the case may be, has not renounced Zorastrian faith, whether by reason of marriage to a non Zorastrian spouse or

otherwise, and continues to profess Zorastrian faith."

The above definition, by play of Words cleverly avoids the definition of who is a 'Parsi' as per the Judgment of the Bombay High Court as pronounced by "Justice Davar and Justice Beamon", as stated herein below.

It is now clear as a daylight that the intentions of the Draftees of the Proposed scheme is to change the very definition of the word Parsi, by declaring that such male or female has not renounced the Zoroastrian faith, whether by reason of a Marriage to a non Zoroastrian spouse and continues to profess Zoroastrian faith. This very definition is perverse and an illegal attempt to change the very definition of the word Parsi as laid down by the Bombay High Court in the case of Petit versus Jeejeebhoy, where the Learned Eminent Judges, being Justice Davar and Justice Beamon has defined Parsis as person born of both Parsi Parents, or one whose father is a Parsi, and includes the Zoroastrians who have migrated from Iran.

To change this definition under the guise of a proposed amendment to the scheme, not only betrays disrespect to the High Court, whose findings have been followed by Hon'ble Supreme Court and Other High Courts of India in the past, but is also an attempt to shake up the very foundation of Parsi Zoroastrian Community in India as it existed for over 1200 years.

Further the proposed scheme created by Darius Khambhatta and Berjes Desai at para 11 of the scheme has attempted to create "Power to Co-opt any Parsi as a Trustee, where vacancy has occurred and has declared such trustees will have the same right and obligations as a Trustee duly elected under the Scheme".

In other words it amounts to granting powers to the Trustees to bring in by back door, any person as they please, without elections as a full fledge BPP Trustee, which clearly betrays that fact the Learned Advocates is attempting to override the views of the electorate to bring in person of their choice as Trustees.

The proposed scheme put forward by Darius Khambhatta and Berjes Desai is illegal and violative of the Fundamental Rights gauranteed by Constitution of India, by what could be called Back Door entry to subvert the BPP Trust from within.

BPP election scheme to be readied

Amendments to the Bombay Parsi Punchayet (BPP) election scheme should be put before a division bench of Bombay High Court Justices Sharukh Kathawalla and Milind Jadvav on Thursday, February 3.

The decision followed a two and a half hour hearing on February 1 between the Justices, intervenors, sitting trustees Noshir Dadrawala and Kersi Randeria, several lawyers representing the various parties, two lawyers instrumental in drawing up the amendments, Darius Khambata and Berjis Desai and an amicus curiae, Sharan Jagtiani. Two other BPP trustees, chairwoman Armaity Tirandaz and Viraf Mehta joined in briefly when Kathawalla wanted their consent to the amendments.

After hearing the various legal arguments put forth, it was decided that the proposed amendments should be put forward by a majority of the BPP trustees to avoid any legal complications later. When universal adult franchise had been mooted around 15 years ago, the BPP trustees had unanimously agreed to move the Court for the historic change, noted Kathawalla.

The two counsels for the five trustees, Karl Tamboly and Firoz Bharucha, and four of the trustees themselves gave their assent subject to certain modifications in the proposals. These will be incorporated as required. Once the scheme is drawn up, advertisements will be placed in two publications, probably this weekend, inviting objections to the modified scheme. A fixed time frame will be stipulated to avoid any party trying to indefinitely delay the election process.

After that a date for the elections will be fixed by the Court.

One crore rupees election corpus

A one crore rupee (USD 133,877) election corpus will be donated to the Bombay Parsi Punchayet (BPP) by jurists Darius Khambata and Berjis Desai, the Bombay High Court was told by Desai this Friday morning, February 4. A division bench of Justices Sharukh Kathawalla and Milind Jadhav were hearing virtually the third day of arguments on the modification/amendments to the BPP election scheme. The hearing in Chambers dragged on for four hours as some points agreed on yesterday were once again gone over as the three majority trustees changed their minds.

They said they were not agreeable to the chairperson losing her/his casting vote should the number of trustees drop below seven. This clause was introduced to avoid midterm elections being held every time a trustee exited from the board.

"If the casting vote remains, then hold midterm elections," to avoid a majority-minority tussle, said Kathawalla.

"Today you are a majority, if tomorrow a minority what will happen? All of you are thinking of yourselves, not the community."

The notice period for holding elections was reverted to 60 days from the 40 or 45 days agreed upon Thursday. The majority trustees who had agreed to EVMs (electronic voting machines) being used once Khambata and Desai stated they would subsidize the additional cost over and above paper ballots, now said they wanted paper ballots for this election. Similarly the trio opposed any upper age limit for holding office.

Kathawalla was annoyed with the BPP's solicitors for writing directly to the amicus curiae, Sharan Jagtiani, instead of the court regarding modifications. "You don't have the guts to address the Court," he commented angrily. The discussions on the code of conduct that went on for two hours decided no freebees were to be given

to voters as an inducement to vote for a particular party or individual. A candidate could spend upto Rs 5,00,000 (USD 6,694) for her/his candidacy. The Parsi Press was instructed not to carry "anything that is defamatory" about a candidate or his family and to shun publishing personal attacks. This applied to online publications as well. Poll Khol, Sacchu Bol editor Kaikhushroo Irani assured the court he would observe the guidelines. When Mehta was initially asked to give an undertaking for Parsi Junction (PJ) he replied, "I have nothing to do with Parsi Junction." He admitted he wrote articles for PJ but they were on issues, not personal attacks. He referred the Court to Kersi Sethna who is the editor of PJ. Sethna was phoned by Kathawalla and an assurance taken from him that he would adhere to the guidelines. "I agree your honor," Sethna replied.

All campaigning has to stop 24 hours before the polling. Kathawalla said CCTVs (closed circuit television cameras) should be installed in all the five polling booths.

Advertisements will be placed in the Parsi Press announcing the scheme and objections invited from community members within 15 days. After hearing the intervenors, the scheme will be finalised and dates announced for the holding of elections.

The Surat Parsi Panchayat matter concerning the last rites (Dokhmenashini) of the Parsi Zoroastrian community was listed in the Hon'ble Supreme Court of India before Hon'ble Dr. Justice D. Y. Chandrachud today.

The Solicitor General of India, Mr. Tushar Mehta mentioned that the stakeholders met as discussed in the previous hearing dated 17.01.2022.

The parties have come to an amicable settlement in this matter. The Union Government has agreed to allow Parsi Zoroastrian community members to conduct last rites of the deceased in the manner of Dokhmenashini with certain conditions.

*The conditions include setting of an iron grill

above the Tower of Silence to make sure birds do not become carriers of the virus which was the main fear of the government. The SOP has been accepted by both the parties.*

The impugned judgment and final order of the Hon'ble Gujarat High Court dated 23.07.2021 is hence set aside by the Hon'ble Supreme Court of India.

The final order shall be out soon.

A million thanks to all those whose took up this matter for the community.

Dokhmenashini for Covid victims

Good news for the community. The petition filed by Surat Parsi Panchayat was taken up by the Hon'ble Supreme Court today. Mr Fali Nariman and Mr Zerick Dastur appeared on behalf of the Petitioners. Mr Tushar Mehta Solicitor General appeared on behalf of the Union of India. It was submitted before the Court that the parties had agreed upon on a standard operating procedure for disposal of parsi covid 19 victims by way of the Dokhmeneshini system. Accordingly the Hon'ble Court was pleased to pass an order allowing Dokhmeneshini system for Parsi Covid victims in terms of the agreed protocol which confirms to the tenets of the Zoroastrian faith and also addresses safety concerns of the Government. The Gujarat High Court Order has accordingly been set aside and the proceedings to be

governed in terms of the agreed protocol.

The news is indeed a positive development for the community where the trustees of the Surat Panchayat, respected High Priest Dasturji Kotwal and the legal team comprising Mr Fali Nariman and Zerick Dastur along with Karanjawalla & Co (the same legal team which represented the community in the Mumbai metro matter) put in efforts together to bring about a successful outcome. They were supported by prayers and good wishes from numerous community members who were concerned and who desired to ensure that Parsi Zoroastrians who succumb to covid get a disposal with dignity and in accordance with their religious traditions.

COVID PROTOCALLS TO BE FOLLOWED

- "1A. Dead bodies of the Parsi Zoroastrians who die of Covid 19 will be brought to the funeral parlour in the Tower of Silence complex and will only be handled by the Nassasalars- (professional Corpse bearers who have been professionally employed by the Panchayats). The corpse bearers are and will continue to be fully vaccinated and their temperatures duly recorded before every funeral and carrying out procedures of handling dead bodies as per existing COVID guidelines.
- 1B. Neither relatives nor friends are permitted nor will be permitted to touch the dead body and it will be ensured that they will always remain beyond 10 feet from the dead body.
- 2. The Nassasalars, at all times, while handling the dead body of the Parsi Zoroastrian COVID-19 victim will wear the PPE kit, gloves, face shield and N 95 mask and the Govt of India regulations pertaining to dead bodies of COVID 19 victims having been read and explained to them and they will be cautioned to follow the directives of the Govt. of India.
- 3. The body of the COVID-19 Parsi victim will be brought by the Nassasalars to the Tower of Silence Complex from mortuary or home in a body bag which will not be opened, but as per existing Guidelines, the face of the deceased will be allowed to be seen from a distance of at least 10 feet by the family only by unzipping the face covering of the body bag.
- 4. The final funeral prayers i.e. the "GehSarna" (or Paidast) ceremony (which is the recitation of the first Gatha handed down by the Prophet Zarathushtra) over the dead body, is and will be by two Parsi Zoroastrian Priests wearing N-95 masks and gloves, who will stand at a distance of 10 feet from the SPACE reserved for the dead body.

The final prayers (which last about 1 hour) will be completed and upon its completion, the Nassasalars will carry the body o the Dokhma (Tower of Silence) where no one except the professionally employed corpse bearers can enter.

As per Parsi religious traditions, no relative can touch, or much less kiss the body and every person at the funeral will perform hand hygiene after the funeral ceremony – a distance of at least 10 feet from the body will always be maintained. The individuals who will transport the dead body are the Parsi Nassasalars (the professional pallbearers) and no one else. Normally two Nassasalars will carry the body (in the body bag) to the Tower of Silence (Dokhma No.3) in a bier.

- 5. Relatives attending the Gehsarna (Paidast) ceremony will wear face masks and follow other guidelines as prescribed by the Government of India and will sit 10 feet away from the dead body and only such number of family members will be permitted to attend the funeral as per the applicable guidelines.
- One Dokhma No. 3 has been set aside for Covid victims alone and used for performing religious ceremonies for dead bodies of Parsis COVID-19 victims. This Dokhma No. 3 will not be used for non-Covid-19 dead bodies.
- 7. Only Dokhma No.3 (in the Tower of Silence) will be used for dead bodies of Parsi Covid victims. And non-Covid victims' bodies will be placed in other Dokhmas i.e Dokhma No.1 and Dokhma No.2. Since the principal mode of disposal at the Tower of Silence is through strong and powerful rays of the Sun, and hence to deal with the problem of birds of prey, the Petitioner undertakes to install as soon as possible, a metallic bird net over Dokhma-No 3 which is exclusively reserved for the dead Parsi COVID-19 victims; this will eliminate contact with birds and animals and will avoid any intrusion by vultures. Hence, there will be no exposure of the body to birds etc. once the metallic net gets installed over Dokhma-No 3.
- Religious rituals such as reading from religious scripts, sprinkling holy water and any other last rites that does not require touching of the body are allowed.
- After each ceremony, the entire funeral area/parlour will be washed, sprayed and disinfected. All PPE suits, masks and face shields will be disposed off and a new set will be used for each COVID-19 victim's funeral ceremony".

UNBELIEVABLE BOMBAY FACTS

Jackal at High Court, Tigers at Malabar Hill, Gowalia Tank, Mazgaon and Mahim

From chronicle: 'Hunting Wild Beasts in Old Bombay'

- 1) The Governor and most of the island's residents, till 1753, went annually to Salsette (Thane district) to hunt the wild boar and Royal Tiger, both of which were found here in great plenty. The tigers also roamed freely on island.
- In 1822, February 9th, a tiger on Malabar Hill came down, quenched his thirst at Gowalia Tank, and ran off over the hill between the Hermitage and Prospect Lodge. Prints of its feet were distinctly visible in the morning.
- 3) In 1828 at Colaba Ferry a huge shark was observed in proximity to some bathers. In 1849, a finback whale was driven on shore at Colaba, 60 feet long, and 30 to 40 feet round the thickest part. All along the road from the Fort to Colaba was a perfect fair. The stench was felt from the town side of the causeway from where it lay at the back of Colaba Church.
- 4) A jackal was killed in the new High Court Buildings shortly after they were finished.
- In 1858, March 3rd, some officers of the P. and 0. Steamer observed a tiger swimming from Mainland to Mazagon. A boat was lowered and the crews armed with ship's muskets were ready. When they came up to it, the brute was boarding a buggalow, and was being kept off by the soldiers by

handspikes. It was shot through the head by six balls. Weight, 353 lbs. Length to tip of tail, 8 ft. 9 inches.

- 6) May 26th 1859 A young Portuguese, shot a tiger at Mahim, and on the 27th, brought the carcass to the Chief Magistrate for the reward. Mr. Forjett, the city Police Chief, shot a tiger within a few hundred yards of the fashionable drive on the Esplanade. Mr. Forjett promised the hide to Dr. Birdwood for the Museum.
- 7) The first observation of a pack of hounds in Bombay was in year 1830, prior to it, the sport was confined to hunting with a "bobbery pack" and to annual "rides" round the island. In 1810, for example, the programme of the ride consisted of breakfast at Malabar Point at 9 am., then a sharp trot to "the Breach," Love Grove and Worli, ending up with tiffin at one o'clock in Mahim college. After tiffin the party rode via Mahim, Sion and Mazagon to Hope Hall, where dinner was served at 6 p.m. The Courier [newspaper] released an advertisement in March, 1811, that "The Picnic meets this morning at gun-fire on the course, where the hounds will throw off. A numerous field and great sport is expected. Afterwards bobbery hunting until breakfast, which has been ordered for fifty at the Stand at 9; the party will then proceed to Lowjee Castle, where various Hindustani gymnastics, pigeon-shooting, tumbling, juggling, etc., will be exhibited till 4, when a dinner in the real English style will be served up for the same number as at breakfast. The sports of the day to conclude with music, fireworks,"

Bombay Fox Hounds.

In 1862, the Bombay Hunt Club was founded.
