### **MESSAGE FROM RUMY ZARIR**

### Dear members of the community

I know how eager our community is to elect a fresh set of Trustees to administrate BPP, and nurse it back to its past glory and to see the community grow and prosper. I also know that my community members look forward to a BPP Board, bringing in positive changes. In that direction, I not only want to see the change but would like to be the change ... be the change for YOU.

I come from an ordinary, middle-class family. We have faced hardships and overcome hurdles every step of the way, and therefore, can relate to the problems faced by many. In spite of several difficulties in the growing years, I have, however, over a period of time, accomplished a lot through hard work and singleminded devotion to the tasks at hand.

If elected, I will assist our community members to the best of my ability, fully understanding their present agony and frustration of having knocked at the BPP doors several times, but to no avail. I will ensure that no one has to wait for long hours outside the BPP office, and everyone will be given a fair chance, in addressing their problems judiciously.

I am an independent thinker, and I will respond to an issue based on the problem of each individual, bearing in mind the larger interest of our community.

I firmly believe that because of any internal clash of ideas or bias, our community should not suffer, and our good intent to serve should not be stalled. I also volunteered, as a social worker, with the Bombay Parsi Panchayat during the pandemic as I wanted to reach out to maximum people. I have gone door to door supplying daily needs to 25- 30 families consistently for months during the peak lockdown period.

I was felicitated with the '100 Most Impactful Corona Warrior Award' by Social Talks in association with Indian Drug Manufacturers' Association (IDMA) for services rendered during the lockdown to the society at large.

Once elected, I will personally devote time to visit our Baugs / Colonies on regular if not monthly basis, to check on any grievances, so that the concerned committee members or tenants do not have to visit the BPP office for small issues. I will be your voice to the Board, to help resolve the issues as I firmly believe that every problem has a solution.

As the Chief Executive Officer of the Zoroastrian Building Fund, my responsibilities in managing matters vary from interfacing with several Government / Municipal agencies and Charity Commissioner's Office, to securing and monitoring the day-today upkeep of the Trust properties spread in different parts of the city.

Having shared my thoughts and approach, I would request my dear community members to give me a chance to serve on our apex body, BPP.

I am at your service today, tomorrow and always. I wish to remain well connected with my dear community members and assure you that I am and shall always be available 24/7.

Last Last week we had stated that the NIFTY will have a range of 17600 on the upside and 16300 on the downside with a bias on the downside. Exactly to our call the NIFTY remained in that range with upsides of 17377 and downside for the week being 16888.

First one was on Canara Bank at 233 levels and it showed a low of 226. Thats about 3% returns for the week. Our second sell call was on Bank of Baroda at 111.5 and that showed a low of 109 which works out to about 2 % returns for the week.

Now lets come to our market call for the coming week:

Expect the NIFTY to remain in a trading range of 17700 on the upside and 16300 on the downside with a sell side bias.

Till the NIFTY doesn't go above the 17500 levels dont expect the NIFTY to trade positive for the week and expect the NIFTY to test lower levels of 16898 and 16247 on the downside.

Where my individual calls are concerned again this week I will give two sell calls.

First sell call will again be on Canara Bank at 230 levels for downisde

till 219. My second sell call will be on Bharat Electronics at 239 for downside targets of 224 for the week.

My long term buy call will be on Titan at 2466 for about 15% appreciation from current prices in the next six months.

## NOWROZ BAUG REDEVELOPMENT PROJECT

### THIS IS NOT A LOLLIPOP

Residents of Navroz Baug want redevelopment. However, its been stuck because of red tape.

Following are the Excerpts of the letter dated 24<sup>th</sup> Sept. 2013 written by **ROHINTON J MEHTA** to all the Tenants of Nowroz Baug after the meeting of all Tenants on 24<sup>th</sup> March 2013 with the Chairman Dinshaw Mehta and all BPP Trustees along with Mr. Nusli Wadia, his son Ness Wadia, Dhun Gagrat and others from Wadia Committee:


"India's most renowned Architect Mr. Hafeez Contractor and his team with tremendous hard work and highest skills designed the most elegant four 45 storey Towers along with podiums and other excellent amenities, like 20000 sq.ft. Clubhouse with swimming pool, a medical centre, old age centre, a crèche for children, shopping arcade, children's playground, adult playground for football and cricket and much more. Audio and Video of Hafeez design project was shown and all the audience was very happy.

The Chairman Dinshaw Mehta addressed the audience and encouraged the Nowroz Baug tenants to join hands, work shoulder to shoulder and cooperate to make this Project a success. It was made clear by the Chairman that the proposal being outlined by the Architect was final and non-negotiable if the project was to succeed. Most nobly to our surprise Mr. Nusli Wadia spoke so softly and wisely to explain that the Nowroz Baug tenants would have much more area and facilities than what they are enjoying now. He was so courteous that he accepted to have a complete round of Nowroz Baug and walked with Ness Wadia and others to see what magnificently 100 years back his ancestors built such a beautiful Baug.

After the meeting in the Question Answer session, the Tenants and Committee members were free to ask one question and they were answered by the Chairman along with Trustee Jimmy Mistry.

The Trustees very kindly agreed to accept all the Leave Licensees as also legal heirs of the demised parents as permanent tenant and they all will be given Ownership rights by choice. If any of the Tenants wants to remain as Tenant that is also accepted. Trustees also agreed to give 25% more built up area as well as Corpus inclusive of Society Maintenance charge and all the relevant municipal taxes for 20 long years.

The Trustees were thereafter served a letter that a new Committee has been appointed and to negotiate fresh terms



of redevelopment with them. This obviously has created suspicions in the minds of the Wadia Committee as well as the Trustees who do not now seem to be rightly interested in taking the project forward.

For the redevelopment we surveyed the whole of Nowoz Baug grounds, all the 13 buildings, recreation club, malli's quarters, transformers and electrical installation area, underground water tanks, pump houses and structure of overhead tanks opposite C and D blocks. We surveyed the size of each and every flat with digital electronic computerized Theodolite. The survey team worked for days and did excellent job and gave us 3 sets of total drawings along with CD which we gave to BPP, Architect Hafeez Contractor and Nowroz Baug Maintenance and Development Committee. All the heavy expenses for the above was borne by Rohinton Mehta and family.

This project is designed to rehouse 355 Tenants with 25% more area and about 600 more flats from which 200 fats will be allotted to those on Merit rating waiting list and the balance 400 flats will be for sale. Thus almost a 1000 Parsi families will have a chance to live together in harmony.

Please sincerely think for our children and their future. The community should understand that BPP is doing everything to promote housing as a first priority for our dwindling community.

## A week in the life of Armaity Rustom Tirandaz

The electioneering for the trusteeship of the BPP has begun in earnest and I am one of the candidates who wishes to continue to serve this august body and the community. Social service is meant to be a silent service and not done for any accolades and self-appraisements. Giving the best of oneself for the most benefit to others makes one feel privileged that the infinite and eternal spirit has given the responsibility for doing His bid. But an important part of the electioneering process revolves around the candidates giving enough information about themselves for the voter to make an informed

decision, for whom they should vote. So I decided to pen down a week in my life and my accomplishments over the years.

I am now in my late 70's but I am blessed with excellent health. I love to drive myself wherever I go in my Maruti. I ensure I attend to all my calls and emails regularly. I am a retired person and all my efforts throughout the years are towards social service and the development of our community. The list of responsibilities I attend to mentioned below are enough bonafide of my mental faculties and my service to our community.

### **EVERY MORNING**

I begin every day with prayer, meditation and light exercises, followed by projecting good positive thoughts for the day ahead.

### MONDAY

A typical week would begin with my visit to the Parukh Dharamshala, where I am currently





the Chairperson of the Ladies Committee. Our Ladies Committee is a group of positive and result oriented women who ensure that the care given to the elderly there is of utmost priority.

The responsibilities of the committee encompass everything from raising funds to managing the staff and budgets to ensuring the upkeep of the Dharamshala. After the meeting is concluded I make my rounds to meet each inmate and spend time in conversation to help lift their spirits.

I return home by late afternoon and dedicate myself with all the reading and tasks required to be accomplished before the BPP meetings for Tuesday. I coordinate with the staff to make sure that the Minutes of meeting to be passed and the Agenda for the BPP meetings are in order.



#### TUESDAY

On this day my energies are dedicated solely for the BPP. Although, the meeting is normally set to commence at about 4:30pm I make sure I read all the required files before the meeting. I reach the office by 3:30 pm before the meeting begins to sign documents, cheques, to discuss specific queries with the staff, I also verify any doubts from my notes I have prepared from the day before, etc.

Our BPP meetings normally go on till 11pm and beyond. The role of Trusteeship is a 24/7 responsibility and the organizational machinery of the BPP has many issues that need to be tackled through the week. Under my chairwomanship, with the support of my other colleague trustees, to ensure quick resolution of lighter issues we have used email as a mode to make quick decisions without having to wait for a weekly Tuesday meetings.

Being the current Chairwoman of the BPP, I feel a deep sense of responsibility to point out that the BPP staff, who work long hours under pressure, have supported us Trustees and are an invaluable asset to the smooth functioning of the BPP.



WEDNESDAY, THURSDAY, FRIDAY & SATURDAY

For the rest of the work week, I ensure that I visit at least one of the following places: Parsi General Hospital, Gamadia Health Unit, Gamadia Boys Hostel, J.J. Parsi Ward and Masina Hospital.

Elderly care in our community is an important problem that needs to be tackled. And although we have institutions to care for them, their mental health is a cause for concern. Loneliness is darkness the elderly face every day and bringing a light to their lives by spending time with them brings me the greatest satisfaction. I encourage every individual reading this to spend time with their neighbours and bring a light into their lives and make them feel like someone cares for them.

As Trustees, we always have colonies and associations to meet and issues to resolve. Most times the issues of colonies are resolved by peaceful discussion and understanding of perspectives. But these are time consuming affairs and patience, leadership and conflict resolution abilities are qualities each one of us Trustees needs to be mindful about.

12. I am active in animal welfare and am also associated with the Sakarbai Petit Hospital at Parel. I have been on the hospital committee from the year 1990. Along with my sons, we have been feeding more than 30 stray animals in my area everyday for the past 25 years.

So, if you are still wondering, why I am doing all that I do at this age, my answer is simple:

Service makes me feel purposeful, positive and productive. "Honesty and Service before Self" have always been the mottos in the Tirandaz household and it was imbibed into the whole family by my late husband Rustom.

I am proud that my daughter in law Pearl and both my sons Faredoon and Darayus and even my grandson Rustom exude the same principles. I feel that life fills me with great energy when I am able to do what I believe I was meant to do.





Some critics have mocked my efforts and my dedication to the community. But I never thought it fit to run to the cosmopolitan presses. 

WHY HAS RANDERIA NOT PAID THE 40 LAKHS DEPOSIT THAT HE HAD PROMISED TO PAY BPP ON BEHALF OF IRANI FOR THE FLAT ALLOTTED TO IRANI IN PALMLANDS? Can such a trustee, as per his own definition, be called as one "beyond reproach, in terms of corruption and malpractices, vis-a-vis our trust funds and properties"?

While my previous columns have drawn a wide range of support from my community, there seems to be one, soon to be extrustee, my erstwhile friend Dadrawala, who appears to suffer some memory lapse. He in his mentor's typical fashion tries to deflect the community's attention from the real issues at hand!

In a message posted by him and received by me through a contact, Dadrawala has imputed motives to my recommendations of "THE MAGNIFICENT SEVEN" and ventures to suggest (keeping in mind my flats) that I have recommended those names waiting for a "dream board", who may let me encash one or may be all three and migrate to Canada. Whenever I have highlighted Randeria's highhandedness, Randeria and his cronies raise the issue of my three 1BRK flats lawfully acquired by my family decades before Dinshaw Mehta became a Trustee.

May 2017, in the presence of Noshir and the late Zarir Bhathena, I was offered by Randeria in very clear terms to help me encash my flats and settle down in Toronto. He not only made that offer to encash my flats for sale, but also suggested that I could keep one flat for my visits to Mumbai. If I was that desperate for money, would I not have accepted that offer then itself rather than "wait for a dream board"?

If genuinely Randeria was concerned about my family having three flats, why did he offer to encash its Tenancy values in private meetings with me when publicly he demonstrates his dissent for the auction of flats?

I would like to emphasise that I did not accept Randeria's offer for I did not want any favours nor did I want to withdraw my protest against the unjust increased service charges. I have always asserted my rights and won, and I shall do so now too irrespective of a "dream board"!

Randeria was NOT doing me any favour, because by his own admission, my fatherin-law's flat at Khareghat colony was in August 2013 minuted by the then board for transfer to the highest bidder as per the then prevailing rules.

I then refused Randeria's offer to help me encash, so why should I now wait for a "dream board" when Randeria offered me on a platter? What I fail to understand is, who is Randeria to decide unilaterally and indiscriminately, without any laid down norms or rules and without consultation with other members of the board to dole out favors to his chosen ones?

Noshir forgets that my protests for the steep increase in service charges was one of the main reasons for Randeria's animosity towards me. I was protesting the steep increase in service charges of

Rs.750/-, on behalf of those who could not afford as well as because the demand was beyond the scope of the Rent Act and was therefore unlawful.

How can Noshir forget that at my suggestion and request he came to meet Dinshaw Mehta, late Parvez Driver and me at the Gaylord restaurant in May 2017 (which was prior to the Grand Maratha meeting), to discuss this issue of the increase. He did agree to have the same reviewed and promised all of us that he would reduce the increase to Rs. 350/pm from Rs. 750/ pm.

Despite Noshir and the late Zarir agreeing to lower the increase, Randeria succeeded in bulldozing his own majority panel members. At this meeting at Gaylord, Noshir also raised the issue of the sale of a flat in Ness Baug, in which both the buyer and seller were known to Noshir, and he argued in favour of pushing through that deal involving 4 crores! For meeting Dinshaw and me, Noshir was humiliated and was referred to as supporting the "enemy of BPP". Despite this humiliation, before Kersi Randeria, Noshir is like a puppet and shuts up at Kersi's command.

Most of my differences with Randeria are as a Trustee of the BPP and are due to his high-handedness on policy which I have published repeatedly over the last few years and summarised again in the Parsi Junction issue no.115 of January 9, 2022. I have kept Noshir abreast whenever Randeria has been up to his tricks, and if his memory has failed him, and if he so desires, I can help him refresh it!

Messrs Randeria and company a word of unpalatable and unsolicited advice: Your repeatedly resorting to false allegations about my 3 flats mainly at election time no longer works. Please remember that I am NOT a candidate but Randeria you are! You


